Celebrate Spring and Help Save Lives by Giving Blood

It's officially spring! As the weather warms up and the latest COVID-19 surge continues to slow, many people are looking forward to meeting up with family and friends. At the start of this new season, the American Red Cross encourages the community to play an important role in helping save lives by making blood donation part of their spring plans.

The Red Cross is grateful to the hundreds of thousands of individuals who have rolled up a sleeve to give in early 2022. It's important to remember donated blood has a limited shelf life, so supplies must be constantly replenished. In the days and weeks ahead, it's critically important to maintain a readily available blood supply. Donors can make an appointment by downloading the Red Cross Blood Donor App, visiting RedCrossBlood.org or calling 1-800-RED CROSS (1-800-733-2767).

While getting back into the stands to watch the home team play this spring, donors can join a team of their own - Team Red Cross! As a thankyou, all who come to give April 1-18 will receive an exclusive Red Cross T-shirt, while supplies last.

The Red Cross is testing blood, platelet and plasma donations for COVID-19 antibodies. The test may indicate if the donor's immune system has produced antibodies to this coronavirus after vaccination or past exposure, regardless of

whether they developed symptoms.

Plasma from routine blood, platelet and plasma donations that have high levels of COVID-19 antibodies may be used as convalescent plasma to meet potential future needs of COVID-19 patients with weakened immune systems.

The Red Cross is not testing donors to diagnose infection, referred to as a diagnostic test. To protect the health and safety of Red Cross staff and donors, it is important that individuals who have been asked to quarantine or believe they may be ill with COVID-19 postpone donation until they are symptom free for 10 days and feeling well and healthy.

At a time when health information has never

been more important, the Red Cross is screening all blood, platelet and plasma donations from self-identified African American donors for the sickle cell trait. This additional screening will provide Black donors with an additional health insight and help the Red Cross identify compatible blood types more quickly to help patients with sickle cell disease. Blood transfusion is an essential treatment for those with sickle cell disease, and blood donations from individuals of the same race, ethnicity and blood type have a unique ability to help patients fighting sickle cell

Donors can expect to receive antibody testing results and sickle cell

disease.

trait screening results, if applicable, within one to two weeks through the Red Cross Blood Donor App and the online donor portal at RedCrossBlood.org.

Each Red Cross blood drive and donation center follows high standards of safety and infection control, and additional precautions - including face masks for donors and staff, regardless of vaccination status - have been implemented to help protect the health of all those in attendance. Donors are asked to schedule an appointment prior to arriving at the drive.

Donors can also save up to 15 minutes at the blood drive by completing a RapidPass®. With RapidPass®, donors complete the pre-donation reading and health history

questionnaire online, on the day of donation, from a mobile device or computer. To complete a RapidPass®, follow the instructions at RedCrossBlood.org/ RapidPass or use the Red Cross Blood Donor App. To donate blood, individuals need to bring a blood donor card or driver's license or two other forms of identification that are required at checkin. Individuals who are 17 years of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also must meet certain height and weight requirements.







The City of Noblesville is a Combined Sewer Community, which means that some of the sewers in the older part of the City transport both storm and sanitary some of the sewers in the older part of the City transport both storm and sanitary wastewater to the treatment plant. During rain events, the capacity of the lines transporting this liquid to the treatment plant may be exceeded. Overflow points exist to allow the system to relieve the excess flow to a receiving stream. This discharge into a receiving stream is a combination of the storm and sanitary flow.

The Utility has placed signs at each of the eight (8) outfall structures where the combined waste flow is discharged to a receiving stream. It is important that when you see water coming out of these structures, you stay out of the water. There is a risk of becoming sick if you come into contact with this water.

Holcomb Signs HB 1296, "Constitutional Carry" Law


Governor Eric J. Holcomb today signed HB 1296. With HB 1296, which repealed the law that required a license to carry a handgun in Indiana, now signed into law, Indiana Gov. Eric Holcomb issued the following statement:


"The Second Amendment has been debated for years, yet time and again our U.S. Supreme Court has reaffirmed this important constitutional right that I fully support. Twenty-three other states have laws comparable to HEA 1296," he said.


The Governor went on to say, "HEA 1296, which I've signed today, entrusts Hoosiers who can lawfully carry a handgun to responsibly do so within our State. It's important to note that if a person is prohibited, under federal or state laws, from possessing a firearm before this law goes into effect, that person will still be prohibited. And if a prohibited person has a firearm, he or she can be prosecuted. Firearm permits will remain available, without fee, to anyone who wants or needs one, such as Hoosiers desiring to carry a firearm to, through or in another state that has reciprocity with Indiana."

Indiana State Police Superintendent Doug Carter issued the following statement: "As Superintendent of the Indiana State Police, I have pledged my continued commitment to Governor Holcomb to work towards solutions enacting HEA 1296. I, like Governor Holcomb, feel enormous responsibility for front-line law enforcement officers. I will work with law enforcement leaders across our state to make necessary changes to firearms enforcement as well as finding the best way to identify individuals who are not allowed to carry a firearm as defined by Indiana statute."

He concluded his statement by saying, "We will continue to encourage citizens to apply for, and maintain, a firearms permit. A permit will assist law enforcement officers and will also allow a permit holder reciprocity with other states."

Holcomb Vetos HB 1041; Override Vote Announced by Huston

Governor Holcomb yesterday vetoed HB 1041, a bill that would have banned transgender girls from playing school sports with their peers.

In a letter to Indiana House Speaker Todd Huston announcing his veto, Gov. Holcomb called on the Indiana house to address what he saw as shortcomings in the bill pertaining to enforcement and consistency. He also stood by the IHSAA, saying, "I am heartened by the IHSAA which has done an admirable job to maintain fairness and consistency in all sports. Nowhere in the testimony in this legislation was a critique leveled against their model on how to govern this and other complex matters. Furthermore, not a single case of a male seeking to participate on a female team has completed the process established by IHSAA's

now decade-old policy. Speaker Huston, as well as several members of the Indiana House, have called for an override vote. Speaker Huston announced yesterday the house would hold a special override vote on May 24. An override vote in the Indiana house requires a simple majority of votes to pass.

Katie Blair, ACLU of In-

diana Advocacy and Public Policy Director, released the following statement:

"This victory belongs to the trans youth of Indiana, who deserve to live as their authentic selves and to play the sports they love, free from discrimination. This win wouldn't have been possible without the thousands of Hoosiers who voiced their strong opposition to state legislators and who showed up at the Statehouse to oppose this harmful bill. Discrimination has no place in our state."

Christiana Holcomb, Senior Counsel for the Alliance Defending Freedom, issued a statement following Governor Holcomb's veto:

'Women and girls deserve to compete on a level playing field. When we ignore biological reality, female athletes lose medals, podium spots, public recognition, and opportunities to compete. While Indiana's fairness in sports bill glaringly failed to include protections for athletes at the collegiate level, the governor's refusal even to protect girls in K-12 is all the more disappointing. By vetoing this bill, Gov. Holcomb has chosen to reject fairness in sports for thousands of women and girls in Indiana. Just last

week, a female swimmer from Indiana was knocked down in the rankings at the NCAA Women's Swimming Championships by a male who went on to claim a national title. Where is the governor's empathy for those talented and courageous women? Regrettably, he has turned a blind eye to the increasing examples of males dominating girls' athletic competitions."

"Gov. Holcomb's claims about the bill ring hollow considering that 11 other states have enacted women's sports laws without any confusion. They understand that these laws are not only constitutionally

sound but fully consistent with Title IX. Attorneys general from 14 states said as much when they filed a brief supporting Idaho's 2020 Fairness in Women's Sports law. If Gov. Holcomb truly finds saving women's sports 'a worthy cause for sure,' he would not sacrifice fairness for Indiana's women and girls to such flimsy and baseless justifications. We are thankful to the legislators who took a stand for a level playing field for female athletes of all ages, and we will continue to work alongside them to protect fairness in women's sports."

IN Dept. of Education Launches Data-Driven Educator Marketplace

The Indiana Department of Education (IDOE) launched the first phase of a new statewide supply and demand educator marketplace, which will provide data to schools and the state to strengthen and support Indiana's educator pipeline. The marketplace is a key component of Governor Eric J. Holcomb's 2022 Next Level Agenda.

"Across Indiana and the nation, in order to maximize the positive impact for students, we must continue to recruit and retain high-quality

educator talent," said Dr. Katie Jenner, Indiana Secretary of Education. "Through our continued development of this new marketplace, we gain a valuable new tool that allows us to understand not only the 'supply' from our current educator workforce and educator preparation programs, but also the real-time 'demand' for specific positions in our schools. This data can be leveraged to make sure we are continuing to support and strengthen our state's educator pipeline, and in

turn, our students." With the launch of the

first phase of this new platform, Indiana will gain real-time data on statewide openings in schools – including the most in-demand roles – as well as data on educators currently seeking open positions. Additionally, Indiana educators gain a one-stop-shop for finding and applying for open positions, and schools gain a user-friendly, data-driven tool for recruiting talent in the classroom and in

leadership roles. The platform replaces the outdated IDOE job board, and is available to all Indiana schools at no cost. It supports one of IDOE's top priority pillars, which is elevating and supporting Indiana educators by improving guidance, support and accessible data for those recruiting, educating and mentoring rising educators.

Through the supply and demand marketplace, Indiana educators can now easily view available positions statewide and search for jobs using multiple criteria, helping

them more easily find positions that match their interests. With a "quick apply" feature, educators will be able to save time by applying for positions using a common applica-

Indiana schools can leverage this new tool to engage with educator candidates who previously might not have had access to the posting – including diverse applicants and applicants for high-need areas like special education and science, technology, engineering and

math (STEM). As schools

are considering applicants for both classroom and leadership positions, they will be able to access a data dashboard to support their recruitment efforts.

Indiana educators can access the demand-side of the marketplace here to create an account and view available positions. The platform will continue to be developed and improved based upon stakeholder feedback and with additional data on "supply" from teacher preparation and training programs across the state.

The sanctuary offers some of the most diverse collection of wildflowers and plants in Indiana, according to the Centennial program.

Rick Towle, Noblesville Middle School science teacher and president of the Blatchley Nature Study Club in Noblesville, was the first to write me about the 2022 celebration, asking me to share with the public and invite the community to guided tours to see some of the most diverse varieties of wildflowers in Indiana, from 1 p.m. to 5 p.m. on two Saturdays, April 16 and 30. (The first tour will showcase early bloomers, and the second tour late bloomers. So make plans to attend both if you love nature.)

"I am humbled by the opportunity to lead our club of nature enthusiasts into the next 100-year chapter of our esteemed organization," Towle offered as a message in the Centennial program. "...The things we have accomplished during my tenure as president continue to amaze me, and truly illustrate the dedication and energy needed to live up to the mission of our

club." He wrote, "My message this year is one of insight, passion and determination ... all intended to rekindle the importance of what we try to achieve through our club activities, programs and goals.'

Emma St. Dennis of Noblesville is vice president of the Blatchley club and also shared a wealth of information with me about the club and its history. She recently found out that the club members actually laid out the plans for the trees that are in Forest Park, she said.

This year marks the 100th year of the nature study club, which was founded on April 8, 1922, by Dr. Earl Brooks. The club, which is made up of individuals who share a love of nature, changed its name to The W.S. Blatchley Club to honor Indiana's greatest naturalist, Dr. Willis Stanley Blatchley (1859-1940). The Blatchley Nature Study Club was incorporated as a nonprofit on Nov. 12, 1941. Then Brooks deeded 15 acres of land to the club for use as a sanctuary and on which to build a clubhouse on March 8, 1963. The Clubhouse (built with a generous monetary gift from Eli Lilly family) and the sanctuary was dedicat-

ed on July 18, 1965. Each spring, the club leads Wildflower Walks, inviting the community to

attend. Just over the weekend, club members gathered for a cleanup of the clubhouse interior. And this Thursday, the club will have a pitch-in dinner at the clubhouse for the IU Scholarship Presentation featuring Haiz Webb, Blatchley's scholarship recipient, a fourth-year student on a five-year graduation plan pursuing dual Bachelor of Science degrees in biology and comprehensive design with minors in animal behavior, environmental science and music, as well as the Hutton Honors Notation. (Annually, the Biology Department of Indiana University awards a Blatchley Nature Study Scholarship to a deserving student. Since 1989, 33 scholarships have been given out.)

Members will gather again for an outdoor cleanup at 9 a.m. April 9

on the grounds of the club. Monthly meetings offer special programs that teach club members about all aspects through presentations, which this year feature: "Willis S. Blatchley" history by Chris Wirth at 7 p.m. April 28 (at the actual Centennial monthly club meeting); "Owls of Indiana" by Mark Booth at 7 p.m. May 26; "Birding in South Africa," by Doug Vine at 7 p.m. June 23; "Birding in Panama," by Rob Ripma, Becky Heck and Mary Kay Pitts at 7 p.m. July 28; a Butterfly Walk field trip led by Sherry and Phil Cartridge at 10 a.m. Aug. 13; "Adventures in Bird Training," by Jenna McElroy at 7 p.m. Aug. 25; Blatchley Sanctuary Cleanup at 9

a.m. Sept. 10; "Antarctic Field Research," by Dan Boritt at 7 p.m. Sept. 22; Fall Hike and Bonfire at 4 p.m. Oct. 8; "Living with Coyotes," by Jessica Merking, 7 p.m. Oct. 27; "Why Our Rare Plants are Rare," by Scott Namestnik at 7 p.m. Nov. 17; and a Potluck Dinner Christmas Party at 6:30 p.m. Dec. 15.

Members are encouraged to propose new members for the club with a written application.

Memberships range from \$5 for ages 18 and younger to a \$500 individual life membership.

I expect to write more about the Blatchley Nature Study Club in the coming weeks as the Celebration draws nearer. So save the dates: April 16 and 30.

To make up for the lost time, there will be presentations on the Herbs of the Year for 2020 and 2021, but the star of the show is the 2022 Herb of the Year, Violas.

Violas?

Yes, the 500 to 600 species that belong to the genus viola. You know them best as violets, pansies and heartsease (also known as Johnny-jump-ups.)

I know pansies and violets aren't what most people usually think of as herbs. They do, however, meet the International Herb Association's criteria for selection as Herb of the Year, being outstanding in at least two of three categories: decorative, culinary and medicinal.

I'm sure you already know violas are decorative. Cold tolerant pansies are among the first plants available to add color to your flower beds in the spring and they provide some of the last bright colors in the fall garden. Violets and pansies are

also edible, as I learned when I worked at Conner Prairie back in the 1970s.

Libby Doss, the training guide for the costumed interpreters at Dr. Campbell's house, showed me how to make candied violets to decorate cakes, ice cream and other desserts.

The basic steps are fairly simple: beat an egg white until it's frothy but not stiff, carefully paint the egg white on the violet with a brush, then dust the flower all over with very

fine sugar and let it dry. Of course, you need to make sure the violets are clean and pesticide-free, and these days you'd better use dried egg whites or meringue powder in place of raw egg white, just to be safe.

What I didn't know about violets and pansies is that they also have valuable medicinal qualities. Sweet violets ("viola odorata") have been used to treat respiratory disorders, and heartsease or wild pansies ("viola tricolor") are useful for respiratory disorders, skin ailments and arthritis.

You can learn more about violas at the Spring Symposium.

Food writer, editor, photographer and "flavor artist" Susan Belsinger will discuss all aspects of violas — from their cultivation, to medicinal uses, to recipes using violets, pansies and "johnnies" — in two presentations, "Celebrate Viola, Herb of the Year 2022" and "The Virtues of Violas."

In addition, HSCI member Helen Burke will speak on "Brambles," the 2020 Herb of the Year (brambles are raspberries, blackberries, etc.) and Joyce Miller, another HSCI member, will talk about "Humble Parsley," the 2021 Herb of the Year.

Other presentations include "Tai Chi for Gardeners" with Christine Bhe, a certified Tai Chi and Qigong instructor, and "Best Fragrant Plants for the Midwest Garden" with author, ethnobotanist, gardener, and lecturer Bill McKnight (aka The Mad Botanist.)

A breakfast snack and a lunch, catered by Juniper

Spoon, are included in the \$60 registration fee (\$55 if you're a member of the HSCI,) but take along a little extra cash because you'll also have an opportunity to shop for live plants and herb-related items, and to participate in a silent auction.
