## 2022 Hamilton County Primary Election

A higher-than-average turnout in Hamilton County saw a number of incumbents win re-election; however, incumbent Hamilton County Councilman for District 3 Steve Schwartz lost his re-election bid to newcomer Mark Hall, 58.44% to 41.56%. Tim Griffin (71.35%) beat John V. Accetturo in their race for the Hamilton County Council seat in District 1.

Incumbent Sheridan Town Council at-large member Steve Fisher (27.22%) lost his re-election bid to newcomers Daniel A. Bragg (39.38%) and Eric D. Gifford (33.40%).

## Holocaust Survivor Eva Kor Teaches Us to Be Forgiving

Eva Kor was about hope, healing, respect and responsibility by shining a light on the story of the Holocaust.

I last saw Kor's picture -- a

larger-than-life-size color poster -- in the hallway at Franklin Central High School on Friday night when our Noblesville High School show choirs were competing there. Her picture on the school walls was a great reminder of her legacy and what she stood for.

It got me thinking about our visit with Kor three years ago.

One of my daughter's most inspirational and educational days was taking a road trip west to Terre Haute, where she met then 84-year-old Holocaust survivor Eva Mozes Kor.

Kor was the founder and president of CANDLES (Children of Auschwitz Nazi Deadly Lab Experiments Survivors) Holocaust

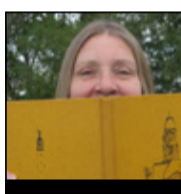
Each school winner was select-

### Harley William Hobson December 1, 1929 - April 5, 2022

Harley William Hobson, age 92, passed away at his home in Zionsville, Indiana, surrounded by his loving family on Tuesday afternoon, April 5, 2022.

He was born December 1, 1929, in Clarksville, Indiana, the son of the late Alva K. and Minnie (Johnson) Hobson.

Mr. Hobson was a 1948 graduate of Sheridan High School. During his high school years, he worked at McDonald's Hatchery and Sheridan Packing Company. After graduation, he proudly served his country as a soldier in the United States Army. When his military service was complete, Mr. Hobson re-entered the workforce, taking the first steps of what turned out to be a long productive career in the manufacturing industry. He got his start with Sheridan Metal Processing, and after 5 years took a position with General Motors, working on the electroplating line for 31 years. Mr. Hobson was proud of his years at GM and was honored that his department was always one of first to be called in when operations would shift to supporting the war effort. When the call would come to switch to military production, his plant was tasked with building parts for helicopters.

Mr. Hobson was a lifetime member of the K.V. Elliott American Legion Post 67 of Sheridan, Indiana and a member of UAW Local 933. He and his wife Martha attended Zionsville United Methodist Church.

Mr. Hobson's return from the service was also the perfect setting for a Sheridan story that has been told time and time again - when two brothers eloped and married two sisters. He, along with his brother Harold, set off on a road trip with girlfriend Martha Jane Baird, and her sister Norma Baird, and on October 9, 1950, Harley and Martha (along with Harold and Norma) were wed. Throughout the years there wasn't much that wasn't done as a group. The foursome loved to travel together, and various accounts of their adventures would surface from time to time. Many family members swear that the reason they always traveled with each other was so that they could make up stories to tell when they got back home.

Mr. Hobson was also well known for his green thumb; there wasn't much he couldn't grow. His garden got larger and larger throughout the years, and it was more for others than for himself. He was also a wealth of knowledge about... well... random things. He was a voracious reader and had a seemingly unquenchable thirst for knowledge. Sometimes Mr. Hobson would just sit and read the encyclopedia. This would lead him to be able to rattle off obscure facts at the drop of a hat, such as all the past Indy 500 winners. Now it did help that he was a fan of auto racing, both open wheel and NASCAR (Jeff Gordon being his favorite driver), but that is still no less of an impressive feat.

Mr. Hobson had no greater love in his life than his family. He loved following their activities and was always there to support them in whatever they were going through.

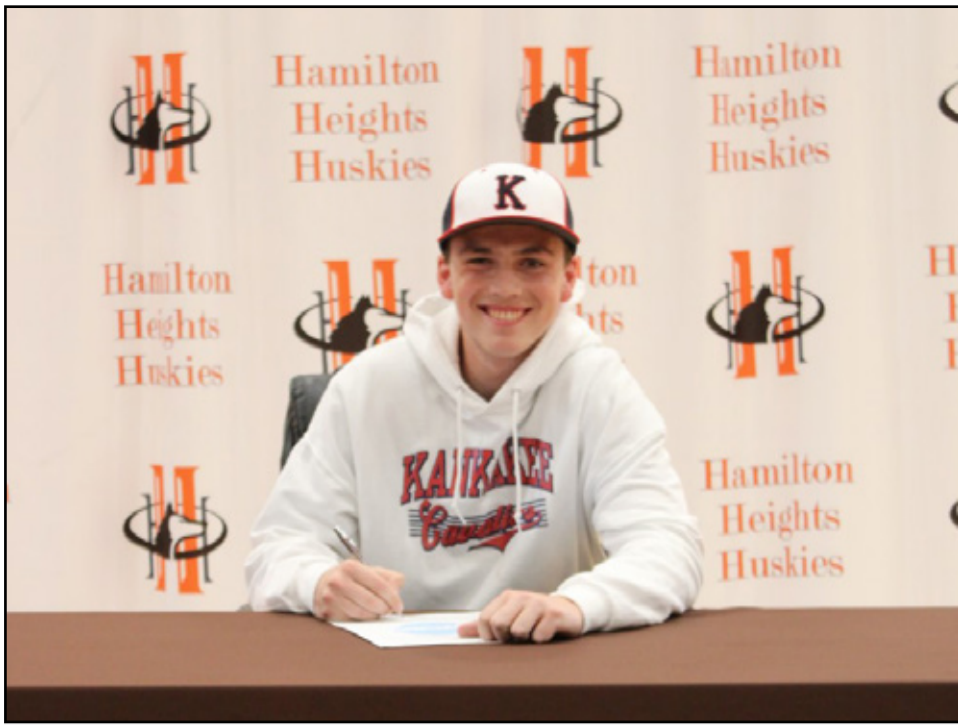

# Producer Sentiment Improves with Rising Commodity Prices, High Cost Inflation Worries Farmers

The Purdue University/CME Group Ag Economy Barometer improved in April, up 8 points to a reading of 121; however, it remains 32% below its reading from the same time last year. Producers' perspective on current conditions and future expectations saw an uptick over the past month. The Index of Current Conditions improved 7 points to a reading of 120, and the Index of Future Expectations improved 9 points to a reading of 122. The Ag Economy Barometer is calculated each month from 400 U.S. agricultural producers' responses to a telephone survey. This month's survey was conducted April 18-22.

"Rising prices for major commodities, especially corn and soybeans, appear to be leading the change in producers' improved financial outlook," said James Mintert, the barometer's principal investigator and director of Purdue University's Center for Commercial Agriculture. "However, it's hard to

overstate the magnitude of the cost increases producers say they are facing.

The Farm Financial Performance Index improved to a reading of 95, up 8 points from March, and 12 points higher than in January and February. As Mintert suggests, much of this could be attributed to the strengthened commodity prices. For example, Eastern Corn Belt cash prices for corn in mid-April rose more than 10% above their mid-March levels while bids for fall delivery of 2022 crop corn climbed 20% over the same period. Soybean prices rose as well. Near-term delivery prices for soybeans rose about 7% from mid-March to mid-April, while elevator bids for fall delivery of new crop soybeans climbed 5% over the one-month span.

Even as commodity prices have strengthened, producers continue to say higher input costs are the top concern for their farming operation. In April, 42% of producers chose higher input costs as their

biggest concern, which was more than twice as many who chose government policies (21%) or lower output prices (19%). In April, 60% of survey respondents said they expect input prices to rise by 30% over the next 12 months. This compares to an average of 37% of respondents who said they were expecting a cost increase of this magnitude when the same question was posed in the December 2021 through March 2022 surveys.

When asked specifically for their expectations for 2023 crop input prices compared with prices paid for 2022 crop inputs, 36% of respondents said they expect prices to rise 10% or more and 21% of crop producers said input price rises of 20% or more are likely. The war in Ukraine has also added a new level of uncertainty for producers. Sixty percent of survey respondents said the biggest impact of the war on U.S. agriculture will be on input prices. Crop input challeng-

es extend beyond their inflated cost to their availability. In April, 34% of producers said they experienced some difficulty in purchasing inputs for the 2022 crop season, up from 27% in March. In a follow-up question, producers who said they had some difficulty obtaining inputs said that herbicides (30% of respondents) were most problematic, followed closely by farm machinery parts (27%), fertilizer (26%), and insecticides (17%). In a related question, 11% of crop producers said they received notice an input supplier would not be able to deliver one or more crop inputs they had already purchased for use in

2022. Of those, herbicide availability was the top problem reported.

Despite an overall improved financial performance outlook, the Farm Capital Investment Index remains at its all-time low. Supply chain problems remain a key reason many producers feel now is not a good time for making large investments in their farming operations. For example, just over 40% of producers said their farm machinery purchase plans were impacted by low machinery inventories. The rising cost of all inputs, including machinery, buildings, and grain bins, is likely another factor causing producers to say now is not a good time for

large investments.

too, but unfortunately, I haven't run across any interior photos of the store to confirm that.

Pam added that, although she got most of her shoes from her grandfather who sold shoes at an Elwood department store, she always got her Keds from Craycraft's.

I've been wearing leather athletic shoes for so long, I'd forgotten about Keds and how big those canvas shoes were when I was little. You weren't cool back then unless you wore Keds. (From what I see on the internet, Keds are cool again.)

Larry Cloud remembered Kirk's rolling ladders and "drawers/shelves that seemed miles high to this little boy," but he was more impressed with the "overhead cable/trolley system" at the J. C. Penney store on the east side of the square.

Penney's aerial trolley transported sales slips and cash to and from the balcony at the rear of the sales-room. My memory of that is pretty hazy, but I think it was similar to the pulley system still used at Stout's Shoes in Indianapolis.

Speaking of Kirk's, when I was working on that column, I asked Nancy Massey if she could find more information about the break-in that took place at the hardware store in 1981.

The article she came up with was so interesting, I think it's worth a mention here.

The three burglars got into Kirk's by first breaking into the Mental Health Association of Hamilton County office, which was over the Sears store next door to Kirk's. They then crossed over to the United Auto Workers Local 1571 over Kirk's, chopped a hole in the floor and dropped into Kirk's through the hardware store's ceiling.

Luckily, someone alerted the police to what

was going down. Eight detectives were waiting for the thieves when they exited the building.

Burglar #1 got away, but was caught a week later. Burglar #2 was tackled in front of Deering Cleaners, which was, if I remember correctly, three or four doors west of Kirk's.

Burglar #3 got as far as Syd's, then he made the mistake of glancing over his shoulder to check on his pursuers. He ran into a parked car, executed a couple of flips in the air and ended up doing about \$200 worth of damage to the car. (Nothing was mentioned in the article about what he might have done to himself.)

Meanwhile back at Kirk's, the quarter-inch steel door on the store's 4-foot floor safe had been "peeled off." Damages there ran to the tune of \$4,000.

(Note to anyone contemplating future criminal activity at that location — Kirk's last owner, Bill Prater, told me they fixed it so nobody would ever be dropping into the store like that again.)

My Anonymous Friend remembered that the old Stringtown schoolhouse on Hague Road was still around during our grade school days. (That road is only "Stringtown Pike" north of 216th Street.)

Although the brick structure was falling apart then, it was still recognizable as a school. At that time, it was located on a small farm. Today, Noblesville West Middle School sits on that property.

Dartown Road remains a mystery . . . but, I said the same thing about Llewellyn Spring years ago and that puzzle eventually was solved, so I have hope.

Museum and Education Center in Terre Haute, and she spoke to visitors on a posted schedule.

I had met and written about Kor -- a survivor of Nazi death camps -- more than 12 years ago as a journalist for *The Indianapolis Star*, writing a story about Kor's visit to Noblesville Intermediate School in 2010, and before that as a journalist for *The Noblesville Ledger*, during her visit to our schools.

But what was most important on this visit was that my daughter had the chance to meet this inspirational woman and hear her story firsthand.

Kor and twin sister, Miriam, born Jan. 31, 1934, in Portz, Romania, were just 10 years old when, in 1944 during World War II, they were forced from their home and transported by cattle car to Auschwitz-Birkenau, the largest of concentration and death camps, in Poland. They were recognized as identical twins, torn from their mother's arms, never to see her again and became two of 3,000 prisoners

subjected to "horrific medical experiments" on twins, supervised by Nazi doctor Josef Mengele.

Her parents and two older sisters disappeared in the chaos, taken away to die in the gas chambers.

Our four-hour round-trip drive on Jan. 3, 2019, during Noblesville Schools' winter break, to see Eva Mozes Kor was well worth the time.

We listened closely as Kor told her very-detailed story, as if it were yesterday, showing maps of Auschwitz and black-and-white wall-size photos of Kor and her twin sister leaving the concentration camp, being liberated on Jan. 27, 1945, a day now commemorated as International Holocaust Remembrance Day (called Yom Hashoah in Hebrew and most recently celebrated in Israel on April 27-28).

Kor moved from Israel to Terre Haute in 1960 after marrying Holocaust survivor Mickey Kor, and they raised two children. After her twin died in 1993, she founded the Holocaust museum in Terre Haute. That was the same year that she

discovered healing through forgiveness.

After many years of hatred for her time spent in captivity, she was able to forgive. And she taught others, like Genocide survivor Kizito Kalima, who shared his experiences with students at both Noblesville East and Noblesville West middle schools in spring 2019. He attributed her to his walking a path to forgiveness. "She had a lot of impact on me, to reach out and to encourage me to do what I'm doing," he told this journalist during his NEMS visit. "...I respect her so much. I feel like she's the one who gave me courage."

Kor, who traveled across the United States and around the world, loved to talk to others, especially children, about her experience, and took the time to talk to each and every person who wanted to meet her and ask questions of her. The day of our visit with Kor, she smiled and posed for photos with us, and she autographed for us two of her books, in which she wrote about her experience, one written before her forgiveness and the other written after forgiveness. She signed each of our books with "Forgive & Heal, Eva Kor, 1-3-19."

She encouraged listeners and those she met to "never give up, be kind, forgive and choose to make the world a better place every day."

Kor, an inspirational woman who in 2017 received the Schem Award, Indiana's highest honor, was the 2017 grand marshal of the 61st 500 Festival Parade, where we watched her ride down the middle of the street, wav-

ing to fans, in a golf cart after the antique car she was riding in had engine trouble. (Former Noblesville Ledger photographer Joe Garza, who is currently with *Terre Haute's Tribune Star*, was trailing Kor, snapping photos of her along the parade route.)

While Kor on that Jan. 3, 2019, couldn't recall specifically either of my previous newspaper interviews, which she said were among hundreds of interviews a year, it was so nice to be able to see and talk to her face-to-face and hear her inspirational story again.

"Be the best that you can be," Kor always said. She expected that of herself, and she hoped for that in all others. Her greatest hope was that her "life would mean something" and that others would spread "her life lessons around the world."

The world was saddened by news of Kor's death over the Fourth of July holiday in 2019. But it just seemed fitting that her passing came on July 4, Independence Day. Eva Mozes Kor spent the last days of her life on her annual summer trip to Auschwitz, with people from around the world, sharing her message and "planting her seeds of peace," her obituary read.

We can all apply Kor's values today, by being respectful to others and being forgiving. Especially on social media, when it's easy to be the judge and jury. So the next time you think about speaking before thinking, think twice. And strive to be more like Eva Kor.
