





She'll tell you, as she did Kiwanis members last Saturday, that area parks offer a wide range of activities sure to interest various ages and degrees of recreational enthusiasm.

Summer camp, nature programs, and a nature center are available at Cool Creek Park in Westfield, with the center open 7 days a week. Closer to home, Strawtown Kotewei Park also houses a nature center, programming, trails for hiking and horseback riding, and a lake for kayaking. Rich in history, this 750-acre park also offers adventure experiences, such as zip lining, archery, and a winter snow-tubing hill.

programs at county parks, recommending a tour of Coxhall Mansion for adults and Cool Creek's "Haunt on the Prairie" for young children. She was most enthusiastic, however, about the county's nature programs, rookery, and recently acquired properties on which new plant species were found. ## Eunice Trotter Named as Director of Indiana Landmarks' New Black Heritage Preservation Program

Indiana Landmarks welcomes Eunice Trotter as director of the statewide organization's new Black Heritage Preservation Program. Trotter will assume the new role beginning September 1, 2022.

A longtime journalist, historian, and community organizer, Trotter brings more than 30 years of experience focused on communications, research, advocacy, and mentorship. In her new position, she will coordinate a broad initiative to identify, save, and celebrate places significant to Indiana's Black history.

"We couldn't be more pleased to have Eunice join our staff," says Indiana Landmarks President Marsh Davis. "Her experience and passion will be powerful assets as we seek to expand Indiana Landmarks' work in Black heritage preservation."

A native Hoosier with roots in Indiana dating back to the 1700s, Trotter began studying Black history as a teenage intern at the Indianapolis Recorder, one of the oldest African American weeklies in the nation. She went on to own, edit, and publish the Recorder from 1987 to 1991. Trotter has worked as a reporter and contributing writer for newspapers and publications in Indiana, Florida, New York, and California. She served as the first Black editor at the Indianapolis Star and was inducted into the Indiana Journalism Hall of Fame in 2017. Trotter's award-winning book, "Black in Indiana," details the history of Mary Bateman Clark, her greatgreat-great grandmother, whose 1821 Indiana Supreme Court case resulted in a precedent-setting decision against indentured servitude in Indiana. In 2016, Trotter received the Indiana Historical Society's Dorothy Riker Hoosier Historian Award, honoring historians who make distinguished con-

tributions to the field of historical scholarship. Most recently Trotter has worked in public relations as owner of her own communications and media relations firm, and as senior communications specialist for American Senior Communities. She has served on boards and committees of several organizations, including the Indiana Debate Commission, the Indiana Journalism Hall of Fame, the Kurt Vonnegut Museum and Library, and the Indiana Remembrance Coalition.

Indiana Landmarks' Black Heritage Preservation Program aims to expand the work of the organization's African American Landmarks Committee, established in 1992 to help identify and save historic African American sites.

Among other goals, the new program will bolster efforts to recognize Black heritage by identifying places that should be listed in the National Register of Historic Places. Another key element of the program will be building sustainable futures for Black heritage sites through new funding and strengthened support for local partners.

Indiana Landmarks' Black Heritage Preservation Program is funded by a \$5 million grant from Lilly Endowment Inc., and generous commitments from private donors and the National Trust for Historic Preservation's African American Cultural Heritage Action Fund.

## Rokita Secures Third Pro-Life Court Victory Since Dobbs Decision

A U.S. district court has vacated a judgment against an Indiana law prohibiting abortions sought on the basis of the unborn child's race, sex or disability.


Attorney General Todd Rokita headed the effort in this third court victory since the Supreme Court Dobbs decision.

"There is something particularly repugnant about discriminating against a child because of his or her race, sex or disability," Attorney General Rokita said. "To choose to end a child's life on that basis while he or she is still in the womb is especially tragic. Hoosiers can be grateful that Indiana is now free to enforce a law rooted in common sense, compassion and justice." On July 7, Rokita

achieved another pro-life legal win when a federal district court granted his motion to lift an injunction on dismemberment abortions, which occur well into an unborn baby's development.

Then, on July 11, a U.S. appellate court vacated judgments in the Whole Woman's Health Alliance v. Rokita case that had invalidated several other Indiana laws.



farm in the Noblesville/ Fishers area, where her family raises Dairy Cattle, Beef Cattle, Pygmy Goats and Sheep.

In 2019, she was named Hamilton County's Supreme Showmanship Reserve Champion, representing Dairy Cattle.

In 2020, she was named Hamilton County Supreme Showmanship Reserve Champion, representing Beef Cattle (which was postponed until the beginning of the 2021 Fair due to the COVID-19 pandemic.)

In 2020, she was also named Hamilton County Royal Showmanship Grand Champion, representing Pygmy goats.

She said all of the experience helped her be better prepared for this year's contest.

On Monday afternoon at the 2022 4-H Fair, Fisher won Senior Beef Showman, which qualified her to represent the Beef Cattle in Monday evening's Supreme Showmanship, Senior Showmanship winners an incentive to master showmanship, not only of their own animal but of seven species: beef, dairy, dairy goat, horse, meat goat, sheep and swine.

During the competition, spectators fill the show arena to cheer on their favorite showmen (This year, all seven Supreme contestants were females), who compete with the seven different animal species, for which they were earlier deemed top shown.

Royal Showmanship works the same but with six small animal breeds that include dog, cat, rabbit, llama, poultry, and pygmy goat.

The competitions put the best of the best in the show arena. Contestants wear white shirts, blue jeans, boots and their competition "letter" bibs.

Going into Monday night's competition, Fisher had only one thought on her mind, to do her best. "I tried to forget the 4-H program for 36 years, volunteering with 4-H cattle, swine and sheep -- was Fisher's Livestock Production teacher at HSEHS. He was right there on the Show Arena floor proudly watching his student compete and win the glory on Monday.

"Two years, she was close; she was Reserve (in 2019 and 2020). Last year, she didn't make it (to Supreme)," said Younts. "It was a hard pill to swallow. You know it's been a goal since she got into high school. It's like something we talk about, we talk about in class...."

According to the May 3, 1933 Ledger, this ferocious beast had been running (I use the term loosely) around the same general area for at least 38 years.

Farmer Ora Newton, who'd discovered the box turtle a few days earlier, immediately recognized it. In 1895, when he was a boy, he'd carved his initials into the turtle's shell. Over time, the names of Newton's brother and sons had also been added to the shell.

And just how did the turtle gain its lethal reputation? A few years earlier, one of Newton's young sons had flung it at a rabbit.

The bunny died, but the turtle was "none the worse for this experience."

Our next act is Noblesville's "Canine Champion Roof Climber," reported in the April 18, 1933 Ledger.

"Bare footed and without the use of any brakes," Captain Jenks Cryderman thrilled witnesses with a death-defying leap over the "very steep, 35% grade, smooth-surfaced" roof of the local traction company's freight house. (The traction company operated the interurban.)

After a running start, the two year-old Boston terrier hurtled over the peak of the roof and down

#### the opposite side. He then went back up and over, ending his performance with a safe landing in the arms of his mistress, Mrs. George Cryderman, wife of the traction company's local agent.

And now, the grand finale — the Fiddling Bear!

According to the May 2, 1890, Hamilton County Ledger, in the years before the Indians left this area, three Ohio men came here to hunt and explore along Cicero Creek.

One of them brought along an old fiddle to while away "the tedious hours of frontier monotony." This fiddle and its bow were kept together on some pegs, high on a wall of the hunters' log cabin.

During one of their excursions around the area, the men discovered a bee tree. Collecting a considerable amount of honey from the tree, they carried the sweet treat back to the cabin and placed it on a log that protruded over the fiddle.

The next day as they returned from hunting, they were startled to hear fiddle music coming from their cabin.

A cautious investigation revealed the musician was not an Indian, as they'd feared, but a bear who'd taken advantage of their open door. In attempting to get at the honey, "his bearship" had caught his paw in the fiddle's bow, producing the music.

The impromptu concert ended when the men closed the door and shot the bear through a window.
