

What makes Larry Jacobi smile? "These old airplanes; they make me smile. And we enjoy taking people on rides. These airplanes were built as trainers in World War II. I just love taking people up in them." Jacobi was found recently giving an airplane ride to Promise Road Elementary Principal Christy Martino as a reward for students' fundraising. Jacobi has been flying airplanes for 53 years and was happy to do a flyover for the kids in his U.S. Army blue and yellow open-cockpit 1941 Stearman two-seater biplane PT-17, that was used for training in World War II. Jacobi, 78, Noblesville, a retired Noblesville High School math teacher has given hundreds of airplane rides in his Stearman over the years. And Another Thing...

1. Chinook Salmon

The salmon are swimming! The Indiana Department of Natural Resources said it is increasing Chinook salmon stocked in Lake Michigan by 50,000 starting in spring 2023 The change will increase the annual production target for Chinook from 225,000 to 275,000. Baitfish populations have rebounded from an all-time low in the mid-2010s after lake-wide stocking reductions made by all state agencies during the past decade. Staff from Mixsawbah State Fish Hatchery recently traveled to Michigan to obtain Chinook salmon eggs to meet the new production target. Fish from the eggs will be raised at Mixsawbah to be stocked in April 2023. They will spend one to three years feeding in Lake Michigan before returning to their stocking sites as mature spawning adults in the fall. He was a 1953 graduate of Farmland High School and a graduate of Purdue University, earning a Bachelor's degree in Mechanical Engineering and a Master's degree in Industrial Engineering, working his way through school as a waiter. Upon graduation from Purdue, he worked at Western Electric as an engineer.

He volunteered for the US Army National Guard from 1958-1961, serving as a Recon Utility Cargo Helicopter Repairman, rising to the rank of Specialist E-4 and earning a Course A Marksman riflery badge.

In the mid-1960s, Mr. Wagner owned and operated a Mobil service station in Lawrence, Ind., for three years. In addition to being an avid reader, bridge player and investing hobbyist, Mr. Wagner was an enthusiastic inventor, always trying to build the perfect mousetrap. He enjoyed numerous road trips and vacations with his wife and sons, both stateside and abroad. He was well-known for his dry wit and deadpan delivery of puns and groaners. He also had a true passion for magic tricks, though his shyness prevented him from performing publicly.

Alongside his wife, Mr. Wagner spent decades participating in the Hamilton County Theatre Guild in Noblesville (The Belfry). Beginning in 1991, he helped with set building as well as running lights and sound. He made a brief but memorable appearance on stage in the 2010 production of Guys and Dolls. Mr. Wagner was a member of the Belfry's administrative board for many years, serving both as secretary and president. He also created and maintained the Belfry's original website in the early 2000s.





"Nige and I are kind of alike," Hammer explained. "We got into this pretty young. I think I was 19. We ended up starting out at smaller stations. I went to work at 104.5, the Bear. Actually, I think I replaced Nigel.³

Nigel Laskowski agreed. He graduated from Tri-West High School (Hammer from Beech Grove) in 1994.

"I started off at a contemporary Christian radio station doing every shift I could possibly get when I turned 18 . . . making \$5 an hour," Laskowski said. Like a lot of folks in the media, Laskowski worked at a few places, including KLBJ in Austin Texas in late 2007. After that he "came back home, started the podcast with Hammer and a few years later here we are."

Both men, now in their 40s, share a passion for

Laskowski was similar, although his goal wasn't necessarily talk radio.


"I remember my parents listening to Rush (Limbaugh) but didn't know about politics or what any of it meant when I was a kid. I remember being fascinated at the notion of one guy sitting in a studio and talking for three hours and millions of people listening. I listened to the rock and pop stations in town and when I got older Bob and Tom . . . I thought about it constantly . . . almost obsessive!"

The two men think about it a lot now, and not just during their work days.

And then even afterward. We'll see something and text the other one. We're always working on the show."

and is the longest of all time, he said.)

While the show is about deception, crime and murder, keep in mind this is "Chicago: Teen Edition." So it is a little tamer.

Neubauer said, "The high school version eliminates some swearing, and some of the darkest humor is eliminated or lightened. But the story is intact, and the spirit of the show remains."

The cast is costumed appropriately for this production, Neubauer said. And that means primarily a black color palette, like the Broadway musical.

He said, "It is different from other recent (NHS) productions with its more adult themes. But we have not focused on them. They are, however, part of the story. Gotta tell the story."

The 1975 musical has music by John Kander, lyrics by Fred Ebb and book by Ebb and Bob Fosse.

"I would say emulating the Fosse choreographic styles is the most challenging for the students," Neubauer said. "Fosse style is well known and closely associated with 'Chicago.'" (Fosse is best known for sultry hip rolls, smooth finger snaps, turned-in knees, sideways shuffle, rolled shoulders and 'jazz hands' with props, such as bowler hats and chairs.)

Shantel Morris is the show director and lead choreographer. "Shantel has done an incredible job of pushing the students to capture as much of that as possible," Neubauer said.

Morris isn't alone in her choreography role. New NHS assistant choir director Julianne Fowler, is also a choreographer alongside Morris and who has extensive choreography experience, and she has taught several numbers herself. Plus assistant choreographers Stephenie Knoll, Bailey Mann and Jeanne Wade have helped with specialties like tap dance and some comedy numbers. "Everyone worked as a team," Neubauer said. NHS Miller Girls Dance Team under the direction of Mann is also perform-

as choreographer as well as acting co-director on previous shows in the past. "We sit down as a team each year and discuss who runs point based on the show content and who has capacity to direct in any given year," she said. In the past 10 years, besides Morris and Neubauer, the show's technical director Greg Richards (NHS theater, public speaking and English 10 honors teacher) has directed as well as Debbie Wittstein (retired NHS music teacher) and Ryan Shelton (youth theater director and former elementary school teacher). Prep work for "Chicago" began with summer intensive workshops that covered a handful of dance combos as well as dramatic workshopping to understand the history behind the show since it is based on a true story in a specific time period, Morris said. "We knew that Fosse technique would be foreign to the majority of students and wanted to give them a full perspective of the show content and expectations so they knew how best to prepare." Rehearsals for the show began in August, not long after classes began. "We started with a read-through and sing-through of the entire show and gave broad expectations of the dedication and concentration the students would need to have to make this a grand success," Neubauer said. "After that, we dove into teaching music. Students were simultaneously working

on their lines. Once some of the material was in the students' brains, Shantel began staging everything. The choreography and the blocking work together seamlessly. The staging and the choreography feed each other and drive the story forward."

Each school year, Neubauer and his artistic staff "bat around lots of ideas and take stock of what show we believe will

would explore the Indiana frontier years later.

Richard eventually ended up among the Shawnee Indians in southern Ohio. There he met Margaret Boyer, a young white girl who'd been taken captive by the Shawnee during the French and Indian War.

According to one source, Boyer was a French name, but other references maintain the family was of German descent, with Bauer, Beyer or Bayer the original spelling. That seems more likely given the area of eastern Pennsylvania in which they lived.

In his book, "Sons of the Wilderness," Charles N. Thompson cites a tradition handed down in the Boyer family which holds that Margaret's family had a farm near Lehigh Gap (north and a little west of today's Allentown, Pennsylvania.)

One day during the war, Margaret's father left his wife at a nearby fort, and took their three children with him to their farm. While he was plowing a field, Indians attacked. The father was killed and the children were taken prisoner. Margaret was only six years old at the time.

Margaret's brother was released after a few years and returned home, but the Boyers' two little girls remained with the Indians.

Richard asked the Shawnee for permission to marry Margaret. His request was granted, but he had to pay \$200 and promise that the couple's first-born son would stay with the tribe. (That seems like an incredible amount of money for those days, but that's what was in the book.)

Richard and Margaret remained among the Shawnee for a while, living in a village that came to be Despite the Moravian missionaries' efforts to keep their Christian Indians (primarily Lenape, or Delaware, as they're commonly known,) neutral in the conflict, the British viewed the Moravian villages as a threat and wanted to break them up.

In the fall of 1781, the missionaries and their followers, including the Conners, were captured by Indian allies of the British and marched north to the Sandusky River.

By then, Richard and Margaret had four little boys — James (Richard had tracked him down and ransomed him from the Shawnee,) John, William and the baby, Henry. It was said Henry was so fair-haired, Margaret darkened his hair on the journey to make it less noticeable that the family was white.

The Conners eventually regained their freedom and settled in New Gnadenhütten, a mission Reverend Zeisberger established north of Detroit. A daughter, Susanna, was born there in 1783.

The Moravians left New Gnadenhütten three years later, but Richard decided to stay put. The Conners were now the only whites in an area populated by the Chippewa tribe.

For the next 20 years, Richard farmed, ran a trading post and bought up land in what later became Michigan's Macomb County. When he died in 1807, he left his family over 4,000 acres.

Margaret Conner died in 1813.

At the auditions, "in addition to acting, singing and dancing talent, we were also looking for personality, variety and a willingness to take chances," Neubauer said. "'Chicago' is not typical. The presentation and choreo are not typical. So the kind of student that will thrive in that atmosphere is also a little 'edgier' than usual."

Morris agreed. "The audition process is always tough, but everyone grows from it whether they are cast or not. We tell students to audition as much as possible all over town as it prepares them on how to better their personal expression and brand for all things in life," she said.

Morris has been a part of the NHS musical directing team for more than 10 years and has served build student interest, be supported by the community and also inspire the students to strive," he said. "We also have to work within the confines of our auditorium, budget, and available personnel."

Typically, Neubauer would be the show director, but he's handed the duty off to Morris this year. "Shantel has such a clear vision of what she wanted this show to look like, sound like, feel like. So she's taking the reigns. It's wonderful," he said.

Morris' first time seeing "Chicago" was a national tour when she was a teen. "I was mesmerized," she said. "The choreography and styling was completely different from any classical training I had as a dancer as Fosse seemed to break all the rules, which I loved."

Morris and Neubauer agree that "Chicago" is an "in your face" piece of satire.

"This form of art is a hard pill to swallow when the audience is made aware that we, as society, play a part in sensationalizing and therefore potentially encouraging bad behavior from rogue individuals out for instant fame, Morris said. "'Chicago' may appear that it celebrates people making bad decisions when, in fact, the intent is to showcase the ugly nature of how society still gives a platform to people, like Roxie and Velma (the co-lead female roles), who use their bad behavior for the spotlight. Crime, unfortunately, still sells."

Neubauer said, "Can't wait for the kids to unleash their talents and bring this to life."
