## Spartz Kicks Off 2023 Farm Bill Listening Tour

On Monday, Rep. Victoria Spartz (R-Ind.) kicked off her Farm Bill listening tour with a roundtable in Howard County at the Downing's family farm in Greentown and speaking at the Hamilton County Farm Bureau policy meeting. Rep. Spartz will continue her listening tour throughout the rest of the Fifth District this week.

"Agriculture plays a major economic role in the Fifth District economy," said Rep. Spartz. "It's always important to hear directly from the ground on issues affecting our producers and raising food security concerns."

Every five years, Congress reauthorizes legislation to set national agriculture, nutrition, conservation, and forestry policy, commonly referred to as the "Farm Bill".

## Virtual Museum Features New Exhibits



that Wayne Township's J. S. Simmermon had been showing friends a copy of the Intelligencer, an old Noblesville newspaper. The issue, dated November 23, 1839, had been preserved as a family heirloom - although the Ledger didn't explain why the Simmermons felt it was worth keeping.

I found little information about the Intelligencer besides the fact it was politically aligned with the Whig party, probably because it didn't last long. In the words of the Ledger, "although it was but nine weeks old, conspicuous in its editorial columns was the announcement of its suspension." I'm afraid that newspaper has long since crumbled into dust. Moving along to another exhibit I covet . . . The June 1, 1870, Hamilton County Register reported that M. W. "Wallie" Essington, the county's "efficient and untiring Recorder," had just finished creating a new map of Noblesville that showed all the most recent additions and outlots, as well as the new (Crownland) cemetery. He also made an index as a reference to go along with the map. The map measured 4'x5,' and was to be framed or mounted and kept in the County Recorder's office. (At that time the office was a small brick building that occupied the spot on the courthouse square where the old Sheriff's Residence and Jail now sits.)

The November 23, 1929, Noblesville Daily Ledger noted that the wife of Tipton businessman Simon Rosenthal had recently acquired a book published in 1838 by J. H. Colton, one of this country's early map makers. Designed to accompany a map of Indiana, the directory and travel guide contained statistical, historical, geographical and business information about Indiana's 88 counties.

### PAULA DUNN From Time to Thyme

Spring has brought a change of exhibits to the From Time to Thyme Virtual Museum! Come on in and don't crowd — there's room for everyone (especially since this is a museum that only exists in cyberspace.)

Our first exhibit is an artifact Jacob Case dug up in the alley beside his Cicero home in 1908. (Why he was digging in the alley, I don't know.)

According to the July 3, 1908 Enterprise, Case's find was a medal from Abraham Lincoln's 1864 campaign. The medal, which was in surprisingly good condition, sported a likeness of Lincoln in profile on one side, along with the inscription, "Abraham Lincoln for president 1864." The other side featured the U. S. Shield.

The Enterprise pointed out that Case, a Civil War veteran, undoubtedly valued the medal highly, so maybe it ended up being passed down in his family.

Our next stop is an item I'd have liked to have gotten my hands on.

The April 26, 1901, Hamilton County Ledger mentioned

I'd love to know where that map is today. Good early maps of Noblesville aren't easily come by

Speaking of maps, our final exhibit is a book that includes a map.

Yes, that's 88, not 92. Tipton and three other counties didn't exist then. At that time the southern part of what is now Tipton County belonged to Hamilton County.

An interesting feature of the map is that the Central Canal is included among the "principal streams" of Hamilton County, even though the canal wasn't yet finished (and never would be.)

The Ledger declared that Mrs. Rosenthal's book was probably the only one of its kind in existence.

Um, no, it isn't.

After doing a little research online, I determined that her book was most likely "The State of Indiana Delineated." If I'm right, at least one other copy is still around. A first edition showing a little wear, but in decent condition, was sold by a Chicago auction house last year for . . . \$1,375!

It's a good thing this is a virtual museum. If it was real, I'd have to hire guards!

## Westfield Paramedics And EMS Personnel Receive Award

On February 15, paramedics and EMS personnel with WFD were called to childbirth in a car on U.S. 31 at 10:55pm. Upon arrival, it was determined that the baby's birth was imminent.

"We were driving from our home in Kokomo to an Indianapolis birth center when my wife Rebecca went into labor," said Jared Simoneaux. The couple quickly called the birth center, which told them to pull their vehicle over and immediately call 9-1-1. "Everyone remained calm, and we got the help we needed. The Westfield Fire Department did a great job," said Jared.

Baby Anna was delivered in the back of the ambulance while parked on the shoulder of U.S. 31. Rebecca and her infant daughter were transported to the hospital and later released. Indiana Department of Homeland Security EMS Director Kraig Kinney presented the department's Stork Award to EMS-certified professionals who assist with a non-hospital delivery of a newborn as part of their EMS duties. Director Kinney states, "EMS professionals are called upon many times daily to respond to challenging calls that are often life-altering, including bringing new lives into the world. Another Indiana family has a happy story to tell for many years to come about how baby Anna was born with the help of the Westfield Fire Department."

While not everyone was in the back of the ambulance delivering the baby or taking care of Rebecca and Anna, it took a team to ensure the safety of everyone involved as the ambulance was stopped along U.S. 31 with two patients needing care. 



## Proposal Would Block Foreign 'Threats' From State's 'Critical Infrastructure'

A bill aimed at protecting Indiana's critical infrastructure from four countries — China, Iran, North Korea and Russia easily advanced through a House committee Monday.

Lawmakers also overhauled a provision blocking those foreigners from buying land near military facilities.

"We certainly do not want to give control of any of our critical infrastructure over to companies owned or controlled by citizens of bad actor states that seek to do harm to the United States," Rep. Ethan Manning, R-Logansport, told the public safety committee Monday. He's the House sponsor for the Senate-born legislation.

Critical infrastructure refers to sectors crucial to a functioning society, such as roads, energy, water and communications systems.

"Foreign governments with nefarious purposes like to use our own democracy and economic freedom against us but we should not allow this to the extent possible, so this is a step in the right direction," he continued.

Indiana's General Assembly has already approved a law banning the state and local governments from buying telecommunications equipment or services that are on a Federal Communications Commission list of security threats.

Manning called Senate Bill 477 a "follow-up" to that 2020 law.

It would use a broader "covered list" from the FCC of communications equipment or services considered an "unacceptable risk" to national security.

It would ban the state and local governments from contracting with "prohibited" entities — citizens and companies from those four countries, and any others the governor deems a threat - on "critical infrastructure" projects. Under existing law, that includes chemical, aluminum, paper, pharmaceutical and other manufacturing, plus utilities, hazardous waste storage and more.

And the bill blocks those citizens and companies from buying or leasing land next to military facilities, effective at the end of June. Lawmakers on Monday tweaked the bill on the spot to include Indiana National Guard assets.

"We're not necessarily identifying an existing issue, but trying to ensure there isn't an issue in the future where somebody may come in and purchase land next to a military facility, or take over a power plant, or a highway or a dam or something," committee chair Randy Frye, R-Greensburg, said.


They also added a process for stripping land from people or entities that violate the proposal: the attorney general would investigate the purchase and appoint a receiver, who would sell the land back off. Real estate experts said the bill would've otherwise interrupted the legal chain of ownership over the land.

"What that [amendment] does is it protects the chain of title [and] it puts a process on it that also satisfies due process concerns that could arise if we just say, 'It's prohibited,' and we roll back," said Elizabeth Berg, a property attorney speaking on behalf of the Indiana State Bar Association. She also said the change would shift legal burden from the seller to the buyer.

"If a prohibited person did do it it's that person that gets in trouble," Berg said. "And then the state has the ability to put that property back into someone else's hands, to own it, to do something with that property to keep it on the tax rolls."

The committee advanced the bill unanimously, 12-0. It now goes to the full Senate for potential amendments and, later, a final vote.

She's been riding for 10 years and has her own horse, Bama. "Lately, it's making me really happy." She is in Law and Government Academy. She also volunteers with her former junior high to serve as an outdoor education counselor for students. She played basketball her freshman and sophomore years and was awarded the Mental Attitude Award, joined Unified Track her junior year, and earned academic awards in Health, French, Geometry, Honors English and was Top 10 percent of her class every year. She was also voted homecoming queen by her student body "because she is kind to everyone, and people see the compassion she has for others," said Joy Volz, her English teacher. "She has a strong work ethic and personal standard for herself that have helped her succeed in the classroom and on the soccer field," said Travis Kauffman, her social studies teacher.
