What makes Dan Clark smile? "Doing events like this, and my family," said the 73-year-old Carmel resident, who was found Saturday morning at the first Noblesville Farmers Market of the season, collecting donations, with the Thurber family, from the vendors who have food to donate to the Hamilton County Harvest Food Bank. He expected to collect lots of vegetables and some microgreens that would be distributed through the food bank and then on to food pantries around the county. "They'll do this all summer ... It's perishable goods they donate. They're really, really generous. It's a great thing that happens for the families who are in need in this county." The former vice chancellor at Ivy Tech Hamilton County in Noblesville, who was at the campus for six years, is still staying busy. Besides volunteering, he said, "I'm working with some school corporations to figure out some more opportunities for students." Clark was born and raised in Lafayette but had an early family connection to Noblesville. His dad started coming to Forest Park in the 1930s. "He had relatives here." Then Dan's children played in Forest Park as they grew up. "We came to Noblesville a long time ago because we appreciated the range of people who live in Noblesville and thought that was a good environment for our children." He and his family lived in Noblesville for 26 years before moving to Carmel a year ago. His wife, Anne Minnich, served on the Noblesville Parks board for 15 years. He has two daughters, Kylie Clark, physical therapist in Arvada, Colo., and Jenna Clark, children's mental health counselor in Owatonna, Minn. He said he's finally found time to exercise more, and he walks a lot. He also likes to ride his bicycle. He said, "Just enjoying the things I can do now."

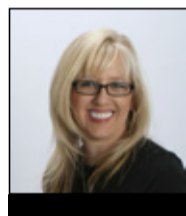

Adams Township is the Hamilton County Bicentennial Commission's featured township in May. That means it's time for the Adams Township quiz!

9. Name two of the three main landmarks currently found in East Union, the tiny neighborhood at the intersection of U. S. 31 and 296th Street.
10. Sheridan High School has long been a power in Class 1A football. How many state championships has Sheridan won?

And the answers:

1. Sheridan was laid out by Egbert Higbee in 1860 as Millwood. (You get the Woo Hoo! if you knew Millwood beat out Phineasville, Higbeeville and Pioneer City.) "Millwood" later became "Sheridan" for the usual reason — Indiana already had a Millwood post office.
2. Pickett's Autumn Gold Sorghum. Blacksmith Warren Pickett began producing the sorghum in 1913. After his death, his son and grandsons kept the popular family business going until a fire destroyed the factory in 2009.
3. Abolitionist and pioneer educator George Boxley built the township's first cabin in 1828 on a hill on what would later be the north side of Sheridan. (That very cabin was restored in recent years by the Sheridan Historical Society and you can visit it on Saturdays from June to September.)

HSHC continues to take in over 4,000 animals every year, including those at-risk for euthanasia at other shelters. Their no-kill status and philosophy means no animal will be turned away due to age, disability, medical needs, or breed.

# Secretary Diego Morales Speaks At Anti-‘Woke’ Conference In Hungary

Indiana Secretary of State Diego Morales jetted to Hungary last week to speak at a right-wing conference, but it wasn't on the state dime, according to his office.

The Conservative Political Action Coalition has hosted annual conferences in the United States for decades, but went global last year with a Hungarian edition — and continued this year on Thursday and Friday. Organizers billed it as “the world’s preeminent international conservative

gathering” on a dedicated website.

“As a Conservative Republican, I was proud to be invited to speak at CPAC,” Morales wrote on his campaign Facebook page. He spoke during the “Make Kids Not War” segment of the event, according to the agenda.

The schedule featured a video message from former Fox News host Tucker Carlson during a “No Woke Zone” panel. Unsuccessful Arizona gubernatorial candidate Kari Lake spoke in person, as did several other American conser-

vatives. Rightist leaders from Hungary, Georgia, the Czech Republic also delivered remarks.

Morales’ activities drew sharp criticism from Hoosier political opponents.

“What in the world is Diego Morales doing?” Indiana Democratic Party Chairman Mike Schmuhl said in a statement Monday. “Indiana held municipal primary elections less than a week ago, military ballots are still arriving, and several races were incredibly close, yet Indiana’s top election official decided to jet off to a political conference

in Eastern Europe for a photo op with [Hungarian Prime Minister] Viktor Orban.”

“Working Hoosiers deserve elected officials that represent the best in Indiana, stick around and do their job during critical times,” Schmuhl added, before rebuking Morales for other controversial moves.

Morales’ office said he took personal time off Thursday and Friday to attend the conference, and that no other state staff attended and no agency or taxpayer money was involved.

“It was paid through

private funds,” spokeswoman Lindsey Eaton said in an emailed response Monday.

Asked how the trip was related to Morales’ official duties, Eaton said, “The role of a public official such as the Secretary of State includes interacting with and learning from diverse communities and constituencies, as well as sharing information about our state.”

Orban, a champion of what he calls an “illiberal democracy,” spoke of battling “woke culture” in his keynote speech Thursday, according to

the Associated Press. For him, that has included promoting conservative Christianity while cracking down on Muslim migrants and LGBTQ people, among other initiatives.

Provided however, that if a vehicle arrives to the storage facility on or after 9:00 p.m., the storage fee shall not begin to accrue until the day after the next business day the vehicle arrives.  
(4) Removing a vehicle from storage \$25  
(5) Lien fee \$75  
(6) Window wrap fee \$50 total

**Bernard To Go Before Medical Licensing Board This Month, Despite Rokita Attempt To Delay Hearing**

The Indiana Medical Licensing Board will hold a hearing later this month on a complaint against Indianapolis OB-GYN Dr. Caitlin Bernard, despite an attempt by the Attorney General’s Office to further delay the matter.

Bernard, who is at the center of a controversial abortion case, will appear May 25 and Board members will weigh whether the doctor violated professional standards.

Indiana Attorney General Todd Rokita sought to push the licensing hearing back until August and delay other deadlines. However, the Medical Licensing Board denied those requests, according to new case filings.

But the board did rule in Rokita’s favor on a separate point of contention, determining that Bernard must give another deposition — which the doctor said in earlier filings she wanted to avoid.

The matter stems from an ongoing legal saga surrounding the doctor, who last year oversaw a medication abortion for a 10-year-old rape victim from Ohio. The case became national news and was a factor in allowing a rape and incest exemption in Indiana’s abortion ban.

Rokita advanced a complaint in November against Bernard to the Medical Licensing Board. He maintains that Bernard “failed to immediately report the abuse and rape of a child to Indiana authorities” after performing the girl’s abortion.

Rokita also argues that Bernard “failed to uphold legal and Hippocratic responsibilities” by “exploiting a child’s traumatic medical story to the press for her own interests.”

Contention over depositions

The licensing board held a pre-hearing conference April 27. Up for discussion were numerous, separate motions filed by both the attorney general and Bernard’s attorneys.

Earlier, Bernard requested a protective order to abstain her from further questioning by Rokita’s office.

The doctor sought to “prevent or limit” her deposition because “she has already testified on multiple occasions and produced discovery responses on these issues.”

“As such, any further deposition would be cumulative, duplicative and an undue burden,” Bernard’s attorneys said in filings with the board.

The state deposed Bernard in November shortly before she testified under oath during a preliminary injunction hearing. The doctor also provided a sworn declaration and other written responses requested by the attorney general.

Bernard’s counsel held that — in contrast to the entire day Rokita’s office said would be necessary for the doctor’s deposition — the state asked for only one hour to depose other key witnesses.

“Certainly, a deposition that imposes no limits on topics or time is guaranteed to duplicate the questions to which Dr. Bernard has already provided sworn answers on multiple occasions,” her lawyers said in an April 20 filing.

“The state’s proposed, unrestricted deposition would keep Dr. Bernard away from her patients and her students to ask her questions to which she has already given an answer.”

But Rokita argued that Bernard’s “continued attempt to preclude or limit her deposition” deprives his office and the Medical Licensing Board “of the full picture of her conduct at issue.”

In oppositional legal filings, his office said Bernard has only provided “limited” or no testimony pertaining to:

- her education and training in patient privacy laws and regulations
- her understanding of her employer’s policies on patient privacy and reporting of child abuse
- her knowledge of Indiana University Health’s Risk Assessment paperwork
- her prior communications with the media and anyone who may have been in her vicinity when she talked to an IndyStar reporter about the Ohio

•any communications she had with the hospital social worker who reported the case to Ohio authorities

“Considering this, her deposition is surely needed,” the Attorney General’s Office wrote.

Rokita further requested the Medical Licensing Board delay Bernard’s hearing until August 24 — six months after its initial setting.

He said the both sides needed more time to review evidence and legal documents, as well as to complete other depositions.

Bernard pushed back, saying both sides can be ready for the May hearing.

“Any delay would be harmful to Dr. Bernard who is ready to move forward and have this matter resolved,” he attorneys said in an April 26 filing.

“She is eager to present evidence to respond to the State’s claims and clear her name.”

In orders issued late last month, the board ultimately rejected Rokita’s request to delay, but granted his motion to depose Bernard.

Dr. Kirk Masten, administrative law judge and Medical Licensing Board vice president, wrote that limiting questioning of the doctor would not be necessary.

Still, the board also granted another of Bernard’s motions to keep confidential any documents or written answers she submits in response to requests from the Attorney General’s Office.

Bernard had asked to keep such documents from public disclosure in the online License Litigation Portal to the extent they might contain “protected health information.” That might include responses with references to information in patient records, for example.

What happens next

Ahead of the hearing later this month, counsel for the Attorney General’s Office and Bernard must file with the board and exchange their final lists of witnesses and exhibits.

Prior to the hearing, each side is also allowed to conduct depositions. That means Rokita’s office can

depose Bernard, as long as the line of questioning does not stray into facts that have been established by prior testimony or discovery responses.

The final hearing in the matter is set for May 25 in Indianapolis. Both parties agreed to allow out-of-state witnesses to testify virtually.

Last summer, Bernard sued to stop Rokita’s office from obtaining certain patient records related to her care for the 10-year-old, who sought an abortion in Indiana after her pregnancy progressed beyond the 6-week cutoff in Ohio.

Bernard’s legal team voluntarily dismissed the case after it transitioned to an administrative licensing action before the Medical Licensing Board. The court officially dismissed the case Nov. 12.

Rokita filed to reopen it Jan. 9 to refute a Marion County Superior Court judge’s finding that he violated state confidentiality laws. A court ruling from that case said that Rokita violated the law during a televised appearance in which he called the healthcare provider an “abortion activist acting as a doctor.”

In court filings, Rokita called the judge’s order an “erroneous finding.”

Rokita withdrew his request to reopen the case in April, saying it’s no longer necessary.

In the latest filings with the state licensing board, Bernard continues to maintain that her public comments about the 10-year-old’s case were within the bounds of medical privacy rules. She also argues that she “could not” have knowingly violated Indiana’s child abuse reporting law because her notification to authorities was consistent with policies in place at IU Health, where she practices.

this? Boxley — or Boxleytown, as it was sometimes called — was laid out in 1836 not by George Boxley, but by his sons, Addison and Dr. Thomas P. Boxley. They named their town in honor of their father.

5. Blackhawk Airport. Owner Lloyd G. Bailey, a Sheridan High School alumnus, named his airfield after the school's athletic teams.

6. One hundred and ten years ago this month Sheridan was nearly wiped off the map by a fire that started at the Weaver Lumber Company. There were no fatalities, but over 20 businesses were destroyed, as was the Wesleyan Methodist Church and its parsonage. In addition, most of Sheridan's early records were lost when the town hall burned.

7. Store owner James McKee, who founded the community, named it Ekin in honor of Civil War General James A. Ekin. General Ekin is best known for being a member of the military commission that tried the conspirators involved in the plot to assassinate

Abraham Lincoln.

8. The Monon Railroad happened. After the tracks were laid through Sheridan in 1882, all the business and travelers that had kept Boxley humming went to Sheridan instead. Sheridan grew and Boxley gradually got smaller.

9. Okay, this isn't really history, but I couldn't come up with a good historical question for East Union. More crossroads than community, East Union consists of a few homes, the East Union Cemetery in Adams Township, the East Union Christian Church in Jackson Township and Lisa's Pie Shop, which is on the north side of 296th Street and is actually located in Tipton County.

10. The Blackhawks have won nine state championships, all under coach Larry "Bud" Wright — 1980, 1984, 1987, 1988, 1992, 1998, 2005, 2006 and 2007.
