Lynda Arbuckle has been a Hamilton County 4-H Dog leader for 50 years.

And she soon will have her own parking space and a sign with her name on it at the Hamilton County 4-H Fairgrounds in Noblesville.

The 83-year-old Noblesville woman -- who was presented a parking sign last Friday during the 4-H Fair Queen Pageant -- got involved in 4-H when her oldest daughter, Dawn (Arbuckle) Moos, joined 4-H and wanted to take the Dog project and show her English Setter, named Lynda (born on the mom's birthday).

"She is truly a legend," said Allison Moos of Noblesville, a 2006 Noblesville High School graduate, who told her grandmother's story to the audience

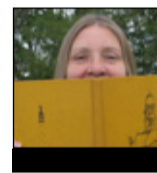

## Hamilton Heights Huskies' Family Tree

From Time to Thyme

My cousin, Kermit Ross, recently showed me a program book from the 2015 Hamilton Heights Alumni Association reunion that contains an impressive history of the Jackson Township and White River Township schools.

(Both Jackson and White River Townships are covered because the two school systems have been combined since the creation of Hamilton Heights.)

The history, compiled by one of Kermit's Jackson Central '61 classmates, Ed Fennell of Arcadia, was passed out to everyone who attended the reunion. Kermit brought it to my attention because he felt there might be a column in it.

Once I got a good look at all that information, I had to agree.

The earliest schools in Indiana were subscription schools where tuition was paid by students' parents. After the enactment of the new state constitution in 1852, schools began to be managed by townships.

That's where Fennell's history starts.

In the beginning, White River Township had 16 township schools and Jackson Township had 20. Fennell notes that, in both cases, the schoolhouses were situated about two miles apart in order to keep students from having to walk more than one mile to reach their classes.

I have to admire the effort he put into this work because I know from my own research on Noblesville Township that digging up precise details on those early schools isn't easy. The information you find is often incomplete and/or confusing.

Township schools were usually designated by numbers, but sometimes they're only referred to by a name, which makes it difficult to pinpoint their location or even be certain which school is which.

Also, a school's number and/or location could change over time. For example, Walnut Grove was originally White River Township School No. 8, but it was later moved to another location and became No. 15.

It wasn't until the late 1800s and early 1900s that things began to settle down.

In Jackson Township, the first high schools were located

# Congresswoman Houchin Introduces No ESG Act To Limit Far-Left Proposals

Congresswoman Erin Houchin (R-Ind.-09), a member of the Financial Services Committee and the ESG Working Group, introduced the No Expensive, Stifling Governance (No ESG) Act. The bill would prevent far-left activists from forcing everyday investors to vote on duplicative or substantially similar Environmental, Social and Governance (ESG) shareholder proposals.

"Southern Indiana companies shouldn't have to deal with duplicative far-left shareholder proposals year after year. That's why I've introduced this first of its kind legislation to put an end to redundant ESG proposals so that meetings can stay focused on the financial best interests of shareholders," said Congresswoman Houchin.

The No ESG Act would stop a new proposed rule under the Securities and Exchange Commission (SEC) that would greenlight left-wing ESG proposals even if shareholders have recently rejected similar proposals. In doing so, this bill provides companies with the means to exclude duplicative or substantially simi-

lar shareholder proposals to save time and money for everyday investors. This is the first bill of its kind to be introduced in Congress.

Last week, Congresswoman Houchin spoke in the Financial Services Committee on the need to reform the current shareholder proposal process.

#### Background:

Many companies, including those with a large presence in the Ninth District, must deal with duplicative or very similar ESG shareholder proposals every year. Constituents who are invested in these companies have to repeatedly vote on these proposals or delegate their voting power to another entity, even when substantially similar proposals have failed. The proposed rule would add burdensome corporate bureaucracy and divert attention away from actual business matters.

This bill seeks to cut down on these redundant proposals and keep shareholder meetings more focused on issues that would promote the financial best interest and overall business operations.

# Indiana Donor Network Maximizing Use Of Latest Technology To Save More Lives

Organization reports a 25% increase in recoveries for transplantation from January through June compared to same time period 1 year ago.

With two quarters of 2023 complete, Indiana Donor Network has surpassed the number of organ recoveries it achieved during the first two quarters of its record-breaking year of 2022, putting the organization on pace to save more lives than ever this year.

From January through June 30, 804 lifesaving organs were recovered, a 25% increase in the number of organs recovered during the same time period one year ago. Additionally:

- 232 organ donors and 734 tissue and cornea donors were facilitated by the organization.

- 8,442 tissues were recovered by the organization.

In 2022, during the same period, 645 lifesaving organs were recovered by Indiana Donor Network. Additionally:

- 155 organ donors and 617 tissue and cornea donors were facilitated by the organization.

- 6,994 tissues were recovered by the organization.

"We are maximizing

use of the latest technology available to increase the time organs can remain viable outside the human body as they are transported to patients waiting for a transplant," said Indiana Donor Network President and CEO Kellie Tremain. "These technological advancements are increasing the viability time of donor organs and substantially increasing the time we have and the distance we can span to get these gifts to those whose lives depend on them. Our successes are also due to our growing, hard-working staff, each dedicated to saving and healing lives through various critical roles."

In 2022, Indiana Donor Network began utilizing revolutionary kidney perfusion pumps, which are used in operating rooms during organ recovery and during a donated organ's transport to a transplant center. These pumps keep donated kidneys functioning outside the body, allowing the organ's temperature and vascular performance to be constantly monitored and increasing its viability for successful transplant. Donated kidneys on perfusion pumps can now be transported up to

250 nautical miles from Indiana Donor Network's Organ and Tissue Recovery Center in Indianapolis, reaching patients at 40 transplant centers throughout the Midwest.

"We've widened our organ donor criteria, enhanced our donor management operations and are utilizing advanced organ recovery coordinators to perform diagnostics and procedures," said Sherry Quire, director of organ services at Indiana Donor Network. "We've added surgical recovery specialists and a surgical medical director. We are also now utilizing a real-time, geo-tracking system to monitor transport of donated organs during all phases of their transport to transplant centers and optimize logistics for recovery, transport and transplantation teams."

Lindsay Hamilton, director of tissue services at Indiana Donor Network, attributes the five-month rise in tissue recoveries to stronger relationships with the organization's tissue recovery partners, which are critical links between tissue donors and recipients. Indiana Donor Network's tissue recovery partners manage the identification of donors and tissue retrieval,

preservation and transportation.

"We've worked diligently to enhance and expand our relationships with our tissue recovery partners," Hamilton said. "Many of our partners have expanded their criteria to accept more tissue donors and donors of increased age."

Currently, there are 1,259 Indiana residents waiting for a lifesaving organ transplant and more than 4.3 million Hoosiers registered as organ donors.

Indiana Donor Network, a non-profit organization, is the federally designated organ recovery organization that coordinates organ, tissue and cornea donation in Indiana and transplantation throughout the U.S. Its mission is to save and enhance the quality of life through organ and tissue donation and transplantation. Its vision is to be a leader in organ and tissue recovery. Founded in 1987, the organization coordinates donation in 85 of the state's 92 counties and serves transplant hospitals throughout the U.S.

SEE PROPOSED ORDINANCE ATTACHED AS EXHIBIT A After the public hearing, the Hamilton County Council may act on the proposed ordinance. There is no remonstrance opportunity on any action taken on the proposed ordinance. The public hearing identified above is the taxpayer's opportunity to express concerns and ask questions on the proposed ordinance.

WHEREAS, Hamilton County, pursuant to Indiana Code 6-9-18 et al., previously adopted a 5% inkeeper's tax as set forth in Section 6-9-18-3 of the Hamilton County Code; and,

WHEREAS, Indiana Code 6-9-56 authorizes the fiscal body of Hamilton County to increase in the inkeepers tax rate for Hamilton County to a tax not to exceed the rate of 8% on the gross retail income derived from lodging income only and is in addition to the state gross retail tax imposed under Indiana Code 6-2-5; and

WHEREAS, Indiana Code 6-9-56 authorizes the county fiscal body of Hamilton County to adopt an ordinance that would require the tax to be paid monthly to the county treasurer with said tax funds being allocated to separate specific funds, namely the current convention, visitor and tourism promotion fund ("tourism promotion fund"), and also a new tourism capital fund;

WHEREAS, Hamilton County previously created the Hamilton County Convention, Visitor and Tourism Commission in accordance with Indiana Code 6-9-18-5;

IT IS THEREBY ORDAINED by the Hamilton County Council that Section 6-9-18-3 of the Hamilton County Code is amended as follows:

(a) A tax shall be levied on every entity, person, corporation, or other business combination engaged in the business of renting or furnishing, for periods based upon a daily basis or multiples thereof, any room, lodging, or tourist cabin in the county.

(b) The tax does not apply to gross income received in a transaction in which a person rents: (1) Lodgings in a college or university residence hall;

(c) The tax shall be levied at the rate of eight percent (8%) on the gross retail income derived from lodging income only and is in addition to the state gross retail tax imposed under IC 6-2-5.

(d) The tax shall be paid monthly to the county treasurer, which shall be paid to the county treasurer not more than twenty (20) days after the end of the month the tax is collected.

(e) The county treasurer shall establish the following funds: (1) A Convention, Visitor, and Tourism Promotion Fund; and (2) a Tourism Capital Fund. The county treasurer shall deposit tax funds collected as follows:

(1) Tax received in the treasurer's collection of inkeepers tax funds that is not more than five percent (5%) of the funds collected shall be deposited into Convention, Visitor and Tourism Promotion Fund; and

(2) Tax received in the treasurer's collection of inkeepers tax funds that exceeds five percent (5%) of the funds collected shall be deposited in the Tourism Capital fund.

(f) The Hamilton County Convention, Visitor and Tourism Commission ("Commission") is hereby authorized to transfer money from the Convention, Visitor, and Tourism Promotion Fund and Tourism Capital Fund in accordance with this ordinance and Indiana Code 6-9-56.

(g) The county auditor shall issue a warrant directing the county treasurer to transfer money from the Convention, Visitor, and Tourism Promotion Fund and Tourism Capital Fund to the Commission's treasurer if the Commission submits a written request for the transfer.

(h) Money in the Convention, Visitor, and Tourism Promotion Fund or money transferred from such a fund to the Commission may only be expended to promote and encourage conventions, visitors, and tourism within Hamilton County. Expenditures from the Convention, Visitor, and Tourism Promotion Fund may include expenditures for advertising, promotional activities, trade shows, special events, and recreation. The Commission may transfer money in the Convention, Visitor, and Tourism Promotion Fund to any Indiana nonprofit corporation for the purpose of promotion and encouragement in the county of conventions, trade shows, visitors, or special events. The Commission may transfer money under this subsection only after approving the transfer. The Commission may transfer money under this subsection on a monthly basis or at another frequency as determined by the Commission.

(i) Money in the Tourism Capital Fund, or money transferred from such a fund to the Commission, may only be expended on infrastructure projects that improve or benefit the tourism economy. Expenditures from the Tourism Capital Fund may include acquisition, construction, alteration, improvements, or installation costs of any existing tangible property or tangible property that is to be constructed. Expenditures may include fees for professional services such as architectural, building consulting or planning, and infrastructure feasibility.

(j) The Commission must approve any transfer of money from the Tourism Capital Fund and may transfer money from the Tourism Capital Fund to support capital projects in the county that promote long term tourism, convention, or recreation projects proposed by any of the following:

(1) The county government;

(2) A city government;

(3) A separate body corporate and politic in Hamilton County; or

(4) Any Indiana nonprofit corporation in Hamilton County.

The Commission may transfer money under this subsection on a monthly basis or at another frequency as determined by the Commission.

(k) The Commission may also review and approve proposals submitted by applicants that seek money from the tourism capital fund with the purpose and view of enhancing or providing support for capital projects that promote long term tourism, convention, or other economic development related to recreation. Funding available under this subsection shall be made available on an annual basis. In determining whether to provide funding to a particular capital project under this subsection, the commission may use the following factors as a guide for capital project funding:

(1) The proposed capital project is believed to be economically sound to the Hamilton County tourism, convention, or recreation economy and is also believed to be beneficial to:

(A) the general population of Hamilton County; or

(B) a particular location in Hamilton County.

(2) The proposed capital project provides for reasonably adequate public assembly, gathering, or entertainment space and is integrally related to enhancing the tourism, convention, or recreation opportunities in Hamilton County or a particular location in Hamilton County.

(3) The Commission makes a reasonable effort to assess whether a proposed capital project aligns with the purpose of the Commission and has a direct, indirect, or supportive relationship to the mission and promotional efforts of the commission as established and funded by the convention, visitor, and tourism promotion fund.

A capital project proposed by an applicant that does not meet at least one (1) of the criteria set forth in this subsection will not be funded, and any remaining funds collected revert to the tourism capital fund for distribution by the Commission on projects within Hamilton County. An applicant that receives a grant of money from the tourism capital fund under subsection must agree to provide to the Commission proof of project completion, including proof that the project was completed through the use of the grant money; and may be subject to annual financial reporting and audit.

(1) All money coming into possession of the Commission shall be deposited, held, secured, invested, and paid in accordance with statutes relating to the handling of public funds. The handling and expenditure of money coming into possession of the Commission is subject to audit and supervision by the state board of accounts.

(m) This Ordinance shall supersede the present terms of Section 6-9-18-3 of the Hamilton County Code and the prior terms of said section are expressly repealed.

(n) This Ordinance shall be effective on January 1, 2024.

Maximizing Use Of Latest  
Technology To Save More Lives**

Organization reports a 25% increase in recoveries for transplantation from January through June compared to same time period 1 year ago.

With two quarters of 2023 complete, Indiana Donor Network has surpassed the number of organ recoveries it achieved during the first two quarters of its record-breaking year of 2022, putting the organization on pace to save more lives than ever this year.

From January through June 30, 804 lifesaving organs were recovered, a 25% increase in the number of organs recovered during the same time period one year ago. Additionally:

- 232 organ donors and 734 tissue and cornea donors were facilitated by the organization.
- 8,442 tissues were recovered by the organization.

In 2022, during the same period, 645 lifesaving organs were recovered by Indiana Donor Network. Additionally:

- 155 organ donors and 617 tissue and cornea donors were facilitated by the organization.
- 6,994 tissues were recovered by the organization.

"We are maximizing use of the latest technology available to increase the time organs can remain viable outside the human body as they are transported to patients waiting for a transplant," said Indiana Donor Network President and CEO Kellie Tremain. "These technological advancements are increasing the viability time of donor organs and substantially increasing the time we have and the distance we can span to get these gifts to those whose lives depend on them. Our successes are also due to our growing, hard-working staff, each dedicated to saving and healing lives through various critical roles."

In 2022, Indiana Donor Network began utilizing revolutionary kidney perfusion pumps, which are used in operating rooms during organ recovery and during a donated organ's transport to a transplant center. These pumps keep donated kidneys functioning outside the body, allowing the organ's temperature and vascular performance to be constantly monitored and increasing its viability for successful transplant. Donated kidneys on perfusion pumps can now be transported up

to 250 nautical miles from Indiana Donor Network's Organ and Tissue Recovery Center in Indianapolis, reaching patients at 40 transplant centers throughout the Midwest.

"We've widened our organ donor criteria, enhanced our donor management operations and are utilizing advanced organ recovery coordinators to perform diagnostics and procedures," said Sherry Quire, director of organ services at Indiana Donor Network. "We've added surgical recovery specialists and a surgical medical director. We are also now utilizing a real-time, geo-tracking system to monitor transport of donated organs during all phases of their transport to transplant centers and optimize logistics for recovery, transport and transplantation teams."

Lindsay Hamilton, director of tissue services at Indiana Donor Network, attributes the five-month rise in tissue recoveries to stronger relationships with the organization's tissue recovery partners, which are critical links between tissue donors and recipients. Indiana Donor Network's tissue recovery partners manage the identification of donors and tissue retrieval, preservation and transportation.

"We've worked diligently to enhance and expand our relationships with our tissue recovery partners," Hamilton said. "Many of our partners have expanded their criteria to accept more tissue donors and donors of increased age."

Currently, there are 1,259 Indiana residents waiting for a lifesaving organ transplant and more than 4.3 million Hoosiers registered as organ donors.

Despite age or medical history, anyone can sign up to be a donor at [DonateLifeIndiana.org](http://DonateLifeIndiana.org).

Indiana Donor Network, a non-profit organization, is the federally designated organ recovery organization that coordinates organ, tissue and cornea donation in Indiana and transplantation throughout the U.S. Its mission is to save and enhance the quality of life through organ and tissue donation and transplantation. Its vision is to be a leader in organ and tissue recovery. Founded in 1987, the organization coordinates donation in 85 of the state's 92 counties and serves transplant hospitals throughout the U.S.

4-H Dog leader because she was good at handling dogs. "I had no training. I just did it. I enjoyed it. I always enjoyed dogs," she said, while watching Monday's Dog Obedience Contest getting started.

"I was always the family person who, whenever anybody in the family got a new dog, I would go and sort of work with it so it wouldn't jump up on them," Arbuckle told me five years ago, when she was celebrating her 45th year. Arbuckle, as a kid, had a Toy Collie, and hunting dogs, then Beagles and Basset Hounds after she was married and started a family.

"I think it's important to know how the legend of Mrs. Arbuckle started, and began and grew to what it is today," Moos said.

Linda Arbuckle's daughter, Dawn, was in tears because her favorite 4-H project, which was dog obedience, was going to be canceled because she didn't have a leader.

So her mom decided to become the leader.

Arbuckle took over 50 years ago for Kay Lancaster, the 4-H Dog leader, who was also leader of the growing Horse & Pony project.

Arbuckle remembered there were roughly three others who wanted her job and 35 4-H'ers in the program.

The family has enjoyed the 4-H Dog project so much that Arbuckle's children and grandchildren have not only been 10-year 4-H'ers in the Dog project, but some of them have followed in Arbuckle's footsteps joining her as 4-H Dog project leaders.

"We've met so many nice people through 4-H," Arbuckle said.

Dawn (Arbuckle) Moos, 63, "who always had a dog," and can remember how her family always took in dogs, is now a 4-H Dog project leader of 37 years.

Arbuckle's new sign -- which is to be installed this week in front of the Hamilton County Exhibition Center at the 4-H Fairgrounds -- is long awaited. I remember talking to Arbuckle five years ago, when she celebrated her 45th year, and she was looking forward to a parking sign in her name to commemorate 50 years of volunteering. At that time, she had no intention to retire, because, she said, she was "still waiting" on her parking space.

Why is the 4-H Dog project good for kids?

"I think it's important. It teaches them responsibility, and that's one of the main things that we try to teach in the 4-H Dog project. The 4-H'er needs to be responsible for their care; that, No. 1, helps the dog bond with the 4-H'er. They (canines) really look to whoever provides their food and water as their person to bond to," Dawn Moos told me during a prior interview.

She loves being a leader and teaching the 4-H'ers. "It's a great experience, having grown up with dogs," Dawn Moos said.

Moos said her mom has been "an excellent role model as a mom and a 4-H leader."

Dawn's sister, Beth (Arbuckle) Lawler, 60, is a 4-H Dog project leader of 35 years. Their brother, Brad Arbuckle,

58, has also been involved in the 4-H Dog project and was a leader for a few years. Dawn's daughter, Allison Moos, 35, Fishers, has been a 4-H Dog leader for 15 years. Dawn's son, Adam Moos, 40, is a former 4-H Dog Agility leader and is now a professional dog trainer.

The Dog project is great for kids because it teaches important life skills, the three generations agree.

"It teaches you how to have a lot of patience and a lot of caring and love," Arbuckle has said. "The dog is a very faithful animal and wants to be loved all of the time."

She has said, "A lot of people say when you learn to train a dog, it gives you a lot of experience in working with kids...."

Arbuckle and her children all see eye-to-eye, "like two peas in a pod," with their 4-H Dog training. "We all believe in positive training and we don't believe in hitting and whipping.... You praise the dog when they do things right, and they will do anything for you then." They also follow the 4-H state rules and regulations.

Each year, "hundreds" of 4-H'ers come through the 4-H Dog program. In 2010, there were 238 4-H'ers enrolled in Dog. "We were the largest Dog Project in the country," Moos said.

"Each year, it's been an enormous group of kids." Arbuckle is so loved and so great at what she does. "Her love and dedication doesn't just stop when the Fair is over or only on Tuesdays.

For several years, she was in charge of the horticulture building on the Fairgrounds.

When her own kids were growing up, she made sure they practiced at home what they learned at the weekly 4-H Dog Obedience class. "Normally, I would want them to practice 20 minutes every day or every other day," she told me. "They enjoyed it, so they worked with the dogs."

Arbuckle has said her daughter Dawn showed Lynda, the English Setter, in 4-H, then later showed Shannon, an Irish Setter who had been dumped at their house in the countryside. "We took her in. We took a lot of dogs in that way. We lived out in the country on a farm, and people always seemed to dump dogs and cats, and we always took them in and took care of them," she told me.

Arbuckle divides 4-H Obedience into five groups, who are trained with the help of other 4-H Dog project leaders, for nearly an hour each week beginning in March. Then the advanced 4-H'ers are trained the second hour, plus 4-H Dog Agility and Dog Showmanship are also offered, with the help of other leaders.

The 4-H motto is to "make the best better" and Arbuckle has been doing that for 50 years.

The community is invited to attend an open house where Arbuckle will be honored for her 50 years of service from 2 p.m. to 5 p.m. Sunday, Sept. 3, in the Exhibition Center at the 4-H Fairgrounds.

in Atlanta, Arcadia and Cicero. Atlanta's first high school graduation took place in 1896, Cicero's was in 1898 and Arcadia's was in 1899.

Meanwhile, back in White River Township, a new building was erected for Walnut Grove in 1903. The following year Walnut Grove became a commissioned high school. The school's first graduating class -- all seven members -- received their diplomas in 1905.

(Commissioned high schools were those bearing commissions from the state board of education, as opposed to those managed by the township.)

With the establishment of the two townships' high schools, athletics came into play. (No pun intended.) Fennell provides the mascot, school colors and fight song for each high school from this point on.

Walnut Grove's teams were called the Wolves, and the school colors were gold and purple. The Arcadia Dragons' colors were black and gold, while the Atlanta Cardinals' colors were red and white, the same as Cicero's Red Devils.

In 1943, all Jackson Township high school students began attending

school in Arcadia when Jackson Central High School was created. Jackson Central's mascot was an eagle, and the school colors were a patriotic red, white and blue.

The consolidation of Jackson Central and Walnut Grove in 1965 resulted in the creation of the current high school, Hamilton Heights. (Of course, we know they're the Huskies and their school colors are brown, orange and white.)

The largest section of Fennell's program book is comprised of lists of alumni from Walnut Grove (1905-1965,) Atlanta, Arcadia and Cicero (1896-1943,) and Jackson Central (1944-1965.)

Also included are a couple of maps showing the approximate locations of the township schools, memorials and tributes, and drawings of the various buildings by Walnut Grove graduate Sam Gibbons.

Kermit told me he's heard there may be an update to the program book this year.
