"I just enjoy watching these kids," said the Westfield resident and executive director of the Indiana Sheep Association, who was found watching youth compete in the Sheep to Shawl Contest at the Indiana State Fair. "I come down to support the Sheep to Shawl Contest and several other activities that the Association has," he said. Benson was the highest bidder, at \$400, on an orange, pink and ivory freshly-woven scarf (above) that was made by the Conner Prairie youth volunteer "1970s Flower Power" spinning team during the four-hour contest. Benson, who has been involved with the Sheep Association for 30 years, has been attending the Sheep to Shawl contest since it started about 15 years ago. "I have fun, and it's tremendous to watch them," he said. How many scarves did he bid on? "I just bid on one today." He's bid on and won several youth scarves through the years at the contest "I like to support the wool industry," he said. "The spinning and weaving is also a part of the sheep legacy that we have over the years." He was born in Ohio and transferred here from St. Louis, Mo., in 1968, and said, "I've been here ever since." He's a member of Westfield Lions Club. He has a wife, three children, and she has two, and they have three grandchildren. He has been retired "for a long time." Benson was found watching the contest with Larry Hopkins, former president of the Indiana Sheep Association and owner of Little Eagle Creek Valley Farm in Westfield, which donates fleece to the Conner Prairie spinning program. Benson said, "I do the executive job as a volunteer because I have a passion for the industry." 

Every year, the Sheep to Shawl finds dozens of youth spinners, including my daughter, competing on teams that have four hours to make a scarf, from start to finish, including carding the fleece, spinning it on spinning wheels, plying wool strands together and weaving it into a scarf.

The south end of the main floor of the Indiana Arts Building is filled with youth on spinning wheels and weaving looms. It's such a great event to watch.

Conner Prairie textile specialist and Conner Prairie's longest employee Sue Payne trains Conner Prairie youth volunteers, ages 10 to 18, male and female, beginning each spring during "spinning training" at

youth volunteers sit at their spinning wheels or weaving looms practicing their skills, knowing that they're keeping alive the tradition of the historic art.

The spinners learn not only to compete at the State Fair but also to volunteer in Conner Prairie's Loom House, which is also a goal for youth, who need to attend 10 spinning practices (20 hours with Payne) before competing.

"The most satisfying part for me, and bittersweet, too, is watching them come in at 10 or 11 years old and maturing, working with others, setting personal goals and being excited to learn new skills," Payne said.

Early Sunday morning on Aug. 20, Payne and her spinning volunteers, and their parents, packed up 22 spinning wheels, four weaving looms, raw fleece and boxes of equipment and headed, in a convoy, to the State Fair Fairgrounds to spin and weave in an intense and fun competition.

Upon arrival, at 8:30 a.m., youth set up their team areas with chairs, spinning wheels,

Hamilton County Legislators Seek Statehouse Interns For 2024 Session

Local lawmakers are seeking interns to join them at the Statehouse during the 2024 legislative session.

According to House Speaker Todd Huston (R-Fishers), House interns will be paid \$900 bi-weekly as they work in downtown Indianapolis during session, which starts in January and concludes mid-March.

"The House Republican internship is a unique opportunity for students and recent graduates to explore their interests, build their portfolio and gain work experience," Huston said. "Whether it's helping constituents or working on policy, House interns manage a lot of responsibilities, and this program can help set them apart from other candidates when looking

for future jobs." State Rep. Chuck Goodrich (R-Noblesville) said House internships are open to college students and recent graduates of all majors.

"This internship is a great opportunity for students to develop new skills, network and work through challenges that will prepare them for the competitive workforce," Goodrich said. "I hope to see local Hoosiers apply for this rewarding experience."

Paid, spring-semester intern positions are full time, Monday through Friday, and include free parking, career and professional development assistance, enrollment access to an Indiana government class, and opportunities to earn academic credits through

the student's college or university. Interns are also eligible to apply for a competitive \$3,000 scholarship to use toward undergraduate and graduate expenses.

"Internships are critical to developing time management, communication and writing skills that will be used in any career," said State Rep. Chris Jeter (R-Fishers). "I encourage students to apply for this opportunity where they will build their resumes and make lifelong professional connections.

According to State Rep. Donna Schaibley (R-Carmel), students can apply for internships in a variety of departments related to their field of study, including legislative operations, policy, and communications and

media relations.

"Whether it's covering committees or press conferences, our interns are key to helping session run smoothly," Schaibley said. "Students and recent graduates looking for a unique and rewarding internship at the Statehouse should apply soon."

State Rep. Jerry Torr (R-Carmel) said applications are available online at indianahouserepublicans.com/internship and are due by Oct. 31.

"This is a great opportunity to serve Hoosiers while taking on more responsibility as a young adult," Torr said. "Our interns work directly with legislators from across Indiana, and get a firsthand look at how laws are made as well as the impact they can make on Hoosiers.

board that has been so prevalent in local and national news lately isn't the first time that censorship has reared its ugly head in Noblesville.

In 2002, an equally misguided Noblesville School Board voted to ban the book, "Follow the River" by another Indiana author, James Alexander Thom.

Thom's book had been on the required 10th grade reading list at Noblesville High School until a parent complained about one scene in Chapter 27. Wiser parents, who understood the literary value of that historical fiction book, lobbied the board to reinstate it on the reading list. Their pleas were ignored.

How is it that a tiny minority of small-minded, fearful parents are allowed to take away the freedom of other parents to decide what their children can read? If any parent does not want their child to read a specific book, that's their rightful decision. That parent could have worked with the school to get the child exempted from reading and class discussion of that particular book. Problem solved. No one else's freedoms are infringed upon.

But is that what happened? Oh hell no. The school board in 2002 couldn't do anything as simple and as reasonable as that. All Noblesville 10th grade kids were forbidden to read that book and discuss it in class, all so that one kid wouldn't be subjected to it. Government overreach and overreaction? Yes.

That board's misguided decision got some press coverage, too. When the Indiana chapter of the American Civil Liberties Union read about it, the organization hosted a marathon reading of the book at Noble Coffee and Tea in protest of the school board's action.

Proud card-carrying member of the ACLU that I am, I took part in that well-attended reada-thon and later wrote a poem about it titled, "The Banned Book."

The poem was published in the 2018 edition of The Polk Street Review, which was founded, coincidentally, by the newest member of the HEPL board, Bill Kenley. I am sharing the poem here.

The Banned Book In the coffee house on the town square, we took turns reading aloud from the book banned by the school board, censored for the erotic fantasy that swept through one character's mind, as if such ideas would never occur to those high school readers, they with their riotous hormones.

One of those students joined us on that day. He settled into the leather chair, opened the book and read words forbidden to him, while his parents looked on.

One by one, others read:

- A mother
- a lawyer
- a plumber
- a neighbor
- a business owner
- a cook,

and people passing by,

lending their many voices so that intellectual freedom could live in America for one more day.

Censorship is never a good choice for any community. It speaks of small minded authoritarians and their attempts

to limit the intellectual freedom of its residents. That includes the intellectual freedom of its children. Parents are the best arbiters of what their children should or should not read and when they should read it.

My mother gave me books with content now being censored at HEPL when I was a young teen. She told me to read the books and then we would talk about them. I did and we did. I learned things I needed to know and she answered all my questions. Nobody tried to tell her or me that I couldn't read those books, and that's as it should be. She knew when I needed to have that information and she made sure I got it. In America, land of the free, that's every parent's right.

I know of no instance in history where the censors were the good guys. I subscribe to President John F. Kennedy's view on the subject, published in the Oct. 29, 1960 issue of the Saturday Review:

"If this nation is to be wise as well as strong, if we are to achieve our destiny, then we need more new ideas for more wise men reading more good books in more public libraries. These libraries should be open to all-except the censor. We must know all the facts and hear all the alternatives and listen to all the criticisms. Let us welcome controversial books and controversial authors. For the Bill of Rights is the guardian of our security as well as our liberty." JFK



The Lease will enable the Authority to finance the costs of (i) the planning, designing and construction of the Pleasant Street Corridor from the intersection of 10th and Pleasant Street, eas to just east of the intersection of Pleasant Street and 19th Street, and from the intersection of Hague Road/State Road 32 to just west of River Road, together with all necessary appurtenances, related improvements and equipment, in, serving or benefiting the Areas (collectively, the "Phases II and III Project"), (ii) the refinancing of outstanding Redevelopment District Bond Anticipation Notes of 2022 of the Commission (the proceeds of which were used to provide preliminary funding for the Phases II and III Project) and (iii) costs of such financing. The Lease provides for payment by the Commission of lease rentals from a special benefits tax levied under Indiana Code 36-7-14-27, to the extent not paid from tax increment revenues from the allocation area for the Pleasant Street Economic Development Area and any road impact fee revenues pledged by the City to the Commission for such purpose. 

weaving looms and more on the performance floor of the Indiana Arts Building.

Beginning at 10 a.m., the youth had four hours, until 2:30 p.m. (with a 30-minute break for lunch) to make a scarf in this annual Sheep to Shawl contest, with judging and an auction of the scarves following.

To make a scarf, the youth volunteers do everything from carding a fleece, which is preparing it for spinning, to spinning it on spinning wheels, to plying, which is twisting two strands of wool together, then weaving it.

While there were also two adult teams this year, all eyes were on the youth teams.

"I think the youth bring an element of pushing creative boundaries to the contest," said Sarah E. Morin, Conner Prairie's youth experience manager. Morin and Bill Freil, Conner Prairie's interpretation coordinator, oversee the youth and help run the contest.

"Early on, their pattern and colors much more closely mimicked what the adult teams were doing, just on a smaller scale," Morin said. The first years were all natural, undyed fibers. "The youth asked to bring more colors into it. They tried 'zebra-plying' (which is two different colors in the same strand of yarn), painting the finished scarf, adding feathers and beads," she said.

This year was the first year that anyone spun metallic fiber into the wool. "While this contest is very much about keeping a historic craft alive, it's equally about making it fun and relevant to the next generation of artists.'

Morin remembers when she started working at Conner Prairie in 2003, and the competition started with one team. A second team was added the second year, a third team the next year

The boys team at the fourth contest -- dressed as Pirates of the Treadle with costumes, swords and a scarf design that incorporated the blackand-white flag that pirates had -- really shook things up. "The crowd roared and loved it," Payne said. "That was history and tradition in the making.

Then the girls' teams immediately wanted to do themes and costumes. For the past several years, they did overall themes, with this year's theme being "Decades" with teams dressing through the decades.

These themes influence the teams' choice of scarf colors, pattern and displays, Morin said.

What do the youth learn from the Sheep to Shawl Contest?

"So many things," Morin said. "Leadership, math, chemistry, patience, project planning, how to handle pressure."

But this year, especially, they learned "teamwork" and that "every member is essential to success." The program offered youth who didn't have the chance to work in a team much during the pandemic years a valuable opportunity to do so, she said.

While there is a maximum of eight on a team, only six can compete at a time. The fastest spinners, the best weavers and plyers, and the very best carders compete with their team the entire time, while their teammates, if any more than six, rotate out.

Another aspect of the spinning program is doing outreaches with Fishers Arts Council, Hamilton County Artists' Association and Nickel Plate Arts, with spinner youth demonstrating at art fairs, fiber events, Hamilton County Ag Days and more. "The kids love it, and it expands the exposure of their skills and bulbs their confidence," Payne said The spinning program has been in place for the past 15 years. Payne has been spinning and weaving for 40 years and was fortunate to learn the craft from "incredible weavers" at Conner Prairie, where she has been a member of the textiles staff all of that time. The

textiles staff makes the **Conner Prairie textiles** that are sold in the museum's gift shop.

"Sue Payne is awesome. She bends over backwards to help any youth who puts in a sincere effort to learn this craft, regardless of their beginning talent level," Morin said. "She has helped youth get into colleges and find their career path, and mentored them into graduating seniors ready to enter a successful adulthood."

Conner Prairie's youth volunteer spinning program got its start when six 12-year-old girls came to Payne asking to participate in the Sheep to Shawl competition at the State Fair. The State Fair judges were so impressed by the youth volunteers' work, a youth category was created.

"I will say the first six girls who also happened to be very strong at age 12 years old, put their hearts into that first contest, and I had no idea and never would have bet the program would turn into the amazing complex machine it has become," Payne said.

By the third year, there were 17 girls, and the beginnings of the mentoring by the more experienced youth were emerging, she said. "It almost seemed natural. We played 'Phantom of the Opera' at every practice and, when the teams were formed, the captains had little stuffed sheep as their mascots and named them after the main characters. They would work for hours, take breaks and it was almost magical.' While teaching the kids how to spin and weave, Payne said learning how to take apart a spin-

ning wheel and change a bobbin quickly and accurately was a major need. At the start of the third contest, "my wheel won't work" was heard, she said, like "chirping birds." So now, in practice sessions, when a youth says, "My wheel won't work," Payne calls out "teaching moment," and all of the youth volunteers come over and try to diagnose. "It's very exciting just

to see all of that energy and everything to get done in that four-hour time period," Morin said.

"Conner Prairie and the Youth Spinning Program particularly is fortunate to have generous people supporting us through monetary donations, purchase of scarves at the State Fair auction, donation of fleeces and wheels, and grants supporting instructional trainings," said Morin. We are grateful to the Indiana Sheep Association in particular for their longstanding support of the Sheep to Shawl contest."

The youth spinning program is part of the larger Conner Prairie Youth Volunteer Program in which youth volunteer on the historic grounds, in modern clothes and costume, interacting with the public and leading hands-on activities. The 2024 program is open for youth who will be 10 years old by April 1, with applications available in early October at www.connerprairie.org.
