Creek Township quiz. The more I dug into his life,

however, the more I felt he was worth a column of his own. Although he was never a Hamilton County resident, he did have a profound influence on this county's development.

Plus, he was a rather colorful character, to say the least.

Clarence Henry Geist was born on a farm in LaPorte County, Indiana, in 1866.

As a young man, he went west to seek his fortune. After five years of dealing in livestock, however, he realized there was no money to be made in the west because "no one in the west, at that time, had any money," so he returned to the Chicago area.

Following a short stint as a brakeman for the Rock Island railroad, he went into real estate. During that period, he became acquainted with future vice president of the United States, Charles. G. Dawes, and Dawes' brother, Rufus.

The Dawes brothers operated the South Shore Gas Company and it was through his association with them that Geist got into the public utility business. That's how he made his millions.

From his new home base in the Philadelphia area, Geist bought, developed and sold gas, ectric and water companies all over the country, including the Indianapolis Water Company which he purchased in December, 1912, as a personal investment. "The Indiana 'water boy,'" as journalist Cleveland Amory later referred to him, has been described both as "loud, vulgar and impolite" and as "suave and amiable.' You can debate which of those assessments is more accurate, but I don't think anyone would deny he was pretty quirky. In 1928 Geist bought the Boca Raton Club in Boca Raton, Florida, and turned it into a luxurious private club for millionaires. The small town of Boca Raton (population around 600) not only became Geist's winter home, it became his own little kingdom. Whenever his private railroad car arrived at the Boca Raton train station, he was greeted by a crowd and serenaded by a band. The performance was repeated each spring when he departed for the north. In 1938, Indianapolis Star reported that Geist played a round



pleasant for patrons and actors who are clothed in Elizabethan costumes.

"This year, the weather is much more enjoyable for both the company and the patrons," Otterman said. She's in her fourth season directing Noblesville Shakespeare in the Park, which also moves its start time up to 7:30 p.m. this season, to accommodate the earlier sunset.

Otterman talked about her love for directing Shakespeare in the Park.

"It is a most enjoyable job to be the director of NCAC's Shakespeare in the Park. I love working with Rob Heighway, the assistant director (and backstage crew member), as he has talent skills and knowledge. He is a master carpenter and can build any pieces of scenery we need," said Otterman, who knows Heighway "from many years ago" where they worked together as actors at The Red Barn Summer Theatre.

For this show, Heighway has constructed five 10-foot trees, as a portion of the play takes place in the forest of Arden. Those were on the Shakespeare set beginning Sunday and proved interesting, she said, to adapt the action around the trees just three days before opening night.

Otterman also enjoys working with her co-producers Joni Corbett and Ka'Lena Cuevas, "both competent women who I very much respect." Corbett is NCAC's board president.

"In addition, we are fortunate to have very talented actors audition, and they are so wonderful to work with, very cooperative in taking direction and giving their best," Otterman said During many years in the past, rehearsals were outdoors at Seminary Park, where productions took place until Federal Hill opened in 2017, on the 25th anniversary of Noblesville's Shakespeare in the Park.

While the audience sitting on the lawn sees the fabulous end product of the show, those who are involved in the show know how much hard work goes into making all of this possible.

Weeks of rehearsals have gone on since auditions in August. Sets have been made. Props and costumes have been found or created. Lighting and sound have been "designed." Mics have been added. Every day this week, crew members set up and break down the set.

And then it's finally show time.

And then there is the weather. Being an outdoor show, weather always plays a role in the show, whether it be the heat or the rain. At press time, according to the weather forecast, there is a chance of rain tonight, but evenings the rest of this week look good.

Otterman has had a great time working with the cast and crew.

"The company has had several laughs while working moments of the show. There is a lot of flirting between characters. Rachel Kelson (as Rosalind) and Logan Laflin (as Orlando) have created a fascinating relationship, but I cannot really give details lest I spoil the unveiling for the audience," Otterman said.

"There is a wrestling scene between Geoff Lynch (as Charles) and Logan (Laflin) where (fight choreographer) Eric Bryant has choreographed a fun exchange of physical prowess and humor," she said. "The two actors picked up the moves in one-half hour of rehearsal with Eric's coaching."

Otterman said there are some family connections in the show. Two young people, who are part of the merry band of Duke Senior's following who live in the forest with the banished Duke, are played by Rob Heighway's grandson, Austin Heighway (on guitar and mandolin) and Kayla McKee (vocals), the daughter of Matt McKee, "who portrays Touchstone with adept hilarity." She said, "It is inspiring to see another generation of actors being introduced to Shakespeare in the Park." Otterman describes the cast and crew as a "tight, friendly family" and the experience "refreshing." She said, "the entire rehearsal process has been delightful. During each game the avid golfer was followed around by a chauffeur-driven limo (there were no golf carts then) that contained three pairs of shoes, two thermos bottles of medicated water (I'm not sure what "medicated" means here) and a policeman with a loaded shotgun.

Geist took a drink of the water on nearly every tee and changed his shoes at every third hole.

According to the Star, the shotgun was supposed to be for any alligators or rattlesnakes Geist might stir up when he sent his ball sailing into the rough (which he often did,) however, Geist was also terrified of being kidnapped.

The possibility of a kidnapping scared him so much that he bought up every photograph of himself he could find. (Luckily, he missed a few.) He also kept an enormous checking account in case of a sudden need for ransom money.

All that paranoia amused his friends, one of whom remarked, "Nobody who knew him would want to kidnap him; if they did, they would have regretted it."

Geist did have a generous side, though. In 1931, he donated a \$15,000 "deluxe auditorium model pipe organ" to Indianapolis' Columbia Club, one of the many social clubs to which he belonged.

Buying that organ didn't strain Geist's finances a bit. When his estate was settled in 1939, it was worth \$10,976,042. Just think what that

would be in 2023!

## Attorney General Todd Rokita Takes Action Against Alleged Manufactured-Home Fraudsters

Lawsuit alleges Bartholomew County defendants schemed to evade licensing requirements.

Attorney General Todd Rokita has filed a lawsuit against three individuals suspected of scheming to defraud Hoosiers seeking installations of manufactured homes.

"We're acting on behalf of Hoosiers who in some cases paid tens of thousands for services they never received in a satisfactory manner," Rokita said. "Our team works diligently to protect the proverbial little guy from getting conned by slick hustlers just looking to make a quick buck. We will hold accountable anyone who dupes consumers in violation of our laws."

The lawsuit alleges the defendants — Steven Singer, Jocel Singer and Aron Singer — engaged in the sales of manufactured homes without a license from the Secretary of State Auto Dealer Services Division. The defendants, residents of Bartholomew County, are also alleged to have promised or completed installations of manufactured homes without a manufactured home installers license.

The defendants allegedly did business at times under such names as Singer Manufactured Homes, Cabin Creek Homes, Rock Creek Homes, and United Palace Home Transport and Sales.

One consumer complained about a transaction in which the defendants allegedly failed to arrange for installation of a manufactured home as agreed, failed to install working appliances as agreed, and otherwise failed to meet their contractual obligations to the complainant after she paid them \$36,000 in cash. The defendants also allegedly failed to deliver a title to the manufactured home — on which the complainant ultimately had to spend additional money to make livable. The complainant later learned the defendants lacked proper licensure to sell and install manufactured homes.

The defendants' alleged wrongdoing spanned many years.

In 2014, the defendants allegedly received a cease-anddesist order from the Manufactured Home Installers Licensing Board — but thereafter worked to hide their transactions from authorities by both insisting on cash and by conducting advertising/sales online using various social media accounts and marketplaces.

In February of 2023, the Indiana Secretary of State sent the defendants another cease-and-desist notice relating to alleged violations of dealership licensing requirements.
