# **For Christmas**

I was going through my mother's cookbooks and recipe files recently, looking for cookies to make for Christmas, when I ran across Mom's well-worn copy of "Kappa



**From Time** to Thyme

Kitchen Kookery That title should provide a clue that the recipes came from members of the local Beta Epsilon chapter of Tri Kappa sorority.

The cookbook, which dates from 1950, is also something of a historical document. Not only does it paint a picture of what was appearing on local dinner tables in the '50s, but it's kind of a Who's Who of Noblesville society at that time. If you've lived here as long as I have, you'd probably recognize the names of a lot of the recipe donors.

These cookie recipes were provided by three women I bet many of you will remember. (I edited the recipes lightly.)

#### **Gumdrop Cookies - Audrey** Haworth

1 C. brown sugar 1/2 C. butter 1 egg 1 C. gumdrops 1/2 tsp. vanilla 1/4 C. milk 2 tsp. baking powder 1 1/2 C. flour

Cream sugar and butter, add egg (and vanilla) and mix. Add milk alternately with flour and baking powder. Then add gumdrops. Drop by teaspoon on cookie sheet. Bake at 375 degrees about 9 to 12 minutes.

(Audrey Haworth was a fixture of the Noblesville Public Library for 50 years. She started as an assistant to the first librarian, Lulu Miesse, then she became the head of the library herself in 1945. Even after her retirement in 1973, she continued to serve as the curator of the Indiana Room.)

#### Ginger Snaps — Denzel Hufford (Mrs. M. L.)

3/4 C. shortening 1 C. sugar 1/4 C. light molasses 1 egg 1/4 tsp. salt 2 tsp. soda 1 tsp. cinnamon 1 tsp. ginger





Cream shortening, add sugar; add molasses and egg. Beat well and add sifted dry ingredients. Mix well. Roll in small balls, dip in sugar, place 2" apart on greased sheet. Bake in 370 degree oven for 15 minutes.

She received a Master Gardener certification when she was in her 80s!)

#### **Mexican Wedding** Cakes - Jerry Snyder (Mrs. Joe)

1/2 C. powdered sugar 1 C. butter 1 tsp. vanilla 2 C. flour 1/2 C. pecans, cut fine

Combine ingredients and roll into 3 or 4 rolls. Place in waxed paper and chill. After they set, pinch off small pieces, roll in balls and flatten. Bake in slow oven (300-325 degrees) for 30

minutes. Shake in sack with powdered sugar. (Like Denzel, everybody seems to have known Jerry and vice versa. Some of that came from her jobs at the Hoosier Dairy and local banks, and some came from her writing. She began penning columns in junior high and she continued to write for publication throughout the rest of her life.

Mostly, however, that was just Jerry being Jerry. I don't think she ever met a stranger.)

We have a few days left before Christmas. If baking cookies is still on your agenda, consider making one or more of these recipes.

The Noblesville woman has said, "I simply never tire of hearing the music." She said, 'The Nutcracker," to me, embodies every role a dancer would feel privileged to perform.

Every aspect of the magnificent music dictates the choreography to the student." This year's "Nutcracker" will be Ephlin's 72nd "Nutcracker," Ephlin, 77, said. We had **CLASSON** not The Postscript arrived early enough at my sister's church for the Christmas Eve service to secure a seat in the back, so we were in the fourth row. "Did you see the organist's kids in the front row?" my sister asked her husband after we got home. "Yeah," he said. I was about to make some snappy remark about their lack of grooming when my sister continued.

"Her husband left them just a couple of weeks ago. He won't even answer his phone when the kids call. Her son is autistic, and she is just beside herself." "The husband was there," my brother-inlaw told my sister. "He came into church at the very end." "Really?" my sister said and shook her head. I realized what a colossal ass I was. There are so many troubles I have never known. There is a world of pain I have never experienced. While I was dwelling on a couple of hastily dressed kids with messy hair quietly doodling in the front pew, there were wells of pain and loss and confusion right in front of me that I could not imagine. to be your humans. You

I do not like that prissy woman in the nice skirt who sits in judgment of those poor kids. I do not like her, and I don't want to be her. While I was focused on grooming and decorum, a tired, lost man took his child in his arms and-right in front of me-a Christmas miracle occurred, a miracle I was too blind to see.




# **Sheridan Coach Honored by Colts**
