Halfway through the meal, the woman confessed her deception. The men were amazed, but took the news in stride.

The Independent noted that the only "evil result" of the substitution was that "Mr. Frog" proved to be a bit

one "dear brother" to awaken from a nightmare that night, "croaking like a frog." The conference visitors' love of chicken dinners was apparently known even to

The Republican Ledger reported that when a large group of the visiting ministers passed a chicken coop outside Craig's grocery, one of the old hens in the coop promptly keeled over dead at the sight of them.

The May 18, 1888 Hamilton County Ledger observed that "the dudes of the city" had issued a decree prohibiting members of their group from putting their hands into their pockets further than their thumbs. The penalty for anyone caught doing so by another member was a rap on



it comes to music, some prefer gospel. Others country. Still others, rock'n'roll. Rap. Blues. Jazz. Southern Rock. Classical. The list goes on.

I'm not sure if I'm lucky or cursed, but I kind of like bits and pieces from almost all of it. I'm not huge on oldtime country, but I'll listen all day long to Waylon Jennings, Barbara Mandrell, Steve Wariner, Toby Keith. I grew up in the '60s and '70s, so how could I not like rock? I'll Take Five with Dave Brubeck.

But on this particular Saturday morning, it was the smoky sweet sounds of Nina Simone belting out Sinnerman. Simone didn't write the old gospel standard, but she surely baptized it as she belted out the story of the sinner looking to avoid judgment.

"Oh sinnerman, where you gonna run to . . . " Simone goes in one ear, rattles around, bouncing from the brain to your gut, down to your toes and ends up tugging at your heart. It's a voice only-"Timmons, I got a theory."

The unmistaken gravelly rasp of John Hammer wasn't loud, but didn't have to be to bring me out of the musical trance I was in office is closed, but dang – do you have to scare me half to death every time?" The man who is bigger than a John Deere tractor and tougher than a cheap steak didn't even blink. "We're not all seeing things the same," he said.



When shoe store owner Augustus Gumberts caught Peed violating the order, his attempt to administer the appropriate punishment met with the predictable result. The newspaper summed the incident up with,

"The festive little carpet tacks got in their work and now Gus carries his hand done up in court plaster and cuss words."

The June 1, 1888 Noblesville Ledger noted that courthouse janitor Ike Hiatt had distributed three dozen spittoons around the courthouse, along with signs admonishing everyone to "spit in the boxes."

When Ike pointed the signs out to attorney Levi Farley, the obedient Farley immediately made a circuit of the courthouse, pausing to spit into each one of the boxes Hiatt had laid out. Hiatt leaned against a bannister and sighed, 'Oh sheol.'"

(I had to look that one up. "Sheol" is Hebrew for the place you DON'T want to go when you die.) Finally, the September 3, 1880 Noblesville Ledger reported that Jim Crooks and Bill Conner (that's William Winship Conner, THE William Conner's nephew) were working in the county clerk's office when Crooks suddenly shouted, "Godfry Elihu!" and asked if Conner had ever smelled such a smell. "Never on God's green earth," came the reply. At that point, other courthouse workers had also noticed the "odoriferous oder" [sic] and had begun to fill the building's corridors, looking for the source. A "committee" was formed to track it down and within minutes they

discovered county tax collector Peter Lawyer sitting in a window in the Treasurer's office without his shoes on.

"That settled it, and Pete was straightway bounced."
