NHS Show Choir Goes 'Back to the Future' With Special Effects

Noblesville High School choir director John Neubauer will tell anyone who asks, "Show choir is absolutely always about

singing first." Choreography and staging and any special effects come second.

But NHS Singers, 59member varsity mixed show choir, is going over and above this year, literally. The high school's oldest show choir takes it to the limit during its competition set, themed "Back to the Future." The choir will perform the show on stage this Saturday night during NHS's inaugural daylong Indiana Show Choir Championships at NHS and again on stage March 20 at NHS's District Show Choir concert. NHS unisex show choirs New Dimension and Sensation will also perform at both events. In NHS Singers' show, a small-scale "DeLorean"

time-traveling machine and an eccentric scientist named Doc Brown are reminiscent of the "Back to the Future" 1985 scifi/comedy film and current Broadway musical of the same name.

Since performing the set, Neubauer has received feedback from many folks who say "Back to the Future" is their favorite

movie. "Without the movie memories, the show wouldn't make sense," Neubauer said. But because the movie is a pop-culture icon, the show, the characters, the staging and the car connect very well with the audiences." In the choir's competition show, the fog barrels and the air

compressor are even decaled and look like movie props. The story is about how Doc might have used his timetraveling machine for good after he invented it, Neubauer said. "The Singers' show does not seek to replicate the movie but rather extend the story and call on people's fond memories of the movie while exploring it a little differently," he said. The choir director became inspired to do the show about a year ago when he led a group of NHS students choir students to New York City, where they passed by the "Back to the Future The Musical" playing at Winter Garden Theatre. "I became even more inspired to investigate and pursue creating the show," said Neubauer, who in July returned to NYC to see the musical

At that point, Neubauer was determined to use the theme for NHS Singers' 2024 competition set. And, of course, the show would feature a time-traveling "DeLorean" along with all of the special

Neubauer had a small-scale "DeLorean" crafted from modeling clay then

commissioned Chicago-area artist Diane Capasso, whose daughter was a former show choir student, to create a "DeLorean" at 60-percent

"After the car was created, the (Noble) Roadies rented a truck, drove to Chicago and picked up "our baby." (Noble Roadies are backstage parent volunteers who travel with the NHS Singers and New Dimension show choirs and set up and break down the stage for every competition show.) Head Noble Roadie parent volunteer Andy McIntyre, whose wife, Stacy McIntyre is also a Noble Roadie, put together a team to figure out how to do everything that Neubauer wanted: to quickly raise the car in the air, to rotate the car 360 degrees while elevated and to do it all safely, "because John (Neubauer) wanted it to both lift and to spin," he said, doing the "DeLorean Dance." The car was mounted on a turntable with a paracord

School Nicknames, **Kindergarten Memories** and a History Mystery

another reader column! Several weeks ago when I asked for information on the origins of Hamilton

County's various high school nicknames, Jeanne Flanders wanted me to include the county schools that are no longer around — Walnut Grove, Jackson Central, Cicero, Arcadia, Atlanta, Adams Township/Boxley and Durbin. Unfortunately, I didn't

have room for them in the earlier columns. That wasn't the only problem, though. The biggest stumbling block was that the further back in history I went, the less information was available. Although I was able to come up with nicknames and school colors for some of those schools, I couldn't find any stories that explained why the nicknames were chosen. Jackson Central and Walnut Grove, the two schools that combined to create Hamilton Heights, were the Eagles and the Wolves, respectively. Jackson Central's school colors were red, white and blue. Walnut Grove's colors were gold and purple. Jackson Central was itself a consolidation of the Atlanta Cardinals, whose colors were red and white; the Arcadia Dragons, whose colors were black and gold; and the Cicero Red Devils, whose colors were also red and white.

In the early 1900s, all Adams Township students who didn't attend Sheridan High School went to school in Boxley. In the beginning, that school was called both "Adams Township High School" and "Boxley High School." Eventually, it became just "Boxley High School," but I don't know if that was an official change or if it was something that simply evolved from common usage. Although I couldn't find a nickname for Boxley High School, I did run across a mention of the school colors being blue and gold. As far as I know, the highest grade ever offered at Durbin was 8th grade, so there were no high school teams. Durbin students usually attended Walnut Grove, Lapel or Noblesville once they reached high school age.



Westfield Loses Jake Gilbert as Football Coach



Westfield High School is losing Jake Gilbert as football coach. The Wabash College alumnus and standout WHS coach is going back to his alma mater to join the coaching staff as defensive coordinator for the 2024 season. Thereafter, Gilbert will take over for Don Morel as the head coach in 2025. Gilbert has posted a

103-55 record in 13 seasons at Westfield since 2011, including a 43-10 mark (.811) over the last four seasons. Along the way, Gilbert's Shamrocks claimed three Hoosier Crossroads Conference (HCC) titles, made eight state playoff appearances, and won the 2016 Class 5A state championship. Thirty-

six of his players earned all-state honors and 43 were named academic all-state. "My purpose is to love, lead, and have a positive impact on others," said Gilbert. "This opportunity allows me to give back to the place that taught me how to live that way. I've been hungry for a new challenge, and I'm honored that Coach Morel, Matt Tanney, and President Scott Feller consider me worthy to work alongside them. We have a shared vision of fulfilling the special mission of the College." On the field, Gilbert's success has led to a trophy case full of honors. His accolades include being named HCC Coach of the Year three times (2013, 2020, and 2021), the Indiana Football Coaches Association Coach of the Year twice (2013 and 2016), and the Fellowship of Christian Athletes Indiana Coach of the Year in 2017. Gilbert was selected to coach in the Indiana All-Star game in 2014 and 2024. He has served as president, vice president, and director of the Indiana Football Coaches Association. He was twice the Midwest winner and national finalist for the American Football Coaches Association Power of Influence Award (2020 and 2021), which honors coaches for the positive impact they have on their team, as well as the legacy they leave with the school and surrounding community.

at WHS. He served on the City Council, ran for mayor of Westfield and was a board member of the Heart and Soul Free Clinic from 2020-23. Gilbert was president of the Wellbeing Coalition of Westfield, an organization that exists to address community well-being issues through a collaborative approach. He was named the Westfield Community Volunteer of the Year in 2023. From 2006-10, Gilbert served as an assistant coach at Wabash, handling offensive line duties in 2006-07 and serving as the defensive coordinator from 2008-10. In that span, the Little Giants posted a 46-10 (.821) record with three NCAA Division III Playoff appearances. Gilbert was the head coach at North Montgomery High School in Crawfordsville for six seasons beginning in 2001. While there, four of his players earned all-state accolades, while 10 garnered academic allstate honors. He got his start in coaching at Ben Davis High School in Indianapolis under legendary coach Dick Dullaghan, where he served as an assistant coach for two seasons during which time the Giants won 26 games and captured the Class 5A state championship (1999).Gilbert graduated from Wabash in 1998 with a degree in history and earned a master's degree in education from Purdue University in 1998. He and his wife, Christina, have three sons, Jackson, Logan, and Tyson. "With Coach Morel and Coach Gilbert, Wabash is fortunate to have leadership of the football program with an unwavering commitment to its present and long-term success," said Tanney. "It's an exciting day to welcome Coach Gilbert back to campus. His onfield success, combined with his passion for preparing men for life after football, is a superb match for our athletics program. In a program with consistently high aspirations, Coach Morel sustained a winning tradition for eight years and contributed much to the life of the College. I look forward to partnering with both Don and Jake to

Extension Project Begins in Carmel

Work is beginning on the complete, the White White River Greenway north extension project. The City of Noblesville is a Combined Sewer Community, which means that some of the sewers in the older part of the City transport both storm and sanitary wastewater to the treatment plant. Normally, only Stormwater discharges to the river from any outfall pipe. During high intensity large volume rain events, the capacity of the lines transporting the combined liquid to the treatment plant may be exceeded. Points in the line exist to allow the system to relieve the excess combined flow to the normally storm-only line in order to avoid property damage.

This discharge into a receiving stream is a combination of the storm and diluted.

The Utility has placed signs at each of the eight (8) outfall structures where the combined waste flow can potentially discharge to a receiving stream. There is a risk of becoming sick if you come into contact with this water. It is advisable that you do not wade in the streams during high intensity high volume rain events.

controls the rotation. To make the car rise, Noble Roadie parent volunteer Charlie McMillan used a manual hydraulic transmission jack that he converted to a compressed airoperated jack, which is activated remotely from offstage using a specialbuilt compressed air system, which the student Pit Crew members nicknamed "The Nuke." The jack was bolted to a 150pound custom-cut halfinch steel plate to counter the weight of the car, McMillan said. The timing and motion of the car is controlled remotely by two student Pit Crew members. With the remote lift and remote puppeteering of the car, the illusion is that the car is suspended in the air high above the choir. "The fact that we were called out in one of the show choir blogs that they thought the 'DeLorean' was actually hanging from the ceiling was really a testament to all of the work that has gone into it," McIntyre said. "Of course, Charlie using the transmission jack was really the thing that made that all happen." As the concept developed, Neubauer saw a need for lighting effects and fog. Roadies stepped up again and created the effects. Noble Roadie parent volunteer Steve Johnson created a wireless onboard light show that was

controlled remotely offstage. With the lighting added, the car weighed about 200 pounds.

Then Neubauer asked for "more fog" and "more lights." To answer Neubauer's request for more fog, McMillan custom built four 55-gallon mobile barrels that contained pre-heated water and dry ice to create the fog that discharges out of connected ductwork from the barrels onto the stage. The barrel size and design allowed for more and fasterreleasing fog that fills the stage and quickly dissipates, exactly what Neubauer desired. "The key is to deliver a

lot of fog quickly and then have it die down (within a minute)," McIntyre said. Part of the work was figuring out how to heat water quickly at competitions to create fog. I won't share all of the Noble Roadies' secrets, including how they created a vertical explosion of smoke thanks to Elwood Fire Equipment Co., but I will share that Noble Roadie parent volunteer Jay Bzdyl and son Brock

took charge of heating water and keeping water at the correct temperature in barrels at every show choir

help of student Pit Crew members. "Being able to pull all of those things together was pretty remarkable," McIntyre said. "It's really just amazing to see how the team, everybody had an idea here, an idea there, drew on various team members' experience. Neubauer said, "While the car and its challenges will be missed, the music, the group's drive and investment in a vision and the growth of students as performers will be what I will miss as the class of 2024 moves on to new challenges. In Noblesville, the kindergartens of both First Ward and Second Ward were in basements. (Second Ward's kindergarten was in the basement of the Masonic Temple.) Third Ward also had a kindergarten, but I couldn't find a description of its location in the building. (I bet it was in the basement, too, though!) It wasn't just Noblesville. My cousin, the Dancing Librarian, reported that her kindergarten was in the basement of Sheridan's Carnegie library. Finally, Nicole Kobrowski pointed out a street in Strawtown called "St. No 15." She wondered if the street's odd name might refer to a railroad stop. Neither the railroad, nor the interurban went through Strawtown, however, so that seems unlikely. I haven't been able to come up with any other guesses as to how the street came by its name. Does anyone know the story behind
