pansies!) and the Herb Society of Central Indiana is holding their annual Spring Symposium.

The theme of this year's Symposium is "Yarrow: It's the Bee's Knees," in honor of the 2024 Herb of the Year.

I'm afraid I've always tended to think of yarrow more as a pretty plant in my yard than as an herb, but it does meet the International Herb Association's criteria for Herb of the Year - it has decorative, medicinal and culinary qualities.

Yarrow is definitely decorative. In addition to adding interesting texture and colors to landscapes, it dries well and is attractive in dried arrangements.

Known since prehistoric times, yarrow has been used medicinally by many cultures to treat a long list of physical complaints - it stimulates digestion, helps to reduce bleeding, and can be used to ward off colds, just to name a few of its therapeutic applications.

The plant's Latin name, "Achillea millefolium," actually comes from the Greek hero Achilles, who is said to have used it to heal his wounded soldiers during the Trojan War.

The ancient Druids foretold the weather by it, while the Chinese traditionally count the plant's long, straight stalks for I Ching divination.

If yarrow has an Achilles heel (sorry, couldn't resist,) it lies in the culinary category. Normally, I like to include a recipe using the Herb of the Year in these columns, but I'm going to skip that this year. I'm not that adventurous.

Oh, you can find recipes for yarrow - quite a variety appears online, in fact but they all caution that it's a very bitter herb and should be used sparingly in whatever dish you're preparing.



Noblesville Hosts Joint Fire Academy Graduation For 23 Firefighters





The Noblesville Fire Department recently hosted a joint fire academy graduation at the Embassy Suites Hotel and Conference Center. Recruit Class 08-23 included a total of 23 firefighters from the Noblesville, Lebanon and Zionsville fire departments. The graduating class included:

Noblesville Fire Chief Matt Mitchell gave the following charge to the graduates: "For over 15 decades people of Noblesville have been able to call us in their time of need. Honor that tradition. You are automatically given trust based on the badges you have earned and now wear. But that doesn't end today. You have to earn that trust everyday children will look at you like you are a superhero and parents will treat you like trusted family because of your integrity. When NFD knocks, people open the doors to their homes. They do this with total confidence because they know the professionals are here to help."

The ceremony included the badge pinning by the graduates' family members and loved

ones; prayers by NFD Pastor Fritz Good; remarks from Recruit Class 08-23 Representative Aaron Adams; and the oath of office given by Noblesville Public Safety Director Chad Knecht.

Hamilton County Firefighters Local 4416 President Jim Butts served as emcee of the ceremony to his fellow Noblesville firefighters. Division Chiefs Joe Scheumann and James Macky oversaw the recruitment class.

"Public safety is a top priority for the City of Noblesville and one of the four pillars of my administration. Continuing to grow our outstanding fire and police departments is imperative to ensure our residents and businesses are as safe as possible," said Noblesville Mayor Chris Jensen. "We are excited to have these new firefighters as part of our Noblesville community and wish them long and successful careers."

The recruit academy lasts approximately 22 weeks. The first 15 weeks are devoted to gaining certification at Firefighter level I, II, hazardous materials and technical rescue swift water, extrication, emergency vehicle operations, and prevention. The remaining seven weeks involved training as an emergency medical technician at the basic level.

Noblesville's recruits have now completed all training and will be moving to their assigned shifts effective Monday, March 18. The new firefighters will complete a probationary year before being promoted to pipemen.



Carmel Updates Spring Construction Projects

The City of Carmel provided an update on upcoming and ongoing construction projects taking place this spring. Projects include the Monon Boulevard expansion, continued work on N. College Avenue and several smaller projects throughout the community.

As always, we remind you that all construction timelines are affected by weather and utilities; the dates and duration of projects are our best estimates. We appreciate your patience while we work to make improvements for our community.

E. 96TH STREET

Beginning on or after Monday, March 18, E. 96th Street between Haverstick Road and Westfield Boulevard will be closed to through traffic for three weeks for road reconstruction. Westfield Boulevard, E. 106th Street and Keystone Parkway will be utilized as the detour route for this closure. The intersections of E. 96th Street with Maple Drive and Lincoln Boulevard will be restricted, and local property access will be provided from the north via E. 99th Street as well as Maple Drive.

COLLEGE AVENUE RECONSTRUCTION Beginning on, or after

April 1, N. College Avenue reconstruction will begin with a closure of the southbound lane

between the I-465 overpass and E. 104th Street to relocate the water main and construction of new storm water collection. This work will continue through July 2024. Meanwhile, private utilities may be working in the easements and the right-of-way, relocating utility lines along both east and west sides of N. College Avenue.

Reconstruction of the northbound lane will begin later this summer with continued work on infrastructure on the east side of the road. During this phase, access will only be open for southbound traffic and limited access to Pennsylvania Parkway will only be maintained for southbound traffic on N. College Avenue during this phase of work. The reconstruction of the northbound lane is expected to be substantially complete and open to traffic Winter 2024.

March 2025 begins with the reconstruction of the west side of N. College Avenue with a closure of the southbound lane of N. College Avenue between E. 106th Street and I-465. Expect deconstruction of the road, infrastructure work, as well as the west side of the roundabout at Pennsylvania Parkway, and reconstruction of the southbound lane. The northbound lane will remain open on the new road during this phase of construction and there will be no access to Pennsylvania Parkway from N. College Avenue during this phase of work. Access to Pennsylvania Parkway will be maintained from the

west during all phases of construction of N. College Avenue.

In late summer 2025, the southbound lane reconstruction will begin. After the opening of both northbound and southbound N. College Avenue lanes, N. College Avenue will be closed (open to local traffic only for area businesses) at Parkwood Drive for the construction of a roundabout intersection for approximately 60 days. Under the full closure of this intersection, the roundabout is expected to be completed in late 2025.

In early 2026, the reconstruction of the E. 96th Street and N. College Avenue intersection into a roundabout will begin. This will involve the closure of the intersection for approximately 60 days.

Alternative and detour routes for N. College Avenue include U.S. 31, Keystone Parkway, E. 106th Street and E. 96th Street.

MONON BOULEVARD

EXPANSION - PHASE 3 Beginning on or after March 18, tree clearing will begin along the Monon Greenway between City Center Drive and W. Walnut Street in preparation for Phase 3 of the Monon Boulevard expansion project in Midtown. Approximately 50 trees will be removed in this section of greenway with the work taking place along the west side of the trail. A temporary multi-use path will be established west of the existing trail once

clearing is complete to allow pedestrians to maintain connectivity throughout the construction. The new plan will incorporate more than 6,000 new plantings (shrubs, perennials, grasses) and more than 100 new trees. Work on Phase 3 will be substantially complete in 2025.

MIDTOWN CONSTRUCTION

Work will resume in the City's central core on parallel stretches adjacent to Midtown this April. The project at 3rd Avenue SW will continue with storm water collection and water main work in the vicinity of Industrial Drive as well as the rebuilding of 3rd Avenue SW to a new boulevard stretching from 2nd Street SW to Autumn Drive. Meanwhile, Veterans Way will continue to move north from City Center to W. Walnut Street. Work expected to be substantially complete in Fall 2024.

PATH PROJECTS

Several path projects are in the works around the City of Carmel. Most of these are filling gaps in the existing network, some are crosswalks with rapid flashing beacons. In addition to these smaller projects, the City has much larger pedestrian connectivity projects in phases of design.

WATER MAIN WORK

The W. Main St. water main work is expected to be complete in late April when motorists can expect W. Main Street, east of Old Meridian, to reopen. Alternate routes include W. Carmel Drive, Smoky Row, W. 146th Street and E. 116th Street.




