## NHS Class of '65 Gathers to **Honor Hometown Heroes**

March 18 - 24, 2025

When Stephen Craig told me about his Noblesville High School Class of 1965 gathering on the Logan Street Bridge to honor two

classmates killed in Vietnam, I thought it would be a great time to share more about the Noblesville Hometown Heroes banners as well as similar banner projects throughout Hamilton County.

About 50 members of the class and spouses, including Stephen Craig and his wife, Moffett Craig, who, too, is a classmate, posed for a photo on the bridge on Sept. 15 honoring their late classmates, Mike Lawhon and Jim Grant. The class met on the downtown Noblesville bridge for the photo because Lawhon and Grant are both honored with banners located on the north side of the bridge, in the center.

Classmate the Rev. Jeff Wilhelm, an ordained Episopal minister, gave a prayer. And after the photo, they adjourned to nearby Syd's Bar & Grill to visit. (In 2025, the class will celebrate its 60th class reunion.)

This was a special event because of the short duration these banners are expected to be hanging on Noblesville light posts, according to the classmates.

I haven't really heard too much about these patriotic Noblesville Hometown Heroes banners, only saw a social media post back in the spring about how Logan Street Signs & Banners' Deb Wade had spent three months creating the banners which were installed around Memorial Day.

So I asked her more about the banners, and she was eager to talk about the project.

She estimates that she created almost three dozen of the Noblesville Hometown Heroes banners. "We started with 24 and were able to add a few here and there when a pole became available," she said. "Whenever a pole is free, the street department contacts me to fill it up."

Noblesville's Logan Street

Signs & Banners, owned by her oldest brother, Jim Wafford, is paying for the banners.

Who came up with the banner project? Wade or Wafford?

"The original idea was mine, but he helped me find a way to expand it so we can keep it going," Wade said.

"The city is waiving the fee to use the posts," Wade said, "thanks to Aaron Head," the city's community engagement manager. "A couple (of veterans) that are up on the posts have donated toward our project."

Wade said, "We are not charging for these. It is an honor for us to do this."

the director of the Hamilton County Historical Society Museum, sent some photos of the Sheriff's Residence and Jail with - and without - the garage and tower.

Garage?

I'd completely forgotten there used to be a garage. (I'd also forgotten about the small parking area that once sat on the northwest corner of the courthouse square behind the garage and the jail.)

The garage was located on the east side of the jail. According to Sandy, it was added in the early 1950s and torn down in 1983 as part of a historic preservation project.

Sandy also sent photos of the tower that was added to the Sheriff's Residence in 1992. The new tower restored the building to the way it looked in 1876. (The original tower had been blown down during a storm in 1948.)

After the first John Dillinger column ran, I received an email from Bob McColgin, the son of Helen (Carey) McColgin, whose parents owned the Westfield Cafeteria where Dillinger was said to have eaten.

Bob included a photo of several members of the Carey family standing in front of the cafeteria and

noted that his mother's job

### **MedTech Company Coming to Westfield Bringing Dozens of High-Paying Jobs**

Portal Diabetes Inc., a medical technology company, announced plans to relocate their headquarters to Westfield from Southern California. As part of its relocation, the company is also announcing a name change from PhysioLogic Devices, Inc. and their technology called ThinPump to Portal Diabetes Inc. and the Portal Pump.

Founded in 2013, Portal is developing a fully automatic, implantable insulin pump to control glucose levels. Its Portal Pump technology will be the first fully automated insulin delivery system that can store up to 12 weeks of insulin through an artificial pancreas.

"We are thrilled that

Portal has chosen to relocate their headquarters to Westfield," Westfield Mayor Scott Willis said. "They are on the cutting edge of transforming the lives of diabetics across the globe and will make a great corporate partner in our community. Their capital investment and high paying jobs align perfectly with my longterm vision of creating a high technology manufacturing center in Westfield with an emphasis in the biotechnology and

The company will employ up to 35 fulltime employees with an average annual salary of \$135,265. The company's employees will be relocating to Westfield by the end of October 2024.

healthcare space."

Based on the company's plans, the Indiana Economic Development Corporation (IEDC) committed an investment in Portal of up to \$925,000 in the form of incentivebased tax credits.

"Having completed a national search of locations for Portal, we chose Westfield, Indiana as a thriving community with a favorable business environment and access to strong life science talent," shared CEO, Stacy Chambliss. "Adding its rich history in insulin manufacturing, we are glad to make Indiana our new home."

"Indiana's life sciences ecosystem continues to grow and prove that we offer the perfect

environment for exploration, experimentation and innovation," said Ann Lathrop, Chief Strategy officer at the Indiana Economic Development Corporation. "Indiana has proven it's one of the nation's top locations for life science businesses of every kind. I'm thrilled to see Portal relocate to Indiana and I look forward to the impact they make on the state and its life sciences sector." The company will lease 18,000 square feet of existing space located on Southpark Drive with a total capital investment of \$4.07 million. #### Noblesville Man Found in Retention Pond

A 35-year-old Noblesville man was found in a retention pond last Friday.

Zachery R. Polson was pronounced dead at Riverview Health after police officers and firefighters pulled him from the pond in the area of Windwood Parkway and Hague

According to Noblesville Police, both police and fire got a 911 call at 4:01 p.m. Friday of a man standing on top of the retention pond's water fountain. The caller stated that the man then jumped in the water and never resurfaced.

Officers and firefighters arrived on the scene a short time later and began searching. A diver from the fire department found Polson submerged near the fountain. Emergency personnel began resuscitation efforts and he was rushed to Riverview in critical condition. He was pronounced dead a short time later.

The cause of death will be determined by the **Hamilton County** Coroner's Office.

Her inspiration? Noblesville's Chuck Layton, a U.S. Army veteran who served in Korea as an Army Ranger and at the age of 22 found himself a Prisoner of War / Missing in Action with 36 other men. After 17 weeks, Sgt. Charles E. Layton, whose Hometown Heroes banner is also on the Logan Street Bridge, led a daring escape that ended his captivity, instilling a desire to do good for people on a daily basis, according to his November 2020 obituary. The experience haunted him for most of his adult life until he put his memories into a book called "Escaped

Wade said, "I started with Chuck Layton as my inspiration as our best friend, and the fact that he was Jim's right hand man starting Logan Street Signs. He is on the Bridge of Flowers." She said, "As for choosing since I was limited on the first group, after talking with Jim, we decided to put two different people on each banner to get more honored. There are so many that deserve to be up there."

with Honor."

It's interesting to walk around downtown Noblesville and across Logan Street Bridge to look at all of the Noblesville Hometown Heroes banners.

"We chose several that have been a major part of our sign shop history and special customers over the years," she said. Wade contacted **Hamilton County** Sheriff's Department, Noblesville Police Department, Noblesville Fire Department and Noblesville American Legion for service members, living and deceased "and they happily helped us out."

Besides Layton, and Michael H. Lawhon and James M. "Jim" Grant, who both served in the U.S. Army in Vietnam, there are many other veterans honored with a Noblesville Hometown Heroes banner on the bridge. One of those veterans is Noblesville native Robert L. Roudebush, who served in the U.S. Army during World War II and served five terms as a U.S. Representative from Indiana 1961-71. The Richard L. Roudebush Veterans Administration Medical Center in Indianapolis was named in his honor.

Hometown Heroes banners on the bridge include: Deputy Joshua Lollar, who served in the U.S. Army in Iraq and Afghanistan; Deputy Adam Leckrone, who served in the U.S. Marines; and First Lt. Alan J. Bardach, who

served in the U.S. Army in Vietnam. There is also U.S. Army veteran Israel Menchaca Jr., who served in Vietnam.

Other poles besides on the bridge feature Noblesville Hometown Heroes, U.S. Army Chief Warrant Officer 2 James Jessee, who served in Vietnam; U.S. Army Specialist Eric Behrends, who served in Operation Iraqi Freedom; U.S. Army Specialist William Prater, who served in Vietnam; and U.S. Army Specialist Doug Robinson (Moffett Craig's brother who graduated in the NHS class of 1966), who served in Vietnam; U.S. Army Private First Class Joe Whitmoyer, who served in Vietnam; U.S. Army Specialist Greg France, who served in Vietnam; U.S. Coast Guard's Jack Clark; U.S. Marine Corp.'s Lt. Col. Douglas Herrington; U.S. Air Force's Eric Berger, a firefighter and staff sergeant; Jeremy Hopkins, who served in the U.S. Army. There are many more banners. Noblesville isn't the only community honoring their veterans on banners.

In Cicero, Hometown Hero banners are funded by donations and honor those who have served in the U.S. Armed Forces. In 2023, members of the Sheridan Historical Society's Veterans' **Banner Committee** collected photos and information about more than 130 local veterans to create rotating banners for placement on 20

Street lamp poles. The

project began as an idea from Vance Wallace, based on banners in Cicero and Tipton downtown areas.

Fishers is also doing the same with its special light pole banner program, offering the community the opportunity to request banners dedicated to honoring veterans and active-duty service members Banners are displayed around the Nickel Plate District with request forms available at fishersin.gov com. There's no cost to participate. The City covers all expenses related to the creation and display of these banners. This is the city's way of saying 'thank you' to those who have given so much.

Besides banners, one nearby community is honoring Hometown Heroes this week in another way. The **Builders Association of** Greater Indianapolis (BAGI) Home-A-Rama's Hometown Heroes Day, will honor heroes and thank them for their service to their communities and country during the 2024 Hometown Heroes Day on Thursday, and will include \$5 off the \$25 admission tickets for military veterans, active military members, first responders, health care workers and teachers to the 2024 Home-A-Rama in the private, lakeside community, Promontory of Zionsville, near Westfield. The day will feature a separate check-in area for heroes, and signs honoring their service.

Hometown heroes are honored in many ways throughout Hamilton County, including Westfield's Hometown Hero Program that covers lawn care services and snow removal for public safety personnel and active service military members who qualify.

In Carmel, a Mayor's Advisory Commission was established by Carmel Mayor Sue Finkam to address the needs of veterans and military families in Carmel.

Also, active military and veterans are honored at free Memorial Day and Veterans Day programs throughout Hamilton County in partnership with local veterans organizations. ### **Final 96th Street Sculpture Complete**

The fourth and final 96th Street corridor "Classic Cars of Indiana"-themed sculpture by local artist Arlon Bayliss, went in at the roundabout at 96th Street and Gray Road.

"We are excited to share final piece of public art in the Classic Cars sculpture series along the 96th Street corridor," said Chief Infrastructure Officer Jeremy Kashman. "It's an impressive piece that's been designed and fabricated locally and adds to the uniqueness of the city."

"Stutz" joins three other sculptures by Bayliss, installed at the roundabouts on 96th Street at Priority Way, Delegates Row and Hazel Dell Parkway. Commission in late 2021, the four sculptures feature artistic interpretations of the classic cars



Inspired by the Stutz 'Ra' Art Deco hood ornament, "Stutz", when finally placed on its five-foot-high Indiana limestone base, will stand at 18feet-high. Bayliss' design incorporates dozens of sheets of steel, fabricated by bomar Industries, in vertical slices with space between each one creating an ethereal lightpermeable abstract form. At night, the sculpture will be illuminated from within using the artist's signature-colored dichroic-filtered light sources.

was to roll pie dough each morning before heading to school. (I especially liked the sign in the photo: "32 MILES TO NEXT TOWN, EAT HERE.")

Bob said his memory of his mother's account of "Dillinger's" visit differs a little from what I

According to him, she didn't actually see the man believed to be Dillinger, but "she remembered the story that when John and his men walked into the cafeteria, the only commotion was that the barber, Doc Ross, swallowed an ice cube and choked."

(In point of fact, the "men" were one man and two women.)

About the body in a hearse parked outside the cafeteria - Mrs. McColgin and her sisters DID get a look at the casket inside the hearse while the driver was eating, but Bob said his mother was never sure who was in the casket.

We know now that body was most likely Dillinger gang member Harry Pierpont.

(By the way, Pierpont was no stranger to Hamilton County. In 1924 he was part of a gang that attempted to rob the Citizens State Bank in downtown Noblesville. A few months later he was caught and sent to the Indiana Reformatory at Pendleton, which is where he met Dillinger.)

You can't fault Mrs. McColgin and her father, Lowell Carey, for believing Dillinger had eaten at their cafeteria. Remember, people in

the 1930s had no television, no internet and no smartphones. All they had to go on to identify the notorious bank robber were newspaper photos and maybe an occasional newsreel at a movie theater. Most people never saw how he moved, or heard his

While I can't say with 100 percent certainty Dillinger NEVER ate at the Westfield Cafeteria, it's extremely unlikely. From 1924 to 1933 he was serving time for the attempted robbery of a Mooresville grocery. Following his release in May, 1933, he was only known to have been in this area once or twice.

It's well established that he visited his family in Mooresville April 5-8, 1934. (He was staying there the weekend he made the trip to Ohio that ended with the Hamilton County car crash.)

Additionally, the Indianapolis Times and another source indicate that he made a "fleeting" visit to Indianapolis to drop money off for his family on May 10, 1934. I haven't been able to confirm that to my satisfaction, though.


