a member of the Kentucky Music Hall of Fame and the prestigious Musicians Hall of Fame, grew up in Noblesville. Recently, he shared with the Noblesville Times some memories of what the holidays were like when he was living a few blocks from downtown in the 1960s. Like so many of us, he found growing up in Noblesville back then a very special time and place.

A black and white autographed 8x10 of Michael Landon. Little Joe! That hung on my Grandma Glover's living room wall for years!

One of us grand kids got it for her at the annual Noblesville Thanksgiving parade. Yes, Michael Landon was there IN PERSON in the parade! So was Barbara Eden and Fess Parker on different years in the '60s. What a time to be a kid in Noblesville! (I met Barbara Eden at the White House right after 9-11 happened. I was performing for President Bush at the Christmas Tree lighting ceremony on the Ellipse. I HAD to bring up Noblesville

to her!)

In the mid '60s, we lived down on south 8th street. Right next to "The Biggest Little Store in Town;" a Mom and Pop quickie market in a house, mainly featuring penny candy, soft drinks, milk and cigarettes. My siblings and I kept that place in business!

In the summertime, we could not wait for the daily train to roll right down the middle of 8th. As we lined the sidewalks waving, the caboose guy would throw Tootsie Pops out to us! Of

courthouse next to it are so close in age, I tend to think of the two together, so it seemed only right to do a quiz on the courthouse, too.

(When I say "courthouse" or "old courthouse" I'm referring to the one next to the old jail, not the newer Hamilton County Judicial Center on the west side of the courthouse square.)

- 1. What year was the old courthouse built?
- 2. How many courthouses has Hamilton County had?
- 3. Before the old courthouse was built, a petition was being circulated to move the county seat to another town. Which town was it?
- 4. A room on the second floor of the old courthouse is famous for something. What is it?
- 5. True or False: The old courthouse was built because the previous courthouse was in such poor condition that county officials had to lease rooms in another building.
- 6. In 1971 the old courthouse was plagued by a serious health issue. What was it?
- 7. True or False: The old courthouse is on the National Register of Historic Places.

And now the answers:

1.1879.

2. Five. The first courthouse was a temporary log structure built in 1826 at what is today Tenth and Clinton Streets in Noblesville. It was followed in 1831 by a frame courthouse — the first courthouse located on the square.

The third courthouse, a twostory brick structure, served the county from 1837 to 1875. About four years later, that building was replaced by the fourth courthouse, the 1879 courthouse which still sits on the courthouse square.

Thanksgiving. waiting patiently). I always wanted to see up in that courthouse tower. I finally did, several years ago! But that's another story.





The Addams Family is a fictional family originally created by Charles Addams, an American cartoonist from New Jersey. The TV show, The Addams Family, broadcast on ABC for two seasons, rose to popularity and then the musical was performed on Broadway in 2010 and in international tours through 2021.

For the NHS musical, costume designer Kerin Meyer had the biggest costume team she's ever led with this show, and they have created almost every costume.

"Each of the Addams ancestor ghosts are different characters from various time periods," Morris said. "We have everything from a caveman to an 1800s merchant to an '80s rock star in this show."

Morris designed the set, and NHS English teacher Greg Richards and his theater tech students "brought it to life" with set construction and lights.

NHS performing arts teacher Jay Jasper also has "a very eerie and fun playlist of sound effects to manage that are quite different from years past," she said.

"The multi-talented (conductor) Mr. David Hartman (leading an orchestra of 25 students plus Mrs. Carrie Cain on keyboards) gets to catch a dead bird in the orchestra pit while also queuing the musicians."

"The core theme of this musical is 'family' and remaining true to your values as a family while still welcoming the value of others," Morris said.

What did students learn preparing for this show?

"The style and attitude of the Addams family themselves is

specific ways they move or don't move, both physically and facially. We have a bit where Morticia tries to mirror a big smile, and she physically struggles to get her lips and face to create it and gives up."

What's the most fun about directing high school students? And the most challenging?

"The educational side of directing high school students offers both joy and headaches," Morris said. "I like to take the time as a director and share why I'm making certain decisions and bring the students into my process, as well, because every show inspires not only future actors but also future directors, stage managers, light booth managers, costume designers and more."

She said, "In the professional world, a director is not helping to also paint the tree, create the intricate prop and guide the graphic designer on marketing, but high school directors do it all and then some."

The show is assistant directed and produced by NHS English teacher and ComedySportz adviser Connor Buhl.

While Morris isn't a teacher at NHS, she isn't new to directing, producing and choreographing. She codirected "Spamalot" and "Avenue Q" with Deborah T. Wittstein, codirected "High School Musical" with choir director John Neubauer and directed "Chicago." Morris earned an architectural degree from Ball State University and combined that with her theatrical background to become one of HOK Orlando's senior show and ride consultants for Universal Studios, Disney and numerous international attractions. She's choreographed, directed and performed in both

Morris knows what it's

like to be behind the scenes as well as on stage. In 2014, she was presented a highly coveted Encore Award from the Encore Association (which celebrates excellence in community theater) for Best Lead Actress in a Drama for the role of Joy in the play,

"Shadowlands," during Epilogue Players' 2013-14 season.

For "The Addams Family," Morris enjoys working closely with choreographer, NHS assistant choir director Julianne Fowler, who has worked as a ballroom choreographer and choreographed the spectacular ballroom dance scene in the 2023 fall musical, "Cinderella."

Morris also worked with Fowler in 2022. She said, "I was able to work with Ms. Julianne Fowler doing 'Chicago,' which took us both owning different numbers to be efficient in getting everything taught and drilled well. This show is also dance heavy, but I was fully confident in the talents Ms. Fowler brings to run with the bulk of the numbers, and I just took three (Fowler as main choreographer, Morris and Abby McGrew as assistant choreographers) to help be efficient in rehearsals. Just wait to see her Tango number, wow!"



By the 1970s, county officials began to realize that the 1879 courthouse would soon be unable to keep up with the area's explosive population growth. That led to the construction of the Hamilton County Judicial Center in 1992. The Judicial Center now houses most of the county offices and the county court system.

3. Westfield. In the end, it was decided that the advantages of keeping the county seat in Noblesville outweighed any disadvantages. Aside from the expense of moving, Westfield had no railroad or system of gravel roads at that time and it was inconveniently located on the far west side of the county.

Moreover, moving the courthouse would have violated the terms of William Conner and Josiah F. Polk's original deed, allowing Conner's descendants to reclaim the land. (Polk had no descendants.)

4. The 1925 murder trial of Indiana Ku Klux Klan Grand Dragon D. C. Stephenson was held in the second floor courtroom of the old courthouse. (Stephenson's conviction allows Hamilton County to justly the claim that the Klan of the 1920s effectively died here!)

5. True. In 1875, during a high-profile murder trial, a wall in the 1837 courthouse cracked and threatened to collapse. Although the building clearly wasn't safe, the public voted against replacing it in a special election held the following month. (Too much money!)

In 1877, however, the county commissioners overruled the voters and went anead with plans to erect a new courthouse. The county leased office space in a building on Conner Street, about a block east of the

courthouse square, until the new (1879) courthouse was ready.

6. Histoplasmosis. The airborne disease, caused by a fungus found in droppings left by pigeons roosting on the courthouse ledges and sills, sickened some county workers. The most prominent of these was Hamilton County Circuit Court Judge Edward F. New, Jr., who reported suffering permanent physical damage from the disease.

7. True. The entire **Hamilton County** Courthouse Square was added to the list in 1978.

In its assessment, S&P Global Ratings noted:






