More cone zone news. From now through mid-January, 236th Street will remain closed from U.S. 31 to Deming Road. Bridge work just east of Anthony Road is anticipated to be complete mid-January 2025. The road will open then, but the remaining construction work will resume as weather allows, tentatively April 1, 2025.At that time, 236th will be closed through the completion of the project. #### Dear Rusty:

My wife will reach her full Social Security benefit at 66.5 years of age which is just under 2 years away for her now. If she were to begin to get her monthly check now (i.e. early), would that prevent her from being eligible for the spousal benefit to receive half of what I am currently drawing? Signed: Curious Husband

#### **Dear Curious:**

If your wife claims her own SS retirement benefit now (e.g., at 64.5 years), and you are already collecting your own SS benefit, then she will be automatically deemed to be filing for her spousal benefit immediately when she claims her own benefit (she does not have the option to defer claiming her spousal benefit until later). This is a change made by the Bipartisan Budget Act of 2015, which requires all

those first claiming SS to file for ALL benefits they are eligible for when they claim. What that would mean is that your wife's benefit now, including her spousal boost from you, would be actuarially reduced by the number of months early she claimed. Her own SS retirement benefit would be permanently reduced by about 15%, and her "spousal boost" (the additional amount she would get as your spouse) would be reduced by about 19%, yielding a combined benefit which is roughly 42% of your full retirement age (FRA) SS

The only way your wife can get half (50%) of your FRA benefit entitlement is by waiting until her own full retirement age (66 years and 10 months) to claim. Note too that

### **Medigap Plans Available With Medicare**

A new bill, SEA 215 was introduced and passed in Indiana in Spring of 2024 that impacts Medicare.

As of Jan. 1, there will be guaranteed issue into medigap plans for people under 65. What does this mean? This means that after Dec. 31, 2024, any Medicare Supplement Plan (Medigap) that is available to those with Medicare will also have to provide that same plan, or an equivalent, available for those with Medicare due to disability or ESRD.

WHAT: Beginning on or after Jan. 13, 2025, Pleasant Street will be closed to through traffic between 13th Street and 16th Street. The closure will last until Phase 2 is complete in early 2026.

### Local Police Chase Ends in Henry County

Police ended the year in pursuit of a suspect who allegedly pointed an AK-47-style firearm at a man near Fortville.

Around 11:15 a.m. on New Year's Eve, the Hamilton County Sheriff's Office responded to the 16000 block of Province Court in Hamilton County near Fortville following a weapons complaint. your wife's spousal benefit will be based on your FRA entitlement, so if you claimed earlier or later than your own full retirement age, her spousal benefit will still be based on your FRA entitlement.

Also, your wife should be aware that anyone who claims early is subject to Social Security's "earnings test," which limits how much can be earned while collecting early benefits. Thus, if your wife is working, she will be restricted on how much she can earn before Social Security takes away some of her benefits. FYI, the earnings limit changes annually, but for 2025 it is \$23,420 and, if that is exceeded, SS will take away \$1 in benefits for every \$2 over the limit. And, FYI, the earnings limit goes up a lot during the year FRA is attained, and the

earnings test no longer applies once full retirement age is

reached.

Anyone on Medicare under the age of 65 prior to Jan. 1, 2025 will have a six month window to sign up for a Medigap Plan, guaranteed. This would be Jan. 1 - June 30, 2025.

Anyone enrolling into Medicare under the age of 65 AFTER Jan. 1, 2025 will be granted their own six month guaranteed enrollment window starting from the first day of the month their Medicare begins.

Beginning Jan. 1, 2025, the following rules will apply to health insurance providers:

Issuers may not deny

standardized letter Medicare supplement policy that exceeds 200% of premium charged to those age 65 for the same Medicare supplement policy.

### **\$3.6M in Federal Grants Coming to Indiana**

Lt. Gov. Suzanne Crouch and the Indiana Office of Community and Rural Affairs announced 20 Indiana communities will receive more than \$3.6 million in Owner-Occupied Rehabilitation Grants and Planning Grants through the Community Development Block Grant program.

Owner-Occupied Rehabilitation grants will be used to empower these communities to directly fund homeowners of low-to-moderate income to make needed repairs on their homes. While communities awarded Planning Grants will use the funding to develop plans for long-term planning efforts.

"Each of these grant programs will contribute to improving the lives of Hoosiers across our state," said Lt. Gov. Crouch, Indiana's Secretary of Agriculture and Rural Development. "I am grateful to the 20 awardees who are committed to investing more into their residents and community development."

Communities awarded an Owner-Occupied Rehabilitation Grant will establish a program to help fund low- and moderate-income homeowners make repairs on their homes. Eligible repairs include roof repair or replacement, ADA accessibility, heating and cooling replacement, lighting and electrical upgrades, and water heater replacement.

The Planning Grant program encourages communities to plan for sustainable community development with the aid of subject matter experts and community input. The applications being funded this quarter address comprehensive planning efforts, water utilities, downtown revitalization and broadband readiness.

Dec. 21. We know we'll see freezing rain, snow and plummeting temperatures. Families should prepare now to stay safe, warm and protect their homes with guidance from FEMA's #WinterReady campaign.

Winter officially began

at 4:21 a.m. Saturday,

"It's never too early to think about what you would do if stranded on the side of the road or stuck at home without power during a snowstorm," said FEMA Region 5 Regional Administrator Tom Sivak. "Taking steps today-like making a plan and assembling emergency kits with essential items like food, water, medications and pet supplies—can make all the difference when winter weather strikes."

Here are a few things to keep in mind as winter rolls in:

1. Wear a coat and dress in layers if you work outside or participate in outdoor activities. This will help regulate your body heat and keep you warm. Be sure to keep your skin covered by wearing a hat, scarf and mittens. Hats help keep the body warmer and mittens are more effective than gloves. hypothermia. If the cold causes pain in your body, numb or tingly skin, slurred speech, or shivering, go indoors immediately. Remove wet clothing, wrap up in a warm blanket and if you can, sip on warm fluids to stabilize your body temperature.

3. Gather supplies for your emergency kits. It's important to keep an emergency kit in your home. This kit should include nonperishable food, a can opener, water, blankets, prescription medications, a weather radio, a flashlight with extra batteries, a portable cell phone charger, kid-friendly activities, and pet food. It's also a good idea to make sure everyone in the family has the phone numbers for emergency contacts. It's also important to keep an emergency kit in your vehicle in case you are stranded in the cold. This kit should include an ice scraper, jumper cables, a small shovel, blankets, nonperishable food, water and a portable cell phone charger.

4. Heat your home safely. If you use a space heater, remember to keep it at least three feet away from items other items that can burn. The heaters should be plugged directly into the wall and the cords should not be frayed or damaged. Never use a gas stovetop or oven to heat your home. This can release carbon monoxide into the air and cause serious health risks, even death.

5. Check on elderly friends and neighbors. Older adults often have a harder time regulating body temperature, so they are at a higher risk of experiencing coldweather related injuries. Be sure to check in on them to see if their heat is working properly and they have what they need to make it through the cold.


