#### Dear Rusty:

If a financially well-off individual had multiple ex-spouses, could it happen that the multiple ex-spouses could each be collecting Social Security based on their own financial situation as compared to their rich exspouses? Thus, multiple payouts by SS? Just curious, because there are probably many people in this situation as a result of the everincreasing number of people involved in multiple marriages that each lasted more than ten years. Signed: Curious Ex-Spouse

Dear Curious Ex-Spouse: A former spouse can only spouses of a marriage to the same person to qualify for benefits from those unions, if each marriage lasted at least 10 years. But each exspouse can only qualify for one benefit payment either their own earned SS benefit, or their benefit as an ex-spouse. In other words, someone with two (or more) exspouses might have their ex's collecting full benefits on their record, provided that each marriage lasted at least 10 years. But an exspouse can only get one benefit -their own SS retirement amount or an ex-spouse amount whichever is higher).

It's possible, also, that an ex-spouse can collect benefits from a former spouse at the same time as a current spouse is also collecting spouse

Hamilton Heights Middle School won the JR. FFA State Forestry Contest, a historymaking win that was three years in the making. The contest consists of a written test over the general knowledge of forestry, 55 leaf, 25 seed, and 30 insect and disease identification.

"Our journey started in the fall of 2022 when our team members were entering the sixth grade," Coach Adam Sheller said. "I had personally always enjoyed forestry, judging when I was in middle school, and it just made sense that I would pass that enjoyment to my own kids. As luck would have it, Nikki Higgins, Lilly and Maggie's mother, and I were on the same Forestry Team in middle school at Hamilton Heights back in the mid-1990s. We ended up finishing second in the state in 1995!"

As sixth graders, the girls (now in eighth grade) showed promise and improvement. Last year, Heights placed second regionally and qualified for state, ultimately placing seventh. This year the team won all three invitationals it entered and placed first in the area, taking the top four spots individually. At state, Heights brought home the state championship. In addition, Annie Sheller placed fourth, Lilly Higgins placed sixth and Maddie Higgins placed seventh overall.

The 4-H and FFA **Forestry Career Development Event is** designed to stimulate interest in forestry, to promote forestry instruction in the agricultural education curriculum, and to provide recognition for those who have demonstrated skill and competency as a result of forestry instruction. The CDE consisted of individual practicums that included a general knowledge exam, seed, insect, and disease identification.

**Fishers Mayor Scott** Fadness

Fishers Mayor Scott Fadness delivered his annual State of the City address earlier this week, announcing major new corporate and lifestyle investments and marking a decade of service as the city's first mayor.

Fadness highlighted Fishers' rapid growth over the past decade and the community's transformation from a small suburb to a major regional destination and fourth largest city in the state. In addition to the accelerated population growth, Fadness cited the city's expanding infrastructure and lifestyle amenities over the past ten years, referencing the 61% increase in park acreage; \$135 million investment in parks and trails; roadway improvements such as the 106th Street interchange and State Road 37 project; and new community amenities like the Fishers Event Center, Nickel Plate Trail, and upcoming Fishers Community Center.

Fadness also announced a lineup of major new investments investment from BW Development will bring new restaurant and retail space to The Crossing at Fishers District, home of the new Fishers Event Center. The 35,000square-foot leasable space will provide new dining and retail options to this burgeoning entertainment district.

In the coming weeks, a partnership with another development company will be presented to Fishers City Council to bring a new, mixed-use development to The Crossing. This proposed development will include multifamily housing, retail space, and a potential hotel pad.

benefits on the same record. And there is no detriment to either's amount because multiple spouses or exspouses are collecting on a one person's SS record (Social Security is, after all, a means for spouses, or ex-spouses, to avoid poverty). However, an exspouse's own SS retirement benefit (from their personal lifetime work record) must be less than any ex-spouse benefit they are entitled to from a former spouse. Essentially, if the "10years-married" rule is satisfied, ex-spouses are subject to the same benefit rules as a current spouse.

#### New Target store in east Fishers

A 148,000-square-foot Target store is coming to 136th Street in east Fishers, adding new jobs and a convenient shopping experience for eastside residents. The store will be located south of Southeastern Parkway at Exit 210 and will feature a dedicated drive-up order location, extensive native landscaping, and an improved pedestrian experience.

New investments from life science companies NCOG BioPharma Services has committed approximately \$280 million to build out their Fishers site along Fishers' Life Sciences & Innovation Corridor. calculated refund, prompting the victim to share information – and possibly bank account numbers – to claim it.

Violation scams. This is a fear-based scam, where the criminal poses as an IRS official threatening some punitive action, claiming the victim committed a violation and needs to contact them to resolve the situation.

#### Filing support scams.

Similar to tech support scams, criminals offer to help create IRS accounts to assist with the online filing process. Frequently posing as tax preparers, scammers will go through the motions of gathering the victim's personal information for tax forms they never intend to file.

#### Social media scams.

Social media serves as a great place for criminals to find potential victims and carry out tax scams, fraudulently claiming to offer different types of services or possessing unique knowledge or access.

#### Recovery scams. Once

a victim is scammed, criminals will try to strike again – believing the victim is gullible. Exploiting a time of vulnerability, they'll contact the victim with promises of helping them recover their losses and will leverage this as an opening to commit additional crimes.

While it is not always easy to pick out a scam, here are indicators to watch for:

• Promise of a big payout. If it sounds too good to be true, it • Demands or threats. The IRS can't revoke your driver's license, business licenses or immigration status and cannot threaten to immediately bring in local law enforcement. Taxpayers are allowed an appeals process, so any message of "now or else" won't come from an official channel.

• Request for you to click a weblink. Odd or misspelled web links can take you to harmful sites instead of IRS.gov.

The IRS recommends these best practices to protect against tax fraud:

• Get an early start. File early so criminals have less time to impersonate you.

• Set up a verified account. Set up your own IRS account before someone else can and use an Identity Protection PIN – a sixdigit number known only to you and the IRS.

 Wait for written notice. Do not respond to any supposed communications from the IRS if you haven't first received official notification through U.S. mail. If you get a call from someone claiming to be the IRS, hang up and call the official number on the website before engaging. Further, never click a link sent digitally as initial contact.

Apply good cyber hygiene. Do not use public Wi-Fi when filing your tax returns. Do use strong passwords, secured network connections and multifactor authentication. Run all software updates and keep systems current.

than 200 homicides. Along with the rise in violent and nonviolent crime, Indiana is facing a lawyer shortage. According to the Indiana Supreme Court, nearly all 92 Hoosier counties. especially Indiana's rural and most socioeconomically disadvantaged communities, have fewer lawyers per capita than the national average. That's why I'm authoring a House Republican agenda bill to strengthen public safety across the state by providing additional state investment for deputy prosecutors.

House Bill 1006 would make a once-in-ageneration investment toward the state's criminal justice system and support law and order by reimbursing qualified and participating counties up to 50% of the salary and benefits packages of deputy prosecutors. ## Purdue Passes IU on NCAA All-Time Victory List

the Purdue men's basketball program.

Already the winningest school in Big Ten Conference games only (1,047-712), the seventhranked Boilermakers moved past the Hoosiers into 10th place on the NCAA's all-time wins list with 1,946. Victory No. 1,947 came Tuesday night, a 90-81 triumph at lowa that put Purdue atop the conference standings.

Even the most casual fan could probably name the schools in the top five, maybe not in order though. Kansas (2,433) has a healthy lead on No. 2 Kentucky (2,413). The chasm is wider between bitter rivals North Carolina (2,385) and Duke (2,319) for third place. UCLA, which started playing basketball 22 years after Kansas' first game in 1898, is fifth with 2,018 victories.

The second five is not as easy to guess. Temple has taken advantage of a below average season by Syracuse to move past the Orange (2,003) into sixth place with 2,007 victories.

It may come as a surprise to Purdue and Indiana fans but neither program is the state's winningest. Notre Dame holds that distinction with 1,973 victories.

St. John's has a comfortable margin over Purdue and Indiana for ninth place with 1,961 victories.

The Boilermakers have climbed the NCAA victory list thanks in part to their record against ranked Sparked the scoring surge with season averages of 18.5 and 24.3 points as a sophomore and junior. Then came Jaden Ivey's 17.3 sophomore season in 2021-22, which enabled him to become an NBA Draft lottery pick. Zach Edey posted scoring averages of 22.3 and a nation's-best 25.2 points per game on his way to back-to-back National Player of the Year awards.

This season, it's been the three-headed attack of Trey Kaufman-Renn (18.7 ppg.), Braden Smith (16.4) and Fletcher Loyer (13.8). Smith lit up Iowa on Tuesday night with 31 points, while Kaufman-Renn put up 25 in his continuing bid to join Smith as a first-team All-Big Ten performer.

Kaufman-Renn and Smith were announced this week as semifinalists for the Oscar Robertson Trophy, presented to the nation's best player by the United States Basketball Writers Association.

To no one's surprise, Smith also is one of 10 semifinalists for the Bob Cousy Award given to the nation's top point guard. As of now, odds are that Smith will join Carsen Edwards (Jerry West for best shooting guard) and Edey (twotime Kareem Abdul-Jabbar top center) as major award winners in April.

Smith is on pace to become the first player since California's Jason Kidd in 1993-94 to average at least 15 points, 8 assists, 4.5 rebounds and 2.5 steals per game.

Smith's defensive effort against Michigan and Indiana helped Purdue record its first back-toback 20 turnover games in Big Ten play since 2008 against Indiana and Minnesota. school players. But he added that recruiting isn't completed for the 2025 season.

"We'll be really aggressive in the next portal window," said Odom of the 10-day period in April. "We still have a number of spots of need."

With just one returning starter on each side of the ball (running back Devin Mockobee and linebacker Hudson Miller) thanks to transfers, one could argue that every position is one of need.

The most important one, quarterback, will be one to watch when spring practice begins in March. It is hoped that either sophomore Malachi Singleton (Arkansas), redshirt freshman EJ Colson (UCF), redshirt freshman Evans Chuba (Washington State) or true freshman Garyt Odom, the coach's son, will establish himself as the unquestioned starter.

Seven of the 29 transfers to sign with Purdue followed Odom from Las Vegas. One is possibly the largest tight end in school history, 6-8, 290-pound Christian Earls. Another former UNLV heavyweight is offensive lineman Jalen St. John, who casts a giant shadow at 6-5, 330.

Fifteen of the transfers are seniors, three are juniors, five are sophomores and six are redshirt freshmen.



teams since the start of the 2021-22 season. Nobody in the nation has been better than Purdue, which has gone 23-9 against the Top 25.

Coach Matt Painter is now 22-12 all-time against Indiana, aided by winning 16 of the last 20 matchups with the Hoosiers. Purdue is 9-1 against Indiana in the last 10 meetings at West Lafayette.

While it is still early to be looking at mock NCAA tournament seedings, Purdue's 11 Quad 1-2 victories this season only trails Auburn and Alabama, which have 13 each. One nationally known bracketologist had the Boilermakers as the highest No. 2 seed in his latest projections.

Maybe one of these days, Purdue will shed its national reputation as a "plodding offense." Painter's shift from a defensive emphasis inherited from his mentor, Gene Keady, to a faster paced offense coincides with some of the Boilermakers' greatest success in recent years.

When scoring at least 80 points, Purdue is 104-3 since the start of the 2017-18 season. Carsen Edwards

#### Forty and counting

New Purdue football coach Barry Odom is no stranger to rebuilding projects.

The largest Boilermaker recruiting class in recent memory is going to have to be the foundation of any effort to recover from last season's 1-11 disaster.

"The 40 young men we've signed ... since things have changed in recruiting with transfers and portal and high school recruiting, what is the right number?" Odom said Wednesday on National Signing Day. "I think anyone who has studied what roster management looks like, the recruiting trends, I think those numbers are going to remain consistent as we go forward, 40 and 40-plus.

"Over the last two cycles that I was a part of before this (at UNLV), we signed 50 and before that 55. The ability to adapt, the ability to roster manage is so vitally important to the health of a program." Odom emphasized that Purdue will continue to recruit and develop high Feb. 3, and Sports Collectors Daily honored the former Purdue All-American's milestone by listing eight of his most collected appearances on football cards.

My card collection includes just four of these Griese cards: his first Topps issue in 1968, a 1970 Kellogg's 3D card, a 1971 Topps "game card," and his 1972 Topps All-Pro card.

I've never seen his 1967 Royal Castle card, featuring a posed Griese inside Ross-Ade Stadium. Royal Castle was a South Florida hamburger chain that at one time had 185 restaurants in the Miami region. The other Griese cards on the Sports Collectors Daily list were a 1975 Wonder Bread issue, his 1977 Topps card and a 1978 card manufactured by Topps but placed into bags of Holsum Bread.

### **Carmel Expands CFD Staffing**

In support of the City's commitment to world-class public safety, the Carmel Fire Department is expanding staffing to better serve the growing west side community.

A6

The Carmel City Council approved funding at tonight's meeting that will provide two firefighters per shift, six total, to staff the Advanced Life Support ambulance currently parked at Station 342. Located at 106th Street and Shelborne Road, Station 342 serves the southwest side of Carmel as the first fire and EMS response unit.

The additional staffing will:

- Reduce ambulance response times serving patients on scene, ensuring timely transport to hospitals for critical medical attention.
- Enhance initial fireground operations, reducing response times and minimizing property damage during residential and commercial fires and emergencies.

"Already, we have one of our state's premier firefighting and response teams," said Carmel Mayor Sue Finkam. "I appreciate the council supporting this additional funding that will enhance our response times on the west side, providing a high and consistent level of excellence city-wide."

The approved funding follows a comprehensive assessment by Carmel Fire Department Chief Joel Thacker, who was appointed by Finkam in August 2024. At that time, she called for a plan focused on increasing public safety staffing and services, particularly to the west side of the City.

side area targeted for the increased staffing occasionally falling under the standard.

The City partnered with the International Association of Fire Fighters Local 4444 on the assessment, which focused on increasing fire and EMS service delivery to areas of the city that are not currently meeting all national standards guidelines.

"We thoroughly reviewed current services, past incident numbers and response times and determined that additional equipment, facilities and personnel are needed to provide increased fire and EMS services to the west side of Carmel," Thacker said.

Citing the tremendous growth in the area served by station 342 over the past 20 years, Thacker noted an increase in large private residences, apartments, townhomes and commercial property.

"The increased staffing will bring the southwest side of Carmel up to the same high standard throughout the rest of Carmel," he said.

Accessible beaches, gentle walking paths, and cultural events offer enriching experiences. Excellent healthcare facilities ensure a worry-free stay.

Hawaii Volcano Village offers seniors accessible trails and unique volcanic landscapes for a peaceful winter retreat. Cozy accommodations and local art galleries provide indoor activities, while nearby medical care ensures safety.

#8 Stuart, Florida With walkable waterfronts and charming shops, Stuart is perfect for seniors in winter. Accessible ecotours, cultural sites, and excellent healthcare make this vibrant coastal town a delightful retreat for older travelers.

#9 Paia, Hawaii Paia provides seniors with accessible beaches, boutique shopping, and a relaxed coastal atmosphere. Its supportive community and proximity to healthcare make it a serene winter getaway.

"The U.S. is miles ahead of many other countries in prioritizing accessible public spaces, travel, and accommodations," says Ryan Holt of Freedom Showers ."This makes it a standout option for senior travelers, especially as international travel becomes less appealing with age."

National standards for the delivery of **Emergency Medical** Services include recommended response times to 911 calls within a fire department response district. The standards call for the first arriving unit within five minutes not less than 90 percent of the time, with a transporting unit arriving within nine minutes not less than 90 percent of the time. Carmel's districts all meet or exceed the standard, with the west

#5 Crystal River, Florida Crystal River's warm Gulf Coast weather makes it a favorite winter destination for seniors. Accessible boat tours to view manatees and peaceful parks provide gentle activities, while the town's strong medical services ensure safety and comfort. \* 29% indicated they no longer travel abroad, citing increased challenges and preferences for domestic trips.

\* 17% still travel internationally but less frequently, with only 12% maintaining the same level of international travel as before turning 65.

\* Accessibility is a major deciding factor: 33% of respondents said accessibility standards and laws give them confidence when planning U.S. trips, and 10% identified these standards as the primary reason they choose domestic destinations.

The survey also highlighted that many seniors perceive international travel as more challenging compared to domestic trips. Twenty-seven percent of participants felt international travel was significantly more difficult due to issues like mobility, transportation, and accommodations, while an additional 27% found it somewhat more challenging. ## **Carmel Adding Another Roundabout**

Beginning on or after March 17, the City of Carmel will begin constructing a roundabout at the intersection of East 96th Street and North College Avenue. This project will require a full closure of the intersection for approximately 60 days.

In addition to the roundabout. improvements will take place along North College Avenue from East 96th Street to East 104th Street during the next 12 months. These upgrades will include utility coordination, enhanced pedestrian connectivity (such as multi-use paths), and the installation of additional roundabouts at Pennsylvania Parkway and Parkwood Crossing. Landscaping will also be added along North College Avenue.


The full closure of East 96th Street and N. College Avenue as well as College Avenue between the intersection and I-465, will remain in effect until June 1, 2025.

After this date:
