Did you know that April is National Financial Literacy Month, but most Americans are only getting part of the story? Dear Rusty:

Rusty

I have questions concerning the deduction of money from my Social Security benefit amount as relates to the sale of investment property. I am 66 years old and have been drawing Social Security since I turned 62. My wife is 56 and is a housewife and has no taxable income. Our income comes from our rental property and my Social Security benefit. I have decided to liquidate two of our properties one was sold in December 2024, and one is in Escrow and is scheduled to close in March 2025.

My normal Adjusted Gross Income (AGI) has been running about \$30K-\$32K. However, last year with the sale of the property I will receive a long-term capital gain profit of about \$255K. I did a rough calculation on

what my AGI will be for 2024, and it looks to be about \$318K. How will this affect my Social Security benefit, and will it have an effect on the amount I pay for my Part B Medicare Plan going forward? I have a Medicare Advantage plan.

My next question is about 2025 (after the next property closes and I file taxes), my AGI with the long-term capital gain profit could be between \$700k-\$800K. How will this affect my benefits going forward? Signed: Prudent Investor

Dear Prudent Investor: Actually, the GROS

Don't Scan QR Codes on **Unexpected Packages**

A package you didn't order could be a fun surprise, but be careful - especially if it comes with a QR code. It might be the setup for a scam.

In a "brushing" scam, you receive a package you didn't order, often without a return address. This is often a setup by unscrupulous companies who found your address online. After the company ships the product to you, they can post a fake, positive review on your behalf to improve their store's ratings and get more sales.

• Gov. Mike Braun is in the spotlight. He ran and won the office last fall by convincing Hoosiers he was going to do something about property taxes and ridiculous government spending. 

to a provision known as "IRMAA" (Income-**Related Monthly** Adjustment Amount). IRMAA affects the Medicare premiums you pay from your Social Security benefit, and a higher Medicare premium will result in a lower net Social Security payment. Here's how this will work for you:

Your Medicare premiums each year (typically for Medicare Part B and Part D) are determined by looking at your "Modified **Adjusted Gross** Income," or "MAGI", from two years prior (MAGI is your normal AGI plus any nontaxable interest you may have had). Since the property you sold in 2024 will be reflected as part of your 2024 income, IRMAA will cause your 2026 Medicare premiums to be higher than the standard monthly 2026 amount. How much higher depends on how much you exceed the income level for your IRS filing status. Using 2025 rules, if you file as Married/jointly and your taxable income (MAGI) is more than \$212,000 but less than \$334,000 then, instead of paying the standard 2026 monthly Part B premium, you'll each pay \$370 per month for Medicare Part B (and likely a supplemental amount of \$35.30 if your Advantage plan includes prescription

Your Medicare premiums are recalculated every year (again based on income from two years prior). Thus, in 2027, IRMAA

will also affect your Medicare premiums and your net Social Security payment because of your 2025 real estate transaction. If your MAGI in 2025 will be over \$750,000, then IRMAA will increase each of your 2027 Medicare Part B premiums to \$638.90 (and likely also add a supplement of \$85.80 per month each to your Medicare Advantage premium for

The good news is in 2028 all of this will be behind you and your Medicare premiums will revert to whatever the standard monthly premiums are for that year (because your income levels thereafter will presumably be below the then-IRMAA thresholds).

ABOUT BBB SERVING CENTRAL INDIANA: The Better Business Bureau has empowered people to find businesses, brands, and charities they can trust for more than 110 years. In 2024, people turned to BBB more than 220 million times for BBB Business Profiles on more than 5.3 million businesses, and 80,000 times for BBB charity reports on about 12,000 charities, for free at BBB.org. The International Association of Better Business Bureaus is the umbrella organization for the local, independent BBBs in the United States and Canada. BBB Serving Central Indiana was founded in 1916 and serves 42 Indiana counties.

Reports to BBB Scam Tracker over the last few months show a twist on brushing scams where the package contains a QR code. The code comes with instructions to scan it to find out who sent the package or how to start a return. Scanning the QR code can lead to a phishing website or download malware onto your device.

In one BBB Scam Tracker report, a consumer received a package of pasta via Amazon in her name. Thinking it was a gift from a friend, she scanned the QR code that came with the package. The QR code took her to a website that appeared to be Amazon. The consumer said she has received a higher-than-normal amount of scam emails since scanning the QR code.

In another BBB Scam Tracker report, a consumer received a ring in the mail that he did not order. The ring came with a QR code. The consumer checked **BBB Scam Tracker** before scanning the code, and after reading other reports about brushing scams, he decided not to scan it.

It might seem like there are no downsides to a free package, but it could be a sign that someone is using your personal information for their own gain. If this happens to you, BBB recommends checking the security of your accounts and notifying the retailer who sent you the package.

What to do if you receive a package you didn't order:

- Don't scan QR codes. They might take you to a phishing site that steals your personal information or download malware onto your device.
- Protect your identity. If you did scan the QR code and enter personal information, change your passwords for any accounts that may have been compromised, and enable two-factor authentication. Keep a close eye on your credit reports and credit card bills after you receive the package.

 Notify the retailer. If you can tell where the package is from, go directly to the retailer's website to get their contact information and report the package as a scam. Retailers like Amazon have policies banning brushing and fake reviews, and they will investigate your report.

- Check for fake reviews. If you can identify the company that sent you the packages, look for false reviews in your name and report them to the retailer. • Pause deliveries.
- One package is no big deal, but some targets of brushing scams are overwhelmed with a floor of unordered packages, creating a serious problem. If this happens, you may want to consider temporarily refusing package delivery at your home address and directing your real orders to a package acceptance service.
- Keep the package. The one silver lining of brushing scams is that you get to keep the gift - the Federal Trade Commission says you have a legal right to keep unordered merchandise. Don't try to return it, especially if there are instructions to scan a QR code or enter information. It could needlessly compromise more of your personal information.

Lt. Governor Makes **Mass Spending Cuts**

Lt. Governor Micah Beckwith is announcing mass spending cuts his office is making after assuming his role as Indiana Lieutenant Governor from the previous administration.

The office will not be renewing the following contracts:

- Two separate professional development training services totaling \$120,510;
- An outside graphic design service totaling \$27,000;
- The social media management platform, Hootsuite, totaling \$1,188;and
- The image hosting service, Flickr, totaling \$132.

The office has already canceled a subscription to The New York Times, totaling \$195. Additionally, the office renegotiated an existing contract saving \$15,000 of Hoosier taxpayer money.

"When I first came into office, I asked my team for looking for items and services we could cut immediately," Beckwith said. "I knew there would be wasteful spending left over from the previous administration. Fiscal

responsibility isn't just about numbers-it's about ensuring every dollar serves the people effectively. By cutting unnecessary spending, we can ensure that taxpayer money is going to essential services to Hoosiers."

One major purchase made by the Office of Lt. Governor was a new car. The car from the previous administration had been in multiple accidents and was suffering from mechanical issues. Additionally, the car would not be large enough to accommodate the Lt. Governor and his staff when traveling for town halls and meeting with community leaders around the state. The Lt. Governor's office submitted a request through the Indiana Department of Administration for a car to accommodate the office's needs and the office was presented with only two options. The purchase price of the car is less than the existing savings to be cut to the aforementioned.

"Overall, the Lt. Governor's office has already saved the state money," Beckwith said. "I look forward to continue to dive into these contracts and to make the necessary cuts."

Carmel Reports on Meeting to Save Taxpayer Dollars

Findings from a detailed financial and legal review initiated to ensure appropriate use of taxpayer dollars were discussed at a recent Affiliate Review Committee meeting.

While the full fiscal and legal review prompted in partnership with Mayor Sue Finkam and the Carmel City Council includes four supporting organizations, Thursday's meeting focused on the operation of the All Things Carmel retail store and its supporting organization, Promote Carmel, Inc.

The Promote Carmel, Inc. board of directors voted to close All Things Carmel in August of 2024, with the city taking steps to wind down and dissolve the legal

The store, which sold Carmel-branded items and products from local vendors, operated at a loss since its inception and would have required an additional subsidy of \$100,000 to remain open, prompting Mayor Finkam to call for the need to prioritize important expenditures such as police and fire staffing, as well as road maintenance.

"Running a gift store was not an essential City service and subsidizing it did not serve our taxpayers," the mayor said. "That's why we took steps to close the store and redirect those taxpayer dollars to public safety and other essential services. I appreciated the City Council's support on the

members heard findings from the review, including a summary of annual subsidies to the store that exceeded \$1.2 million over five years. In addition, the review noted that some use of taxpayer funds and donor directed funds conflicted with city policies and with laws governing the nonprofit status of the supporting organization.

City Councilor Ryan Locke, who leads the Affiliate Review Committee, said he was pleased with the detailed review of the affiliate's operations, noting that council and the mayor continue to be unified in the efforts to put appropriate controls in place to ensure taxpayer dollars can only be spent on critical, known and approved city services, initiatives and partners.

"We came into office with the intent to protect taxpayers by increasing transparency, oversight and accountability in government operations," Councilor Locke said. "The findings from this review highlight some of the issues that can arise with unchecked executive authority. The work of this committee will help us build the right framework of checks and balances to ensure our government and any of its affiliates will operate in the best interest of our city and our citizens which is, and should always be, the most important mission."



Health, Parks Departments Partner for Health

The Hamilton County Health Department will use state grant funding to support a series of community-focused health and wellness programs through Hamilton County Parks and Recreation (HCPR) aimed at encouraging physical activity, improving mental health, and promoting overall well-being. These initiatives will support residents and visitors with a variety of outdoor and fitness activities designed to combat obesity and support mental health.

One of the components of this funding is the introduction of a Bike Share Program at Strawtown Koteewi Park and the White River Campground. This program offers readily available bikes for park-goers and campers who are unable to bring their own to the park. By providing convenient access to bicycles, individuals will be encouraged to explore the park and incorporate physical activity into their visit.

HCHD will also fund additional exercise equipment at HCPR parks. The creation of additional fitness stations in various parks is aimed at offering free, accessible exercise opportunities to people of all ages and fitness levels. The goal is to eventually offer instructor-led classes using the equipment at these parks.

Through a collaboration with the Hamilton County Youth Assistance Program (HCYAP), HCPR will provide outdoor recreational activities at the Strawtown Koteewi Park Adventure Area to atrisk youth with HCHD funding. These programs, which have already proven successful, offer young people free access to unique therapeutic and educational experiences, such as equestrian

programs and archery, while also promoting mental health through outdoor engagement. HCPR's goal is to expand this collaboration and provide even more opportunities for youth to develop positive habits and connect with nature.

A new partnership with Camptown will introduce the "Wilderness to Wellness" program, an adventure-based initiative that focuses on building resilience and teaching coping skills to at-risk youth through activities like hiking, rock climbing, and wilderness travel. This program will combine physical activity with mental health education, empowering participants to develop both physical and emotional strength. The program will provide a much-needed diversion for at-risk youth, introducing them to activities they may not have experienced before while also fostering positive mental health outcomes.

Yoga continues to be a popular offering within the county's park programs. The Health Department will help support the ongoing success of the free Sunset Yoga Program at the Osprey Pointe Pavilion, where participants can unwind and relax with guided yoga sessions while enjoying the scenic view over the water. In addition, the free Y12SR Recovery Yoga program, which supports individuals recovering from substance use disorders, will continue, offering a crucial therapeutic outlet for those affected by addiction. how it works. If you get to keep more of your money, that means the government gets less. One side or the other is going to feel pain. That is a fact. The lobbyists and (so far) the politicians have decided that will be you. We'll see if that changes before the legislature wraps up.

- And along THOSE lines, while the government is choosing you to feel the pain instead of them, they are also saying something else. During tough times, the ones who bear the brunt are taxpayers. That's just wrong. When belts have to get tightened, our government should never tighten after we do, or less than we do. It's not that complicated.
- Ultimately, what started as property tax reform has turned into property tax rerun. And like the stale re-runs we see on TV, we all know how things turn out.
- Another VERY interesting angle is that Braun's next political opponent could well be just down the hall (well, up the stairs and across the hall) in Lt. Gov. Micah Beckwith. A quick review -Beckwith campaigned for and won the lieutenant governor's nod at the convention, despite Braun hand picking Rep. Julie McGuire. Beckwith campaigned extensively around the state and his conservative, Christian, common sense platform won favor with Hoosiers. LOTS of Hoosiers. If Braun backs off on property taxes now, he'll very likely be a one-term governor and his replacement could easily be Beckwith.

So many questions, so few answers. It'd be easy to say this is going to go like it always does. A few folks will make noise and jump up and down, but ultimately we'll take what our overlords (uh, I mean elected representatives) hand us.

Or not.

Mind you, I'm not saying there is hope. But the reality is the political climate has changed. Thanks to DOGE shining the light on outrageous examples of our tax dollars being utterly squandered, people are paying more attention . . . and are more fed up.

Here's a big question for Republicans and more importantly, voters. Do you remember when the GOP was the party of limited government and tax cuts? What happened to that? Don't forget that the Republicans have a super majority in the Statehouse. They can literally do whatever they want.

Just one vagabond newspaper guy's opinion, but Braun is going to have to choose between legislators and taxpayers. And to be sure, that doesn't mean property tax reform will win out. Just because the governor says it doesn't mean it'll happen. There's that pesky executive / legislative branch thing (are you listening Mr. Trump?). But Braun can and should veto anything with a "minimal" amount of property tax relief. If the legislators don't deliver real reform, Braun should step up and call a special session. He should make it clear that he is fighting for us, and those in the chambers of the House and Senate are not. They can override him, but if they do I'd hate to be in their shoes when the next campaign
