# **A Visit From the Kansas Smasher?**



Some headlines in the old newspapers

just beg to be PAULA investigated. DUNN Take this one From Time in the July 26, to Thyme 1906 Hamilton

County Times – "Kansas Smasher May Be Sojourning Here – Is Hard To Locate."

"Kansas Smasher?" How could I ignore that?

According to the rather lengthy article, a woman who resembled Carrie Nation, the radical temperance crusader from Kansas, had checked into Noblesville's Houston Hotel the previous week and speculation had immediately run rampant that she was THE Carrie Nation.

(I would hope that everyone has heard of Carrie Nation. However, given how politicized education has become, it probably doesn't pay to assume anything these days, so I'll pause here for a little background. Carrie Nation gained fame - or infamy, depending upon your viewpoint - in the first decade of the 1900s for waging a violent campaign against establishments that served alcohol. She marched into saloons all around the country, praying and singing hymns while using rocks or a hatchet to smash bar fixtures and destroy vast quantities of liquor.)

bar connected with your hotel?"

Apparently satisfied with the porter's "no," she allowed him to carry her luggage into the hotel, where she signed in as "Ada Eaby" of Chicago.

Several "traveling men" were seated in the hotel's lobby at that time and one of them "positively" identified the newcomer as Carrie Nation. That was enough to set tongues wagging – and to spook the hotel manager, T.J. Carroll, into tossing his cigar away.

(Nation was nearly as antitobacco as she was antialcohol. She'd been known to snatch cigars right out of men's mouths while berating them for "polluting God's pure air!")

Mrs. Eaby immediately retired to her room and remained there the rest of the evening, frustrating the busybodies in the lobby no end. She didn't show herself again until the following morning.

The story that eventually came out was that she was a representative of a Chicago wholesale house and had come here to call on the city's school teachers. She admitted, however, that she expected that most of the teachers were out of town. (It was summer, after all.)

reporter described Mrs. Eaby as a "heavy set lady not over five feet tall."

Most sources indicate that Carrie Nation was nearly six feet tall and weighed around 180 pounds.

When informed that she'd been mistaken for the Kansas Smasher, Mrs. Eaby just laughed and expressed the opinion that the Smasher should be arrested.

The Times noted that this wasn't the first time Mrs. Eaby had been mistaken for Carrie Nation. About five years earlier, while visiting another Indiana town, she casually commented on the town's large number of saloons and later found herself attracting a crowd of looky-loos.

After all this I was curious to learn if the real Carrie Nation had ever set foot in Hamilton County.

I wouldn't have been surprised if she had. One of the first things I noticed when I began doing serious research in the old newspapers was how strong the temperance movement was in this county.

It's pretty clear that those who mistook Mrs. Eaby for Carrie Nation had never actually laid eyes on the Kansas Smasher. The Ledger However, although Carrie Nation paid many visits to Indiana – including stops as close to Hamilton County as Indianapolis, Knightstown and Crawfordsville - it appears the only time she was here was when she was a passenger on a train that traveled through in 1901.

16 When the Sabbath was over, Mary Magdalene and Mary the mother of James and Salome bought spices, so that they might go and anoint him.<sup>2</sup> And very early on the first day of the week, when the sun had risen, they went to the tomb. <sup>3</sup>They had been saying to one another, "Who will roll away the stone for us from the entrance to the tomb?" <sup>4</sup> When they looked up, they saw that the stone, which was very large, had already been rolled back.

<sup>5</sup> As they entered the tomb, they saw a young man dressed in a white robe sitting on the right side, and they were alarmed. <sup>6</sup> But he said to them, "Do not be alarmed; you are looking for Jesus of Nazareth, who was crucified. He has been raised; he is not here. Look, there is the place they laid him. <sup>7</sup> But go, tell his disciples and Peter that he is going ahead of you to Galilee; there you will see him, just as he told you." 8 So they went out and fled from the tomb, for terror and amazement had seized them, and they said nothing to anyone, for they were afraid.

Everybody in the family had made their summer plans. But just before Thurman and his wife were ready to leave for speaking engagements, they received word that a companion who lived with their aged grandmother in another town had died. Someone would have to go and be with grandmother during the summer.

A Visit to the Tomb, an Easter Sermon

The family met and talked it over. Thurman's commitments could not be postponed. It was decided the daughters would take their turns and care for the grandmother until the parents returned from their conferences.

When this decision was reached, the youngest daughter rushed from the table and ran up the stairs, weeping. The door slammed. Thurman followed her up the stairs, knocked at the door and found her stretched across the bed, sobbing. He spoke these words to her:

"I didn't come up here to urge you to stop crying. I came to explain to you why I think you are crying. I don't think you're crying because you don't want to go away for the rest of the summer and miss the fun with your friends. You're crying because for the first time in your life the family is asking you to carry your end of the stick as a family member. Something inside you knows that when you get on the train tomorrow, one part of your life will be behind you forever. You'll never again be quite as carefree and unaccountable as you were before." (Thurman, Disciplines of the Spirit (New York: Harper & Row, 1963), 54-55)

witnesses, who until now have been a model of obedience as loyal by-standers, are suddenly called to take definitive action and to spread the Good News. Fearful of the angel, the message and the responsibility, these women fail. They run away silent and shaken.

According to other ancient Biblical interpretations, though, there is a different intermediate ending of Mark which claims that the women did tell those around Peter what they had seen and heard.

But in either case, the risen Jesus has given his disciples an order: Meet me in Galilee.

Galilee... was the site of Jesus' greatest teaching, preaching and healing, the place where the disciples were called together originally. It was the heart of his mission activity --Galilee. And it is all to continue in Galilee -if the disciples will only free themselves from their own fears and come out and meet the risen Christ.

The gospel of Mark describes the faithful Mary Magdelene; Mary, the mother of James; and Salome (Sal-oh-may) as worrying about how they will get into Jesus' tomb once they reach it. What an inversion when considering the church, instead -worrying about how to get into a tomb -a safe, dark, sealedaway catacomb -rather than worrying about how to get out of such a lifeless, damp and totally dark, and empty existence.

#### **"DO I HAVE THAT** RIGHT?"

Heck, I wasn't worried about my heart attack now. Hammer looked like he was going to burst at any second.

For those who don't know John Hammer, he is a giant of a man. He's retired now but clearly worked hard for a living. His huge hands are rough with callouses and his neck lined deeply with creases that were caused by heavy lifting and too many hours under a hot sun. That neck is red, and his heart bleeds red, white

Hammer looked around.

"This is what I see," he said - almost sounding defeated. "Braun got us to vote for him by saying things would be different. He convinced us. And then he does this. He does what government always does. He compromises. He caves. He plays politics. I'm sick to death of politics. I want change. I want fairness. I want to keep more of my money instead of giving it to these clowns to waste."

The defeatist tone abruptly stopped.

Hammer walked out. I wondered how many other Hoosiers are feeling the same way?

Today we end our series on the Journey to Easter with a "Visit to the Tomb" where Jesus was laid after he was crucified.

Tell me....How do we help people out of their tombs? The resurrection calls us forth to roll away the stones that crush people's lives. In a world filled with rolling stones, there is a desperate need for stone rollers.

Besides becoming a Baptist minister in the 1920s, Howard Thurman wrote twenty books on theology, religion, and philosophy, and was a mentor to Dr. Martin Luther King Jr. He wrote over 58,000 documents during his 63-year career, and at one point, served as Dean of Marsh Chapel at Boston University until his retirement. He died in 1981. In his book entitled, Disciplines of the Spirit, he tells of a crisis that took place in his young daughter's

We all want to remain children. We all yearn for those days when we were free from responsibility. Does anyone here recall those carefree days? No responsibilities?

Perhaps that is why we don't like the ending of Mark's gospel very much. Unlike Luke and Matthew and John, who pad the new responsibilities of the disciples with comforting stories of the resurrected Jesus' appearance in their midst, Mark's ending starkly reminds us that while Jesus is risen, things are different now.

The women

Mark's gospel demonstrates how foolish and foundless the women's concerns were -- it is God Our Father who raises Jesus from the dead, our God Almighty who rolls away the tombstone.

I am not blaming the women here. Like many disciples, we can hear of the teaching and love of Jesus, but when it actually happens right in front of our face, it surprises and astounds us. Sometimes confuses us to the point where we convince ourselves, "Nawww, that really didn't just happen." We dismiss it as a possibility of God. Oh really? Oh, yee of little faith!

Now, resurrecting Jesus is not our job, of course, but

meeting him is. The stone that had rolled away so easily to free Jesus seems to crash shut again on the women's hearts, their courage and commitment, trapping them in a tombstone frame of mind.

How do we, the community of Christ, the church of the risen Lord, get all those folks like the two Marys and Salome, like the disciples huddling in some hidden room in Jerusalem, like Peter -probably wedged under some rock of his own -- out of the tomb? How do we roll away their stones?

The angel-messenger inside Jesus' empty tomb tells us how.

By boldly stepping out into the world and taking up the earthly ministry of Jesus where he left it. By offering the risen and regal Lord to every "Galilee" there is in the world. By becoming a stoneroller ourselves.

Speaking of "stonerollers", can anyone identify who these people are?

Now here's a group of stone rollers that came about in 1962, so they have been around a bit. (Does anyone identify?)

According to Business Insider, having performed over 2000 concerts worldwide over the past 62 years, The Rolling Stones' Hackney Diamonds Tour will take the group across 16 cities in America doing 19 shows from April through July, 2024, to kick off yet another brand new album! Talk about resurrection! When we enter our own Galilee with the intent of witnessing to the resurrection of Christ,... to help roll away the tombstone from someone else's life.... to open their eyes to the Good News of Christ...

A used bicycle sale and donation day will be held Saturday, May 17, from 10 a.m. to noon, sponsored by Good Samaritan Network of Hamilton County. The event takes place at Recycled Cycles, 810 E. Main St. in Westfield. (The shop is located at the top of the drive, north of Big Hoffa's BBQ.) Around 40 topcondition bikes and high-end 700c wheels and other parts (Campy, Shimano, SRAM) will be offered for sale at bargain prices. All bikes have been repaired, adjusted, lubricated and inspected for safe use. Payment by check is preferred (sorry no Venmo, Paypal, credit card, etc. available). Proceeds will be used to purchase parts to repair other bikes. Last year, Recycled Cycles repaired and gave away 400 bicycles to deserving families who might not otherwise have afforded new all-volunteer group that repairs child and adult bikes throughout the year under the sponsorship of Good Samaritan Network of Hamilton County. Donations of any used bike, no matter the condition will be accepted. Parts from unrepairable bikes are salvaged to make whole bikes.

## Real Estate Numbers Strong in March Locally

For the first time in four months, pended home sales in central Indiana increased in March. Available housing inventory also rose, while home sale prices remained relatively flat.

According to F.C. Tucker Company, part of the Howard Hanna family of companies:

In Noblesville in March:

- Closed home sales increased 11 percent compared to March 2024.
- Homes sold two days, or 28.6 percent, faster than this time last year, leaving the market in five days on average.
- Compared to March 2024, the median home sale price increased 6.7 percent to \$400,000.
- The median price per square foot also increased, up 7.6 percent to \$183.

In Hamilton County in March:

- Pended home sales increased 15.7 percent compared to March 2024.
  Ausilable bausin
- Available housing inventory increased 6.9 percent.
- Hamilton County homes remained on the market only one day longer than this time last year, leaving the market in 10 days on average.
- The median home sale price increased 5.4 percent to \$437,500.

Beyond Hamilton County, the numbers were also good.

- Available housing inventory increased 20.7 percent compared to March 2024.
- Homes spent five days, or 33.3 percent, longer on the market than this time last year.
- Compared to March 2024, the median home sale price for the 16-county central Indiana region increased 3.1 percent to \$299,000.

In March 2025, 3,298 central Indiana homes were purchased, an increase of 3.7 percent from the 3,179 sold in March 2024. Year-todate home sale prices increased 5.4 percent overall. And central Indiana experienced a 20.7 percent increase in overall available home inventory in March 2025, compared to March 2024, with 728 more homes available for sale

"Now that spring is here, we expect to see the central Indiana residential real estate market reinvigorate," said Jim Litten, president of F.C. Tucker Company. "Interest rates have stabilized, inventory is increasing, and the median home sale price remains flat, at the same level as last summer, creating an attractive market for prospective buyers."

Of the pended home sales in the region last month, seven were priced \$2,000,000 or higher; 57 were priced \$1,000,000 to \$1,999,999; 455 were priced \$500,000 to \$999,999; 1,174 were priced \$300,000 to \$499,999; 947 were priced \$200,000 to \$299,999; 571 were priced \$100,000 to \$199,999; and 87 were priced at \$99,999 or less.

growth in the state's Medicaid program means there is not much additional revenue for lawmakers to work with when crafting the budget. This resulted in decisions to "tighten the belt" and ensure our state is not spending beyond our means.

However, the budget does have bright spots, including an increase in K-12 funding, a moretargeted three-tier **Teacher Appreciation** Grant program, funding to improve mental health, tools for economic development so we continue to invest in Indiana, and an ongoing commitment to paying down our pension obligations under the Pre-96 Teachers Retirement Fund.
