Noblesville Schools Earn National Recognition

Noblesville Schools announced that they have been recognized nationally with honors in both STEM (Science, Technology, Engineering and Math) and music education.

The district was named a 2025 Project Lead the Way (PLTW) Distinguished District for providing broad access to transformative STEM learning opportunities, and a national Best Community for Music Education by the National Association of

County OKs \$3.5 Million for Urgent Care Center

The County Council and County Commissioners have approved \$3.5 million for the creation of an urgent care center in Noblesville. The stateof-the-art facility, to be called the Rely Center, will be located on Aspire Indiana Health's campus and will address urgent mental health, substance use, and psychiatric crises.

The 23-hour crisis center is the result of a strategic partnership between Riverview Health, the Hamilton County Health Department, the Hamilton County Council on Alcohol & Other Drugs, MindWell Solutions, and Aspire Indiana Health. It was spearheaded by Hamilton County **Commissioner Mark** Heirbrandt and County Councilor Steve Nation, a retired judge committed to addressing the intersection of mental health and the criminal justice system.

"This center has been a long time coming," Nation said. "Too many individuals cycling through our courts and jails are there not because they are criminals, but because they are in crisis. The Rely Center offers new path – one focused on treatment rather than incarceration. I firmly believe this will reduce recidivism, ease the burden on our criminal justice system, and help build a safer and healthier community."

observation. Aspire Indiana Health will renovate a portion of its facility on Cumberland Road to accommodate the new center.

"We're proud to be at the heart of this transformative initiative," said Antony Sheehan, President & CEO of Aspire Indiana Health. "This is about meeting people where they are - in crisis and giving them the compassionate care and connections they need to recover. We believe this center will have a profound and lasting impact on the wellbeing of our community."

The Rely Center will be open to everyone in need — no appointment or referral required. Individuals are encouraged to seek help before reaching a breaking point, much like they would visit an emergency room for a physical health crisis.

"This facility will make a major difference for our local hospitals and emergency departments," added David Hyatt, President & CEO of Riverview Health. "Right now, ERs are often the default destination for people in crisis, which is not always the best setting for their needs. The Rely Center will provide targeted, expert care and alleviate pressure on emergency services."

Currently, Hamilton County residents in mental health crisis are transported to facilities like Community North in Marion County. The Rely Center will allow individuals - both youth and adults - to receive care closer to home. The center will be staffed by a multidisciplinary team of behavioral health and medical professionals who can provide triage, assessment, rapid stabilization, symptom reduction, and

In addition to reducing hospital and jail admissions, the Rely Center is expected to reduce overall response times for law enforcement and emergency personnel, shortening the time it takes them to transport individuals out of county for care. The center will also connect individuals with housing, employment, and other essential supports.

Construction and renovation are under way, with the goal of opening the center in fall 2025.

I received this message after quiet and focused prayer, taking this burden to the foot of the cross and talking to Jesus about it. He listened and He answered. Why do we not solicit His help more often?

God has been ready for action for quite some time. So now my prayer continues for guidance and the wisdom to bring what we experience today into the context of

Alan Bardach was missing for nearly six months before being officially reported dead.

Michael Randall's wife gave birth to their second child the day before her husband was killed. Randall was posthumously awarded the Distinguished Service Cross for the "extraordinary heroism" he exhibited in helping evacuate wounded members of his platoon.

James Grant was killed while helping to rescue supplies and ammo from a vehicle damaged by a landmine.

Several of the soldiers on the list were awarded posthumous medals for heroism.

The last two names on the monument were obviously added to the list later since they're not in alphabetical order. They puzzle me a bit. I hope someone can provide some clarity about them.

According to his obituary, Nelson T. (Ted) Hicks died in a plane crash near Guam. Since this took place after U.S. troops left Vietnam in 1973 and the crash wasn't in Vietnam, I'm

listed among the Vietnam War dead.

Cpl. Cupp appears on the Crownland monument as "Charles John Cupp." I found nothing under that name, but Ancestry's military records database, Fold3, shows a "Cpl. John Charles Cupp"

I think this must be the same man because John Charles Cupp died in Vietnam and Noblesville is given as his hometown. Oddly, I was unable to find an obituary for him in the Ledger under either name.

Enjoy your holiday, but you might take a moment to reflect on the young men on this list, as well as the other members of our military who have lost their lives serving this country.

That IS the reason for Memorial Day, after all.



Carmel Announces Street Pavings

The City of Carmel Street Department has released its list of 2025 street paving projects. More than 50 lane miles of roadway are scheduled for an upgrade this spring and summer as the Street Department kicks off its annual effort.

Each paving project begins with concrete and curb repairs, a phase that typically takes a couple of weeks to complete. This is followed by milling the top surface of the blacktop and repaving it with a new, two-inch thick layer. Milling and paving projects require three to five days to complete and will necessitate lane restrictions.

The Street Department uses the Pavement Condition Index (PCI)

of repair for our roadways. StreetScan (pictured) is employed to survey all 1,400 lane miles of Carmel roads bi-annually. Lasermeasuring technology assigns PCI scores to each road segment. This laser device is mounted at the rear of a vehicle with a roofmounted camera for 360-degree imagery.

"By continuing to utilize data-driven asset management, we are able to objectively prioritize roads for resurfacing. This treatment method allows us to extend our road networks life, while ensuring high standards are maintained," said Matt Higginbotham, Carmel Street Commissioner.

STAY SAFE from Scammers

As technology continues to change, it is important for Hoosiers to remain vigilant of those who wish to do them harm.

Earlier this week, fraudulent messages were purportedly sent by state agencies about collecting tolls. These messages are scams, as the state does not send unpaid toll notifications through texts or emails. Anyone who received these messages should not click on any links and should delete the messages.

If you plan to attend the race this year, be on the lookout for scammers, and remember if something seems too good to be true, it probably is.
