## Groundbreaking Effort Helps Law Enforcement

A partnership among the Hamilton County Sheriff’s Office and municipalities in the county is enabling faster, more accurate and resource-efficient law enforcement responses.

The Hamilton County Real Time Information Center (RTIC), fully operational since November 2024, is a groundbreaking, multi-agency collaboration that is delivering substantial benefits to public safety and emergency response operations.

Its operations enhance data and intelligence sharing and ensure timely decision-making across jurisdictional boundaries, Chief Deputy John

Lowes said: “This program is a significant advancement in public safety and a clear win for every resident of Hamilton County—helping to maintain a safe, secure environment in which to live, work, and raise a family.”

The RTIC represents a unified effort among the Carmel Police Department, the Noblesville Police Department, and the Hamilton County Sheriff’s Office. The Fishers Police Department and Westfield Police Department are committed to this collaboration and intend to add resources in the future as appropriate. Despite being staffed by three agencies, RTIC

responds throughout Hamilton County, regardless of jurisdiction. This innovative center supports both criminal and non-criminal types of calls for service, acting as a true force multiplier. Since its inception, RTIC has significantly enhanced response times, improved information accuracy, and reduced operational costs while simultaneously improving officer safety and public service delivery.

Through the integration of advanced technology and real-time analysis, RTIC personnel also monitor incoming 911 calls, retrieve prior call

**1.** Gov. Mike Braun issued a statement recently following the State Budget Committee Meeting: I support the Trump administration’s efforts to reduce spending and promote responsible governance, it is a change at the federal level that is long overdue. However, flexibility in managing Indiana’s HIP program will be essential for the state moving forward, especially if we are required to take on more of the financial obligation. This will require a hands-on approach to updating and maintaining Indiana’s Medicaid system that only Hoosiers can provide. **3.** National Tire Safety Week is June 30 - July 4, so here are some safety tips and tricks to keep cars safe on hot roads and ahead of long drives.

- Maintain proper tire pressure for better fuel economy and vehicle control; for every 10 degrees shift in temperature, tire pressure changes by 1 pound per square inch (PSI).
- As tires age, the rubber becomes harder and brittle, making it higher risk for failure.
- Check the DOT number on the sidewall of the tire – if a tire is 6 years or older, it’s time to replace it.

## The Heat is On

In case you haven’t noticed, it’s HOT!

We’re fortunate In this day and age. We can expect to

be greeted by a blast of cool – if not downright frigid – air pretty much any time we enter a building on a blazing hot summer day.

That, however, has only come about during my lifetime.

When I was a kid, some homes and businesses had air conditioning, but quite a few still didn’t. We didn’t get it in our house until Dad woke up one night and found me sleeping – or rather trying to sleep – on the dining room floor.

Just imagine what life used to be like before air conditioning existed. Better yet, let me take you back to the summer of 1881, one of the hottest summers this area has ever experienced.

The July 15, 1881 Republican-Ledger noted that a local thermometer had reached 102 degrees on July 9th and 10th. The next day it was 104 degrees . . . in the shade!

Some smart aleck at the paper wrote, “Tell every fellow you see it is hot, so he will know it; otherwise he might not ascertain that fact.” (Yeah, right.)

It was nearly impossible to eat, sleep or work, especially in cities, where the heat was amplified by buildings and pavement.

Cases of heat prostration and sunstroke were reported all over the country. While I didn’t see any deaths attributed to sunstroke here during that period in July, there were plenty elsewhere. Cincinnati officially recorded 414 deaths due to the oppressive heat between July 10th and 16th.

A wave of unspecified illnesses hit various parts of Noblesville, prompting the Ledger to predict that, if the city’s streets, alleys and yards weren’t cleaned up, many deaths would soon follow. (Imagine the germs that must have been cooking in that sweltering weather.)

Curiously, I ran across no advice about staying hydrated. On the contrary, an article in the Ledger warned against the extensive use of water and pronounced drinking ice water during the hot spell as “altogether injurious and dangerous.”

Soda fountains and ice cream parlors were kept busy, but barrooms were empty because no one felt safe drinking anything stronger than lemonade. As a result, lemons were in such

The Noblesville Boom completed a trade Monday afternoon with the Salt Lake City Stars. The Boom received the Stars' 1st round pick in the 2025 G League Draft as well as the returning rights to Jaedon LeDee. Salt Lake City acquired the returning rights to Cameron McGriff.

McGriff spent the 2024-25 season with the Boom (known then as the Indiana Mad Ants). In 45 games played, he averaged 12.5 points and 6.3 rebounds per game while shooting 40.5 percent from the field. He played eight games for the Boom during the 2023-24 season after being acquired from the Memphis Hustle.

the Wolves, he averaged 8.1 points and 6.0 rebounds per game. LeDee appeared in 10 games for the Stars and averaged 4.5 points and 5.7 rebounds per game.



The Houston, Texas native played his college ball at Ohio State (2018-19), TCU (2019-21) and San Diego State (2022-24). LeDee was named to the First-Team All-Mountain West Team in 2024 after averaging 21.4 points and 8.4 rebounds per game at San Diego State. After going undrafted, he joined the Minnesota Timberwolves for Summer League. He was waived by the Timberwolves on October 2nd and signed with Iowa a few weeks later.

The 2025 NBA G League Draft is scheduled for Saturday, October 25th.

high demand that prices shot up. Sometimes they weren't even available.

A number of young men "and even persons of mature years" resorted to bathing in White River to beat the heat. Apparently, the paper really meant bathing and not swimming, because a lot of people complained about the (ahem) show.

The Ledger quoted a section of Indiana law dealing with indecent exposure and warned those "large enough to know right from wrong" that they could be arrested and fined for cooling off in public.

Sleep was elusive. People tried to get it any way they could — in bed or on the floor inside their home, or outdoors in a hammock, on a veranda or on a rooftop.

Sleeping outdoors carried some risks, however. One young man managed to roll off his roof while he was asleep. The paper observed that the fellow "did not care for the fall, but regreted [sic] the disturbance of the cat serenade."

You could also end up providing a banquet for "that vile destroyer of sleep, the impolite mosquito," of which there were plenty.

The firefly display would have been impressive, though.

That brings me to a request from Jeanne Flanders that I appeal to people to turn off their dusk to dawn lights so they can enjoy the fireflies' nightly "light shows."

Fireflies, aka lightning bugs, have all but disappeared from our backyards thanks to pesticides, loss of habitat and yes, light pollution. (The lights interfere with their mating habits.)

history, examine location-specific data, research subject qualifiers, and assist responding agencies with critical, up-to-the-minute REAL-TIME intelligence. This capability enhances situational awareness and equips officers with the most accurate and relevant information before they arrive on-scene.

Additionally, a key feature of the RTIC is the implementation of Drones as First Responders. These aerial assets are deployed to various calls for service, including traffic accidents, critical incidents, and active crime scenes. Drones provide live overwatch, aid in suspect apprehension, assist in foot pursuits, and offer real-time situational assessment, further enhancing the safety and effectiveness of law enforcement personnel on the ground.

Lieutenant Brian Niec, Director of the Real Time Information Center, commented, “This is the future of law enforcement in the United States. What makes the Hamilton County RTIC truly unique is that all participating agencies operate under the same Computer-Aided Dispatch system, reporting protocols, Dispatch Center, and Records Management System. These shared resources allow for seamless coordination and establish RTIC as a true countywide task force.”

2024 November – Assisted Noblesville PD with locating a missing person.

2024 November – Assisted HCSO with a trespassing case and subsequent theft arrest.

2025 January – Assisted Carmel PD and IMPD by aerially monitoring a pursuit using the Drone as a First Responder (DFR) technology.

2025 February – DFR assistance for Fishers PD during the apprehension of a stolen vehicle.

# Previously Convicted Sex Offender Sentenced to 45 Years

Darren Ringenberg, 30, of Louisville, Kentucky, a registered sex offender, was sentenced to 45 years in federal prison, followed by ten years of supervised release, after being convicted of two counts of sexual exploitation of a child while required to register as a sex offender.

According to court documents, in 2019, Ringenberg was previously convicted in Kentucky of twenty counts of Possession of Matter Portraying a Sexual Performance by a Minor and was required to register as a sex offender for life.

Then, after his release from the Kentucky offense, in June 2023,

Ringenberg, using the Snapchat username “devil\_hell6969,” communicated with a nine-year old girl living in Monroe County, Indiana and coerced her to send sexually explicit images and videos, threatening to hack into her social media accounts and remove all her friends if she did not comply. Ringenberg directed her as to what images to send, how to take the photos and told her that they could meet in person in the future. He also falsely claimed to be sixteen years old and would screen-record and save many of the images and conversations without the child’s knowledge.

After receiving a tip about his illicit behavior

online, law enforcement conducted judicially authorized searches of both Ringenberg’s Snapchat account and his residence in Louisville. Investigators found text messages, many of which were sexual in nature, between Ringenberg and various other unidentified minors, including the nine-year-old girl. Also located on his cell phone camera roll were many Snapchat screen recordings of minor victims engaged in sexually explicit conduct.

“Sex offenders often use manipulation and threats to sexually exploit children with utter disregard for the lasting trauma they inflict. I urge parents and guardians to talk to the children in their

lives about what they’re doing online and make sure they have trusted adults they can turn to for help,” said John E. Childress, Acting United States Attorney for the Southern District of Indiana. “I commend the FBI and the Bloomington Police Department for their work to seek justice for this victim and protect other children from this online predator.”

“This case is a tragic reminder that with today’s technology, predators can reach across state lines with a few clicks. While the distance didn’t help protect this child from harm, it did not stop the offender from being brought to justice,” said FBI Indianapolis Special

Agent in Charge Timothy J. O’Malley. “The FBI and our law enforcement partners remain committed to protecting children and holding offenders accountable – no matter where they are.”

The FBI and Bloomington Police Department investigated this case. The sentence was imposed by Chief U.S. District Judge Tanya Walton Pratt.

Acting U.S. Attorney Childress thanked Assistant U.S. Attorney MaryAnn T. Mindrum, who prosecuted this case.

This case was brought as part of Project Safe Childhood, a nationwide initiative launched in May 2006 by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by U.S. Attorneys’ Offices and the Child Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state, and local resources to better locate, apprehend and prosecute individuals who exploit children via the internet, as well as to identify and rescue victims.
